**Authority to Receive Reports:** A unanimous-consent agreement was reached providing that during the 114th Congress, it be in order for the Secretary of the Senate to receive reports at the desk when presented by a Senator at any time during the day of the session of the Senate.

**Recognition of Leadership:** A unanimous-consent agreement was reached providing that the Majority and Minority Leaders may daily have up to 10 minutes each on each calendar day following the prayer and disposition of the reading of, or the approval of, the Journal.

**Printing of Conference Reports:** A unanimous-consent agreement was reached providing that notwithstanding the provisions of rule XXVIII, conference reports and statements accompanying them not be printed as Senate reports when such conference reports and statements have been printed as

a House report unless specific request is made in the Senate in each instance to have such a report printed.

**Authority for Appropriations Committee:** A unanimous-consent agreement was reached providing that the Committee on Appropriations be authorized during the 114th Congress to file reports during the adjournments or recesses of the Senate on appropriations bills, including joint resolutions, together with any accompanying notices of motions to suspend rule XVI, pursuant to rule V, for the purpose of offering certain amendments to such bills or joint resolutions, which proposed amendments shall be printed.

**Authority for Corrections in Engrossment:** A unanimous-consent agreement was reached providing that, for the duration of the 114th Congress, the Secretary of the Senate be authorized to make technical and clerical corrections in the engrossments of all Senate-passed bills and joint resolutions, Senate amendments to House bills and resolutions, Senate amendments to House amendments to Senate bills and resolutions, and Senate amendments to House amendments to House bills or resolutions.

**Authority to Receive Messages and Sign Enrolled Measures:** A unanimous-consent agreement was reached providing that, for the duration of the 114th Congress, when the Senate is in recess or adjournment, the Secretary of the Senate is authorized to receive messages from the President of the United States, and—with the exception of House bills, joint resolutions and concurrent resolutions—messages from the House of Representatives; and that they be appropriately referred; and that the President of the Senate, the President pro tempore, and the Acting President pro tempore be authorized to sign duly enrolled bills and joint resolutions.

**Privileges of the Floor:** A unanimous-consent agreement was reached providing that, for the duration of the 114th Congress, Senators be allowed to leave at the desk with the Journal Clerk the names of two staff members who will be granted the privilege of the floor during the consideration of the specific matter noted, and that the Sergeant-at-Arms be instructed to rotate such staff members as space allows.

Yoho received 2 votes, The Honorable Jim Jordan received 2 votes, The Honorable Jim Cooper received 1 vote, The Honorable Peter A. DeFazio received 1 vote, The Honorable Jeff Duncan (SC) received 1 vote, The Honorable Trey Gowdy received 1 vote, The Honorable John Lewis received 1 vote, The Honorable Kevin McCarthy received 1 vote, The Honorable Rand Paul received 1 vote, The Honorable Jeff Sessions (AL) received 1 vote, and The Honorable Colin Powell received 1 vote. Earlier, the Clerk appointed Representatives-elect Miller (MI), Brady (PA), Kaptur, and Ros-Lehtinen to act as Tellers.

**Election of Majority and Minority Leaders:** The Chairman of the Republican Conference, Representative McMorris Rodgers, announced the election of Representative McCarthy as the Majority Leader. The Chairman of the Democratic Caucus, Representative Becerra, announced the election of Representative Pelosi as the Minority Leader. **Page H6**

**Election of Majority and Minority Whips:** The Chairman of the Republican Conference, Representative McMorris Rodgers, announced that election of Representative Scalise as the Majority Whip. The Chairman of the Democratic Caucus, Representative Hoyer as the Minority Whip and Representative Clyburn as Assistant Democratic Leader. **Page H6**

**Electing Officers of the House of Representatives:** The House agreed to H. Res. 1, electing the following officers for the House of Representatives: Karen L. Haas, Clerk; Paul D. Agreed that the question be divided on the adoption of the resolution so as to have a separate vote on the election of the Chaplain. Agreed to the first portion of the resolution by voice vote. Agreed to the remainder of the resolution by voice vote. **Page H6**

Rejected the Becerra amendment to H. Res. 1 by voice vote. **Page H6**

**Notify the Senate that a Quorum Has Assembled:** The House agreed to H. Res. 2, to inform the Senate that a quorum of the House has assembled and of the election of the Speaker and the Clerk. **Pages H6–7**

**Notify the President of the Assembly of the 114th Congress:** The House agreed to H. Res. 3, authorizing the Speaker to appoint Members of the House to a joint committee to notify the President of the assembly of the Congress. Subsequently, the Speaker appointed Representatives McCarthy and Pelosi to the committee. Later, Representative

McCarthy announced that the Committee had notified the President that a quorum of each House had assembled and was ready to receive any communication he may be pleased to make. **Page H7**

**Notify the President of the Election of the Speaker and the Clerk:** The House agreed to H. Res. 4, instructing the Clerk to inform the President of the election of the Speaker and the Clerk. **Page H7**

**Adopting Rules for the One Hundred Fourteenth Congress:** The House agreed to H. Res. 5, adopting rules for the One Hundred Fourteenth Congress, by a ye-a-and-nay vote of 234 yeas to 172 nays with one answering “present”, Roll No. 6, after the previous question was ordered by a ye-a-and-nay vote of 239 yeas to 168 nays, Roll No. 4. **Pages H7–28**

Representative Norton moved to refer H. Res. 5 to a select committee of five members, to be appointed by the Speaker. Subsequently, Representative McCarthy moved to table the Norton motion and by a ye-a-and-nay vote of 230 yeas to 160 nays, Roll No. 3, the McCarthy motion was agreed to. **Page H11**

Rejected the Van Hollen motion to commit H. Res. 5 to a select committee composed of the Majority Leader and Minority Leader with instructions to report it back to the House forthwith with an amendment, by a ye-a-and-nay vote of 168 yeas to 243 nays, Roll No. 5. **Pages H25–26**

**Administration of the Oath of Office:** Representatives-elect Cicilline, Cooper, Gowdy, Price (NC), and Welch presented themselves in the well of the House and were administered the oath of office by the Speaker. **Page H25**

**Hire More Heroes Act of 2015:** H.R. 22, to amend the Internal Revenue Code of 1986 to exempt employees with health coverage under TRICARE or the Veterans Administration from being taken into account for purposes of determining the employers to which the employer mandate applies under the Patient Protection and Affordable Care Act, by a  $\frac{2}{3}$  yea-and-nay vote of 412 yeas with none voting “nay”, Roll No. 7. **Pages H29–32**

**Assembly outside of the District of Columbia:** The House agreed to H. Con. Res. 1, regarding consent to assemble outside the seat of government. **Page H32**

**Appointment Authority:** Agreed that during the One Hundred Fourteenth Congress, the Speaker, Majority Leader, and Minority Leader be authorized to accept resignations and to make appointments authorized by law or by the House. **Page H32**

**Extension of Remarks:** Agreed that during the One Hundred Fourteenth Congress, all Members be permitted to extend their remarks and to include extraneous material within the permitted limit in that section of the Congressional Record entitled “Extension of Remarks”. **Page H32**

**Morning-Hour Debate:** Agreed to the procedures regarding the format for morning-hour debate for the first session of the One Hundred Fourteenth Congress. **Pages H32–33**

**Policies of the Chair:** The Chair announced her policies with respect to particular aspects of the legislative process dealing with (1) privileges of the floor; (2) introduction of bills and resolutions; (3) unanimous-consent requests for the consideration of legislation; (4) recognition for one-minute speeches; (5) recognition for special-order speeches; (6) decorum in debate; (7) conduct of votes by electronic device; (8) use of handouts on the House floor; (9) use of electronic equipment on the House floor; and (10) use of the Chamber. These announcements, where appropriate, will reiterate the origins of the stated policies. The Chair intends to continue in the 114th Congress the policies reflected in these statements. The policy announced in the 102nd Congress with respect to jurisdictional concepts related to clause 5(a) of rule 21, tax and tariff measures, will continue to govern but need not be reiterated, as it is adequately documented in the House Rules and Manual.
