Adopted:

By 56 yeas to 31 nays (Vote No. 304), Wicker Motion to Instruct Conferees to insist upon inclusion of the following section in title XXXII: Truck Tractor-Semitrailer-Trailer Combination Length Limitation. The Secretary may promulgate a rule to increase the minimum length limitation that a State may prescribe for a truck tractor-semitrailer-trailer combination under section 31111(b)(1)(A) of title 49, United States Code, from 28 feet to 33 feet if the Secretary makes a statistically significant finding, based on the final Comprehensive Truck Size and Weight Limit Study required under section 32801 of the Commercial Motor Vehicle Safety Enhancement Act of 2012 (title II of division C of Public Law 112–141), that such increase would not have a net negative impact on public safety. **Pages S7886–87**

Blumenthal Motion to Instruct Conferees to insist upon the inclusion of the rail safety provisions contained in the amendment passed by the Senate on July 30, 2015, including the authorization of grants for the installment of positive train control. **Page S7887**
