**Veteran PEER Act:** Committee on Veterans' Affairs was discharged from further consideration of S. 1873, to require the Secretary of Veterans Affairs to carry out a program to establish peer specialists in patient aligned care teams at medical centers of the Department of Veterans Affairs, and the bill was then passed, after agreeing to the following amendment proposed thereto: **Pages S525–26**

McConnell (for Blunt) Amendment No. 1920, to modify the timeline for establishment of the program. **Page S525**

**National School Choice Week:** Senate agreed to S. Res. 381, designating the week of January 21 through January 27, 2018, as "National School Choice Week". **Page S526**

**National Catholic Schools Week:** Senate agreed to S. Res. 382, supporting the contributions of Catholic schools. **Page S526**

**Pain-Capable Unborn Child Protection Act:** A unanimous-consent agreement was reached providing that at approximately 2 p.m., on Monday, January 29, 2018, Senate resume consideration of the motion to proceed to consideration of S. 2311, to amend title 18, United States Code, to protect pain-capable unborn children, with the time until 5:30 p.m. equally divided in the usual form; and notwithstanding the provisions of Rule XXII, the cloture motions filed during Wednesday, January 24, 2018 session ripen in the order filed at 5:30 p.m., on Monday, January 29, 2018. **Page S526**

Tarbert, Assistant Secretary of the Treasury; Richard E. Ashooh, Assistant Secretary of Commerce for Export Administration; and Eric D. Chewning, Deputy Assistant Secretary of Defense for Manufacturing and Industrial Base Policy.
