the conveyance to the State of Iowa of the reversionary interest held by the United States in and to certain land in Pottawattamie County, Iowa, and to express the sense of Congress relating to the continued provision of information relating to certain national historic trails, S. 1993, to adjust the boundary of the Santa Monica Mountains National Recreation Area to include the Rim of the Valley Corridor, S. 2015, to clarify the status of the North Country. Ice Age, and New England National Scenic Trails as units of the National Park System, S. 2441, to amend the Steel Industry American Heritage Area Act of 1996 to repeal the funding limitation, S. 2570, to repeal the funding authorization sunset and the total funding cap for the Essex National Heritage Area, S. 2604, to amend the Oil Region National Heritage Area Act to reauthorize the Oil Region National Heritage Area, S. 2672, to authorize the Society of the First Infantry Division to make modifications to the First Division Monument located on Federal land in President's Park in Washington, DC, S. 2870, to authorize the Secretary of the Interior to conduct a special resource study of the site known as "Amache" in the State of Colorado, S. 2876, to amend the National Trails System Act to provide for the study of the Pike National Historic Trail, S. 2889 and H.R. 4895, bills to establish the Medgar Evers National Monument in the State of Mississippi, S. 2831 and H.R. 5751, bills to redesignate Golden Spike National Historic Site and to establish the Transcontinental Railroad Network, S. 3176 and H.R. 5979, bills to establish the Mill Springs Battlefield National Monument in the State of Kentucky as a unit of the National Park System, S. 3287 and H.R. 5655, bills to establish the Camp Nelson Heritage National Monument in the State of Kentucky as a unit of the National Park System, S. 3298, to extend the authority of the Vietnam Veterans Memorial Fund, Inc., to establish a visitor center for the Vietnam Veterans Memorial, and H. Con. Res. 33, designating the George C. Marshall Museum and George C. Marshall Research Library in Lexington, Virginia, as the National George C. Marshall Museum and Library, after receiving testimony from P. Daniel Smith, Deputy Director, Exercising the Authority of the Director, National Parks Service, Department of the Interior.

S. 2850, to amend the White Mountain Apache Tribe Water Rights Quantification Act of 2010 to clarify the use of amounts in the WMAT Settlement Fund. Signed on August 1, 2018. (Public Law 115–227)

H.R. 4528, to make technical amendments to certain marine fish conservation statutes. Signed on August 2, 2018. (Public Law 115–228)

H.R. 4645, to amend the Wild and Scenic Rivers Act to designate certain segments of East Rosebud Creek in Carbon County, Montana, as components of the Wild and Scenic Rivers System. Signed on August 2, 2018. (Public Law 115–229)
