Report to accompany S. 3085, to establish a Federal Acquisition Security Council and to provide executive agencies with authorities relating to mitigating supply chain risks in the procurement of information technology. (S. Rept. No. 115–408)

S. 414, to promote conservation, improve public land management, and provide for sensible development in Pershing County, Nevada. (S. Rept. No. 115–409)

S. 594, to authorize the Secretary of Homeland Security to work with cybersecurity consortia for

training, with an amendment in the nature of a substitute. (S. Rept. No. 115–410)

S. 1942, to direct the Attorney General to review, revise, and develop law enforcement and justice protocols appropriate to address missing and murdered Indians, with an amendment in the nature of a substitute. (S. Rept. No. 115–411)

S. 3309, to authorize cyber incident response teams at the Department of Homeland Security, with an amendment in the nature of a substitute. (S. Rept. No. 115–412)

H.R. 5206, to amend the Homeland Security Act of 2002 to establish the Office of Biometric Identity Management, with amendments. (S. Rept. No. 115–413)

S. 569, to amend title 54, United States Code, to provide consistent and reliable authority for, and for the funding of, the Land and Water Conservation Fund to maximize the effectiveness of the Fund for future generations, with an amendment in the nature of a substitute.

S. 785, to amend the Alaska Native Claims Settlement Act to provide for equitable allotment of land to Alaska Native veterans, with an amendment in the nature of a substitute.

S. 1403, to amend the Public Lands Corps Act of 1993 to establish the 21st Century Conservation Service Corps to place youth and veterans in national service positions to conserve, restore, and enhance the great outdoors of the United States, with an amendment in the nature of a substitute.

S. 2290, to improve wildfire management operations and the safety of firefighters and communities with the best available technology, with an amendment in the nature of a substitute.

S. 3172, to amend title 54, United States Code, to establish, fund, and provide for the use of amounts in a National Park Service Legacy Restoration Fund to address the maintenance backlog of the National Park Service, with an amendment in the nature of a substitute. **Pages S7274–75**

Alaska Remote Generator Reliability and Protection Act: Senate passed S. 1934, to prevent catastrophic failure or shutdown of remote diesel power

engines due to emission control devices, after agreeing to the committee amendment in the nature of a substitute. **Pages S7277–78**

Anwar Sadat Centennial Celebration Act: Senate passed H.R. 754, to award the Congressional Gold Medal to Anwar Sadat in recognition of his heroic achievements and courageous contributions to peace in the Middle East. **Page S7278**

Asia Reassurance Initiative Act: Senate passed S. 2736, to develop a long-term strategic vision and a comprehensive, multifaceted, and principled United States policy for the Indo-Pacific region, after agreeing to the committee amendment in the nature of a substitute, and the following amendment proposed thereto: **Pages S7278–91**

McConnell (for Gardner) Amendment No. 4068, of a perfecting nature. **Pages S7284–91**

Museum and Library Services Act: Senate passed S. 3530, to reauthorize the Museum and Library Services Act, after agreeing to the committee amendments. **Pages S7291–98**

Authorizing the Printing of a Commemorative Document: Senate agreed to S. Con. Res. 57, authorizing the printing of a commemorative document in memory of the late President of the United States, George Herbert Walker Bush. **Page S7298**

McNamee Nomination—Agreement: A unanimous-consent agreement was reached providing that at approximately 2:30 p.m., on Wednesday, December 5, 2018, Senate resume consideration of the nomination of Bernard L. McNamee, of Virginia, to be a Member of the Federal Energy Regulatory Commission, with the time until 4 p.m., equally divided between the two Leaders or their designees. **Page S7298**
