*North Atlantic Treaty Organization Support Act:* H.R. 676, to reiterate the support of the Congress of the United States for the North Atlantic Treaty Organization, by a  $\frac{2}{3}$  yea-and-nay vote of 357 yeas to 22 nays, Roll No. 44; and **Pages H976–79, H981–82**

*Hack Your State Department Act:* H.R. 328, to require the Secretary of State to design and establish a Vulnerability Disclosure Process (VDP) to improve Department of State cybersecurity and a bug bounty program to identify and report vulnerabilities of internet-facing information technology of the Department of State, by a  $\frac{2}{3}$  yea-and-nay vote of 377 yeas to 3 nays, Roll No. 45. **Pages H979–81, H982–83**

**Member Resignation:** Read a letter from Representative Tom Marino, wherein he resigned as Representative for the Twelfth Congressional District of Pennsylvania, effective at 12:01 a.m. on January 23, 2019. **Page H981**

### CONSOLIDATED APPROPRIATIONS ACT, 2019; MAKING FURTHER CONTINUING APPROPRIATIONS FOR THE DEPARTMENT OF HOMELAND SECURITY FOR FISCAL YEAR 2019, AND FOR OTHER PURPOSES

*Committee on Rules:* Full Committee held a hearing on H.R. 648, the “Consolidated Appropriations Act, 2019”; and H.J. Res. 31, making further continuing appropriations for the Department of Homeland Security for fiscal year 2019, and for other purposes. The Committee granted, by record vote of 6–2, a rule providing for consideration of H.R. 648, the “Consolidated Appropriations Act, 2019”; and H.J. Res. 31, making further continuing appropriations for the Department of Homeland Security for fiscal year 2019, and for other purposes. Section 1 of the rule provides for consideration of H.R. 648 under a closed rule. The rule provides one hour of debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their designees. The rule waives all points of order against consideration of the bill. The rule provides that the bill shall be considered as read. The rule waives all points of order against provisions in the bill. The rule provides that clause 2(e) of rule XXI shall not apply during consideration of the bill. The rule provides one motion to recommit. Section 2 of the rule provides for consideration of H.J. Res. 31 under a closed rule. The rule provides one hour of debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their designees. The rule waives all points of order against consideration of the joint resolution. The rule provides that the joint resolution shall be considered as read. The rule waives all points of order against provisions in the

joint resolution. The rule provides one motion to recommit. Section 3 of the rule provides that it shall be in order at any time through the legislative day of February 1, 2019, for the Speaker to entertain motions that the House suspend the rules as though under clause 1 of rule XV, and that the Speaker or her designee shall consult with the Minority Leader or his designee on the designation of any matter for consideration pursuant to this section. Finally, section 4 of the rule waives the requirement of clause 6(a) of rule XIII for a two-thirds vote to consider a report from the Committee on Rules on the same day it is presented to the House with respect to any resolution reported through the legislative day of January 30, 2019, relating to a measure making or continuing appropriations for the fiscal year ending September 30, 2019. Testimony was heard from Chairman Lowey, and Representatives Bishop of

Georgia, Fortenberry, Serrano, Aderholt, Quigley, Graves of Georgia, McCollum, Joyce of Ohio, Rogers of Kentucky, Price of North Carolina, Diaz-Balart, Roybal-Allard, and Fleischmann.
