*Routine Proceedings, pages S6657–S6686*

**Measures Introduced:** Four bills and six resolutions were introduced, as follows: S. 4893–4896, and S. Res. 768–773. **Pages S6675–76**

**Impact Aid Coronavirus Relief Act:** Senate passed H.R. 8472, to provide that, due to the disruptions caused by COVID–19, applications for impact aid funding for fiscal year 2022 may use certain data submitted in the fiscal year 2021 application. **Pages S6659–60**

**Rosie the Riveter Congressional Gold Medal Act:** Committee on Banking, Housing, and Urban Affairs was discharged from further consideration of H.R. 1773, to award a Congressional Gold Medal, collectively, to the women in the United States who joined the workforce during World War II, providing the aircraft, vehicles, weaponry, ammunition and other material to win the war, that were referred to as “Rosie the Riveter”, in recognition of their contributions to the United States and the inspiration they have provided to ensuing generations, and the bill was then passed. **Page S6664**

**Malnutrition Awareness Week:** Committee on the Judiciary was discharged from further consideration of S. Res. 716, designating the week of October 5 through October 9, 2020, as “Malnutrition Awareness Week”, and the resolution was then agreed to. **Page S6679**

**National Ataxia Awareness Day:** Committee on Health, Education, Labor, and Pensions was discharged from further consideration of S. **Day of the Deployed:** Committee on the Judiciary was discharged from further consideration of S. Res. 764, designating October 26, 2020, as the “Day of the Deployed”, and the resolution was then agreed to. **Page S6679**

**National Dyslexia Awareness Month:** Committee on the Judiciary was discharged from further consideration of S. Res. 765, calling on Congress, schools, and State and local educational agencies to recognize the significant educational implications of dyslexia that must be addressed, and designating October 2020 as “National Dyslexia Awareness Month”, and the resolution was then agreed to. **Page S6679**

**Honoring individuals fighting wildfires:** Committee on Homeland Security and Governmental Affairs was discharged from further consideration of S. Res. 766, honoring the individuals fighting and the individuals who have fallen responding to wildland fires during the ongoing 2020 wildfire season, and the resolution was then agreed to. **Page S6679**

**Congratulating Tampa Bay Lightning:** Committee on Commerce, Science, and Transportation was discharged from further consideration of S. Res. 767, congratulating the Tampa Bay Lightning for winning the 2020 Stanley Cup Final, and the resolution was then agreed to. **Page S6679**

**Rail Safety Week:** Senate agreed to S. Res. 768, expressing support for the designation of the week of September 20 through September 26, 2020, as Rail Safety Week in the United States, and supporting the goals and ideals of Rail Safety Week to reduce rail-related accidents, fatalities, and injuries. **Page S6679**

**National Principals Month:** Senate agreed to S. Res. 769, recognizing October 2020 as “National Principals Month”. **Page S6679**

**Honoring former Senator Mark Andrews:** Senate agreed to S. Res. 770, honoring the life of Mark Andrews, former United States Senator for the State of North Dakota. **Page S6679**

**National Co-op Month:** Senate agreed to S. Res. 771, designating October 2020, as “National Co-op Month” and commending the cooperative business model and the member-owners, businesses, employees, farmers, ranchers, and practitioners who use the cooperative business model to positively impact the economy and society. **Page S6679**

**Congratulating Los Angeles Lakers:** Senate agreed to S. Res. 772, congratulating the Los Angeles Lakers for winning the 2020 National Basketball Association Championship. **Page S6679**
