**ALS Disability Insurance Access Act:** Committee on Finance was discharged from further consideration of S. 578, to amend title II of the Social Security Act to eliminate the five-month waiting period for disability insurance benefits under such title for individuals with amyotrophic lateral sclerosis, and the bill was then passed in a roll call vote, 96 yeas to 1 nay (Vote No. 250), by the order of the Senate of Tuesday, December 1, 2020, 60 Senators having voted in the affirmative, and after taking action on the following amendment proposed thereto:

**Bureau of Land Management Land Acquisition Data:** Senate passed S. 434, to require the collection of certain data relating to Bureau of Land Management land acquisitions, after agreeing to the committee amendment in the nature of a substitute. **Page S7178**

**Republic of Texas Legation Memorial Act:** Committee on Energy and Natural Resources was discharged from further consideration of H.R. 3349, to authorize the Daughters of the Republic of Texas to establish the Republic of Texas Legation Memorial as a commemorative work in the District of Columbia, and the bill was then passed. **Page S7178**

**Fallen Journalists Memorial Act:** Committee on Energy and Natural Resources was discharged from further consideration of H.R. 3465, to authorize the Fallen Journalists Memorial Foundation to establish a commemorative work in the District of Columbia and its environs, and the bill was then passed. **Pages S7187–88**

The rule provides one hour of debate equally divided and controlled by the chair and ranking minority member of the Committee on the Judiciary. The rule waives all points of order against consideration of the bill. The rule provides that an amendment in the nature of a substitute consisting of the text of Rules Committee Print 116–67, modified by the amendment printed in the Rules Committee report, shall be considered as adopted and the bill, as amended, shall be considered as read. The rule waives all points of order against provisions in the bill, as amended. The rule provides one motion to recommit with or without instructions. Testimony was heard from Representatives Jackson Lee, Cline, and Blumenauer.
