**Buttigieg Nomination—Agreement:** A unanimous-consent agreement was reached providing that upon the conclusion of morning business, on Tuesday, February 2, 2021, Senate begin consideration of the nomination of Peter Paul Montgomery Buttigieg, of Indiana, to be Secretary of Transportation; and that the time until 12 noon, be equally divided between the two Leaders, or their designees, and that at 12 noon, Senate vote, without intervening action or debate, on confirmation of the nomination. **Page S191**

**Mayorkas Nomination—Agreement:** Senate continued consideration of the nomination of Alejandro Nicholas Mayorkas, of the District of Columbia, to be Secretary of Homeland Security. **Page S193**
