**Protecting America's First Responders Act:** Committee on the Judiciary was discharged from further consideration of S. 1511, to amend the Omnibus Crime Control and Safe Streets Act of 1968 with respect to payments to certain public safety officers who have become permanently and totally disabled as a result of personal injuries sustained in the line of duty, and the bill was then passed, after agreeing to the following amendment proposed thereto:

**Board of Regents of the Smithsonian Institution:** Committee on Rules and Administration was discharged from further consideration of H.J.
