#### Adopted:

By 90 yeas to 7 nays (Vote No. 291), Carper (for Padilla) Amendment No. 2133 (to Amendment No. 2137), to amend the Indian Health Care Improvement Act to expand the funding authority for renovating, constructing, and expanding certain facilities. (A unanimous-consent agreement was reached providing that the amendment, having achieved 60 affirmatives votes, be agreed to.)

By 95 yeas to 1 nay (Vote No. 292), Carper (for Thune) Amendment No. 2162 (to Amendment No. 2137), to address the workforce needs of the telecommunications industry. (A unanimous-consent agreement was reached providing that the amendment, having achieved 60 affirmatives votes, be agreed to.)

#### Rejected:

By 45 yeas to 48 nay (Vote No. 293), Carper (for Barrasso) Amendment No. 2180 (to Amendment No. 2137), to limit the use of certain funds made available for grants to enable the sustained cost-effective implementation of updated building energy codes. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.)
