***Reinforcing American-Made Products Act:*** Committee on Commerce, Science, and Transportation was discharged from further consideration of S. 297, to make exclusive the authority of the Federal Government to regulate the labeling of products made in the United States and introduced in interstate or foreign commerce, and the bill was then passed.

***Commending Hamilton-class Coast Guard cutters:*** Committee on Commerce, Science, and Transportation was discharged from further consideration of S. Res. 315, commending the service of Hamilton-class Coast Guard cutters and the officers and crew who served on them, and the resolution was then agreed to.

***PCOS Awareness Month:*** Committee on Health, Education, Labor, and Pensions was discharged from further consideration of S. Res. 325, recognizing the seriousness of polycystic ovary syndrome (PCOS) and expressing support for the designation of September

***National Student Parent Month:*** Senate agreed to S. Res. 362, expressing the support of the Senate for the contributions and achievements of student parents and recognizing September 2021 as National Student Parent Month. **Page S6482**

***School Bus Safety Month:*** Senate agreed to S. Res. 363, designating September 2021 as “School Bus Safety Month”. **Pages S6482–83**

**Rossman Nomination—Agreement:** By 51 yeas to 44 nays (Vote No. EX. 365), Senate agreed to the motion to close further debate on the nomination of Veronica S. Rossman, of Colorado, to be United States Circuit Judge for the Tenth Circuit.

**Pages S6479–80**

A unanimous-consent agreement was reached providing that the post-cloture time on the nomination be considered expired, and that at 5:30 p.m., on Monday, September 20, 2021, Senate vote on confirmation of the nomination. **Page S6480**
