## HIGHLIGHTS

Senate agreed to the motion to concur in the amendment of the House of Representatives to S. 3373, Protecting Our Gold Star Families Education Act.

S. 4430, to amend title 35, United States Code, to establish an interagency task force between the United States Patent and Trademark Office and the Food and Drug Administration for purposes of sharing information and providing technical assistance with respect to patents, with an amendment in the nature of a substitute. **Page S3860**

#### Measures Passed:

**Reese's Law:** Senate passed H.R. 5313, to protect children and other consumers against hazards associated with the accidental ingestion of button cell or coin batteries by requiring the Consumer Product Safety Commission to promulgate a consumer prod-

uct safety standard to require child-resistant closures on consumer products that use such batteries. **Page S3857**

**Jenna Quinn Law:** Committee on Health, Education, Labor, and Pensions was discharged from further consideration of S. 734, to amend the Child Abuse Prevention and Treatment Act to provide for grants in support of training and education to teachers and other school employees, students, and the community about how to prevent, recognize, respond to, and report child sexual abuse among primary and secondary school students, and the bill was then passed, after agreeing to the following amendment proposed thereto: **Page S3857**

Whitehouse (for Cornyn/Hassan) Amendment No. 5193, to require reports on the program of child sexual abuse awareness field-initiated grants. **Page S3857**

**National Anti-Counterfeiting and Consumer Education and Awareness Month:** Senate agreed to S. Res. 738, recognizing the importance of trademarks in the economy and the role of trademarks in protecting consumer safety, by designating the month of August as “National Anti-Counterfeiting and Consumer Education and Awareness Month”. **Page S3858**

**Authorizing the Printing of a Document:** Senate agreed to S. Res. 739, authorizing the printing with illustrations of a document entitled “Committee on Appropriations, United States Senate, 1867–2022”. **Page S3858**

#### House Messages:

**Protecting Our Gold Star Families Education Act:** By 86 yeas to 11 nays (Vote No. 280), Senate agreed to the motion to concur in the amendment of the House of Representatives to S. 3373, to improve the Iraq and Afghanistan Service Grant and the Children of Fallen Heroes Grant, by the order of the Senate of Tuesday, August 2, 2022, 60 Senators

having voted in the affirmative, after taking action on the following amendments and motions proposed thereto:

By 7 yeas to 90 nays (Vote No. 277), Paul motion to concur in the House amendment to the bill, with Paul Amendment No. 5184 (to the House amendment to the bill), to offset the increased spending authorized by this Act by temporarily prohibiting the expenditure of any Federal funds by the United States Agency for International Development other than spending for Israel. (A unanimous-consent agreement was reached providing that the motion, having failed to achieve 60 affirmative votes, was not agreed to.) **Pages S3849–50**

By 47 yeas to 48 nays (Vote No. 278), Toomey motion to concur in the House amendment to the bill, with Toomey Amendment No. 5186 (to the House amendment to the bill), to improve the Cost of War Toxic Exposures Fund. (A unanimous-consent agreement was reached providing that the motion, having failed to achieve 60 affirmative votes, was not agreed to.) **Pages S3850–51**

By 48 yeas to 47 nays (Vote No. 279), Blackburn motion to concur in the House amendment to the bill, with Blackburn Amendment No. 5185 (to the House amendment to the bill), to require the provision of care under the Veterans Community Care Program for toxic-exposed veterans. (A unanimous-consent agreement was reached providing that the motion, having failed to achieve 60 affirmative votes, was not agreed to.) **Page S3851**

Withdrawn:

Schumer motion to concur in the House amendment to the bill, with Schumer Amendment No. 5148 (to the House amendment to the bill), to add an effective date. **Page S3851**

**Protocols to the North Atlantic Treaty of 1949 on the Accession of the Republic of Finland and the Kingdom of Sweden—Agreement:** A unanimous-consent-time agreement was reached providing that at 1:30 p.m., on Wednesday, August 3, 2022, Senate begin consideration of Treaty Document 117–3, protocols to the North Atlantic Treaty of 1949 on the Accession of the Republic of Finland and the Kingdom of Sweden; that the treaties be considered as having advanced through the various parliamentary stages up to and including the presentation of the resolution of advice and consent to ratification; that there be 3 hours for debate, equally divided between the two Leaders, or their designees, on the treaties and resolution of advice and consent to ratification; that the only amendments in order to the resolution of advice and consent to ratification be the following: Sullivan Amendment No. 5192 and Paul Amendment No. 5191; that following debate, Senate vote on or in relation to the amendments in the order listed; and that upon disposition of the amendments, any committee conditions, declarations, or reservations be agreed to as applicable and Senate vote on the resolution of advice and consent to ratification, as amended, if amended, with no intervening action or debate. **Page S3852**
