S. 132, to require a pilot program on activities under the pre-separation transition process of members of the Armed Forces for a reduction in suicide among veterans, with an amendment in the nature of a substitute;

S. 141, to amend title 38, United States Code, to improve certain programs of the Department of Veterans Affairs for home and community based services for veterans, with an amendment in the nature of a substitute;

S. 185, to amend title 38, United States Code, to improve the program for direct housing loans made to Native American veterans;

S. 216, to amend title 38, United States Code, to modify the family caregiver program of the Department of Veterans Affairs to include services related to mental health and neurological disorders; and

S. 326, to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder.
