## Senate

### Chamber Action

*Routine Proceedings, pages S1857–S1959*

**Measures Introduced:** Nineteen bills and six resolutions were introduced, as follows: S. 1786–1804, and S. Res. 231–236. **Pages S1898–99**

**Measures Passed:**

***Waivers and Modifications of Federal Student Loans:*** By 52 yeas to 46 nays (Vote No. 135), Senate passed H.J. Res. 45, providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Department of Education relating to “Waivers and Modifications of Federal Student Loans”. **Pages S1857–68**

***Fiscal Responsibility Act:*** By 63 yeas to 36 nays (Vote No. 146), Senate passed H.R. 3746, to provide for a responsible increase to the debt ceiling, by the order of the Senate of Thursday, June 1, 2023, 60 Senators having voted in the affirmative, and after agreeing to the motion to proceed, and taking action on the following amendments proposed thereto: **Pages S1868–92**

Rejected:

By 21 yeas to 75 nays (Vote No. 136), Paul Amendment No. 107, in the nature of a substitute. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.) **Page S1883**

By 35 yeas to 62 nays (Vote No. 137), Braun Amendment No. 91, to rescind discretionary appropriations in the event of a debt ceiling crisis period and to honor the full faith and credit of the debts of the United States in the event of a debt ceiling crisis. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.) **Pages S1884–85**

By 46 yeas to 51 nays (Vote No. 138), Marshall Amendment No. 110, to secure the borders of the

United States. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.) **Page S1885**

By 49 yeas to 48 nays (Vote No. 139), Sullivan Amendment No. 125, to provide adequate funding for defense and increase the rescission of funding for the Internal Revenue Service. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.) **Pages S1885–86**

By 17 yeas to 81 nays (Vote No. 140), Hawley Amendment No. 93, to require the imposition of additional duties with respect to articles imported from the People’s Republic of China until trade between the United States and the People’s Republic of China comes into balance. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.) **Pages S1886–87**

By 46 yeas to 51 nays (Vote No. 141), Kennedy Amendment No. 104, to remove the sunset on modification of work requirement exemptions. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.) **Page S1887**

By 48 yeas to 51 nays (Vote No. 142), Cotton Amendment No. 106, to provide appropriate adjustments to the discretionary spending limits, in the event of funding under a continuing resolution. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.) **Page S1888**

By 47 yeas to 52 nays (Vote No. 143), Budd Amendment No. 134, to rescind unnecessary coronavirus funds. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.) **Page S1889**

By 48 yeas to 51 nays (Vote No. 144), Lee Amendment No. 98, to strike the waiver authority for Administrative PAYGO. **Pages S1889–90**

By 30 yeas to 69 nays (Vote No. 145), Kaine Amendment No. 101, to strike a provision relating to expediting completion of the Mountain Valley Pipeline. **Page S1890**

Kennedy Amendment No. 102, to require up-to-date employment data for waivers of work requirements. **Pages S1890–91**

**DIPG Pediatric Brain Cancer Awareness Day:** Senate agreed to S. Res. 232, expressing support for the designation of May 17, 2023, as “DIPG Pediatric Brain Cancer Awareness Day” to raise awareness of, and encourage research on, diffuse intrinsic pontine glioma tumors and pediatric cancers in general. **Page S1959**

**Motorcycle Safety Awareness Month:** Senate agreed to S. Res. 233, expressing support for the designation of May 2023 as Motorcycle Safety Awareness Month. **Page S1959**

**Older Americans Month:** Senate agreed to S. Res. 234, designating May 2023 as “Older Americans Month”. **Page S1959**

**Children’s Mental Health Awareness Week and Day:** Senate agreed to S. Res. 235, supporting the designation of the week of May 7, 2023, as “Children’s Mental Health Awareness Week” and May 11, 2023, as “Children’s Mental Health Awareness Day”. **Page S1959**

**Signing Authority—Agreement:** A unanimous-consent agreement was reached providing that Senator Duckworth, Senator Schatz, and Senator Van Hollen be authorized to sign duly enrolled bills or joint resolutions from June 1, 2023, through June 5, 2023. **Page S1959**

**Crane Nomination—Cloture:** Senate began consideration of the nomination of David Crane, of New Jersey, to be Under Secretary of Energy. **Page S1892**

A motion was entered to close further debate on the nomination, and, in accordance with the provisions of rule XXII of the Standing Rules of the Senate, and pursuant to the unanimous-consent agreement of Thursday, June 1, 2023, a vote on cloture will occur at 5:30 p.m., on Tuesday, June 6, 2023. **Page S1893**

Prior to the consideration of this nomination, Senate took the following action:

Senate agreed to the motion to proceed to Executive Session to consider the nomination. **Page S1892**

### APPROPRIATIONS: NATIONAL GUARD AND RESERVE

*Committee on Appropriations:* Subcommittee on Defense concluded a hearing to examine proposed budget estimates and justification for fiscal year 2024 for the National Guard and Reserve, after receiving testimony from General Daniel R. Hokanson, Chief, National Guard Bureau, Lieutenant General Jody J. Daniels, 34th Chief of Army Reserve and 9th Commanding General, Army Reserve Command, Vice Admiral John B. Mustin, USN, Chief of Navy Reserve, Lieutenant General David G. Bellon, Marine Corps Reserve, and Lieutenant General John P. Healy, Chief of Air Force Reserve, all of the Department of Defense.

### ELECTRIC SERVICE RELIABILITY

*Committee on Energy and Natural Resources:* Committee concluded a hearing to examine the reliability and resiliency of electric service in the United States in light of recent reliability assessments and alerts, after receiving testimony from James B. Robb, North American Electric Reliability Corporation, Washington, D.C.; Manu Asthana, PJM Interconnection, Southeastern, Pennsylvania; Melissa C. Lott, Columbia University School of International and Public Affairs Center on Global Energy Policy, New York, New York; and David J. Tudor, Associated Electric Cooperative Inc., Springfield, Missouri.

### BUSINESS MEETING

The Convention between the Government of the United States of America and the Government of the Republic of Chile for the Avoidance of Double Taxation and the Prevention of Fiscal Evasion with Respect to Taxes on Income and Capital, signed in Washington on February 4, 2010, with a Protocol signed the same day, as corrected by exchanges of notes effected February 25, 2011, and February 10 and 21, 2012, and a related agreement effected by exchange of notes (the “related Agreement”) on February 4, 2010 (Treaty Doc. 112–08); and

The nominations of Stephanie Syptak-Ramnath, of Texas, to be Ambassador to the Republic of Peru, Yael Lempert, of New York, to be Ambassador to the Hashemite Kingdom of Jordan, Arthur W. Brown, of Pennsylvania, to be Ambassador to the Republic of Ecuador, Roger F. Nyhus, of Washington, to be Ambassador to Barbados, and to serve concurrently and without additional compensation as Ambassador to the Federation of Saint Kitts and Nevis, Saint Lucia, Antigua and Barbuda, the Commonwealth of Dominica, Grenada, and Saint Vincent and the Grenadines, William W. Popp, of Missouri, to be Ambassador to the Republic of Uganda, Julie Turner, of Maryland, to be Special Envoy on North Korean Human Rights Issues, with the rank of Ambassador, Ervin Jose Massinga, of Washington, to be Ambassador to the Federal Democratic Republic of Ethiopia, Ana A. Escrogima, of New York, to be Ambassador to the Sultanate of Oman, and Lisa A. Johnson, of Virginia, to be Ambassador to the Lebanese Republic, all of the Department of State.
