S. 2116, to require the Secretary of Commerce to produce a report that provides recommendations to improve the effectiveness, efficiency, and impact of Department of Commerce programs related to supply chain resilience and manufacturing and industrial innovation, with an amendment in the nature of a substitute; and

S. 2201, to increase knowledge and awareness of best practices to reduce cybersecurity risks in the United States, with amendments.

### HAITI

# House of Representatives

## Chamber Action
