**Page H4870**

***Continuing Appropriations and Border Security Enhancement Act, 2024:*** The House failed to pass H.R. 5525, making continuing appropriations for fiscal year 2024, by a yeas-and-nays vote of 198 yeas to 232 nays, Roll No. 511. **Pages H4861–69, H4870–98**

Rejected the Ramirez motion to recommit the bill to the Committee on Appropriations by a yeas-and-nays vote of 210 yeas to 216 nays, Roll No. 510.

**Pages H4897–98**

H. Res. 741, the rule providing for consideration of the bill (H.R. 5525) was agreed to by a recorded vote of 218 yeas to 210 nays, Roll No. 509, after the previous question was ordered by a yeas-and-nays vote of 217 yeas to 207 nays, Roll No. 508.

**CONTINUING APPROPRIATIONS AND BORDER SECURITY ENHANCEMENT ACT, 2024**

***Committee on Rules:*** Full Committee held a hearing on H.R. 5525, the “Continuing Appropriations and Border Security Enhancement Act, 2024”. The Committee granted, by a record vote of 9–4, a rule providing for consideration of H.R. 5525, the “Continuing Appropriations and Border Security Enhancement Act, 2024”, under a closed rule. The rule waives all points of order against consideration of the bill. The rule provides that the amendments printed in the Rules Committee report shall be considered as adopted and that the bill, as amended, shall be considered as read. The rule waives all points of

order against provisions in the bill, as amended. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees. The rule provides one motion to recommit. The rule provides that upon passage of H.R. 5525 the title of such bill is amended to read as follows: “Reducing spending, securing the border, and for other purposes.”.
