Mallett was a standout Quarterback at the University of Arkansas, an NFL Quarterback, and most recently a coach at Mountain Home High School and White Hall High School.

In his first season at Arkansas in 2009, he led the Razorbacks to an 8–5 record and Liberty Bowl victory.

He threw for 3,624 yards and 30 touchdowns, third all-time at Arkansas.

In 2010, he led the Razorbacks to a ten-win season and Arkansas's first BCS bowl berth. He threw for 3,869 yards and 32 touchdowns, both a school record.

He was drafted in the third round of the 2011 NFL Draft and made eight starts in his seven-year NFL career with the New England Patriots, Baltimore Ravens, and Houston Texans.

After retiring from football, he would go on to become a high school football coach.

Mallett first served as an assistant football coach at Mountain Home High School in Arkansas, recently moving to White Hall High School where he was preparing for his first season as the head football coach.

Ryan's heartbreaking loss of life far too early touched all Arkansans. His legacy will live on in Arkansas, not just through a distinguished playing career, but as a role model who impacted and improved the lives of the next generation of Arkansans.

Mr. Speaker Pro Tempore, I rise today to recognize Alyssa Milano, an actress, producer, writer and activist who has used her platform for decades to promote social causes and provide a voice to those who are not heard. Her trailblazing work both nationally and internationally is worthy of commendation.

Alyssa's activist career started as a young woman when she made an appearance on the The Phil Donahue Show with Ryan White, a young man who had been diagnosed with AIDS and forced out of his public school in Indiana. A kiss on the cheek to showcase that AIDS could not be contracted from simple skin-to-skin contact was the beginning of almost 40 years of activism coinciding with her incredible career in movies, television, books, and podcasts. In 2017, a post by Alyssa relaunched the #MeToo movement, encouraging survivors of sexual harassment and assault to speak up and bring awareness to the commonality of these sex crimes to the public. To this day, Alyssa remains an active and effective voice in the #MeToo movement.

In 2013, Alyssa created the comic book series Hackivist, which explored the modern world of hacking and global activism. In 2019, she released a children's book Hope: Project Middle School Book which is part of her 'Hope' book series which she co-authors with Debbie Rigaud. Alyssa also hosts the podcast Alyssa Milano: Sorry Not Sorry which deals with social and political commentary and frequently features fellow actors, activists, and political luminaries. Following the Stoneman Douglas High School shooting in 2018, Alyssa co-founded #NoRA, a coalition of artists, activists, and survivors of gun violence in an effort to reduce the influence of the National Rifle Association in American government. In her current role as UNICEF Goodwill Ambassador for the United States of America, she continues to champion civil rights and charitable causes around the world.

Mr. Speaker Pro Tempore, I ask my colleagues to join me today in celebrating the lifetime of work that Alyssa Milano has been kind enough to share with us. Wildly successful in her long professional career, Alyssa could have rested on her laurels and had an easy life. Instead, she has taken her platform at every stage in her career and used it to fight for good and what is right. I thank Alyssa, and we excited to see what more she can accomplish in the coming decades.

Alongside my School Safety Caucus peers, I introduced the Strengthening Our Schools Act of 2023. This legislation would increase funding for SROs and ensure they have the resources required to support and protect students and school staff. I am grateful to the many School Resource Officers across Bucks and Montgomery counties for all they do to support our schools and communities.

In Bucks County, we are fortunate to have several school districts that have invested heavily in having SROs in their schools and we have many others that are in the process of laying the groundwork for an SRO program. The Bucks County school districts that have an existing SRO program include the following: Quakertown, Central Bucks, Council Rock, Neshaminy, Bensalem, and Bristol Borough.

As we acknowledge School Safety Week across the country, and raise awareness about the importance of strategies for keeping students and educators safe, I urge my colleagues to continue to focus on key policies to ensure schools have the necessary resources.

In 2009, Chief Fong was selected for orders at the Naval Special Warfare schoolhouse where he achieved remarkable milestones, including being selected as the Command Sailor of the Year and promoted to the rank of Chief Petty Officer in 2012. Chief Fong's dedication continued as he served in various roles, including as Operations and Training Chief at the Navy Operational Support Center in Tampa, where he managed over 600 Navy Reservists' travel and orders. His final tour of duty saw him handpicked to work for the United States Special Operations Command, Warrior Care Program, where he made significant contributions. Chief Fong has also proven himself to be an incredible athlete as he had the opportunity to represent Team USA for the 2018 Invictus Games in Australia and 2022 Invictus Games in the Netherlands earning gold and bronze medals for rugby and rowing. In addition to his outstanding career, Chief Fong is a devoted husband to Sylvia and a proud father of three sons, Phill, Will, and Dill. I applaud Chief Fong

Returning to civilian life, Richard married the love of his life Christine Hogan Santsfree in April 1971. They moved to Cohoes and started their family together, raising three children: Kimberly, Richard Jr., and Thomas. Richard spent his professional career with General Electric in Schenectady, working as a machinist for four decades before retiring in August 2010.

Richard was a well-rounded member of the Cohoes and Troy communities, participating in his local church, veterans' organizations, and recreational activities. He was a member of the Cohoes Moose Club, the Cohoes-Waterford Elk's Lodge 1317, and the American Legion Ruane Post 476. Richard competed in a league at the Cohoes Bowling Arena, along with the Cohoes Rod and Gun Club's Dart and Horseshoe League. Richard assisted with St. Rita's Church's annual bazaar, as well as the Rod and Gun Club's kids' fishing contest at the Van Schaick Island pond. More than anything, he was a proud family man who enjoyed travelling and spending time with his wife, children, and four grandchildren.

IN MEMORY OF ROY KIDD

Mr. BARR. Mr. Speaker Pro Tempore, I rise today to honor a legendary Kentuckian, Roy Kidd. He was a renowned football coach at Eastern Kentucky University in Richmond, Kentucky and he passed away on September 12, 2023.

Coach Kidd was born in Corbin, Kentucky on December 4, 1931. He was a star athlete at Corbin High School, playing 3 sports. He attended Eastern Kentucky University, where he was an outstanding quarterback and also played center fielder. His coaching career began at the high school level where he coached from 1955 to 1961. He entered the college coaching ranks at Morehead State University and moved to ECU one year later. Coach Kidd served as head football coach for thirty-nine years, retiring in 2002. He amassed an outstanding record, winning over 300 games, with two I-AA national titles and two runner-up titles. Coach Kidd's teams had 25 consecutive winning seasons. He was twice named the NCAA Division I-AA National Coach of the Year and received the prestigious American Football Coaches Association's Amos Alonzo Stagg Award.

Coach Kidd was well respected and beloved by his former players. He was a staunch ambassador for his alma mater, Eastern Kentucky University. His impact on the university was significant, resulting in the football stadium being renamed Roy Kidd Stadium in his honor and the street in front of the stadium named Roy and Sue Kidd Way. He was a member of the ECU Hall of Distinguished Alumni, the ECU Athletics Hall of Fame, the Kentucky Athletics Hall of Fame, the OVC Hall of Fame, and the Madison County Sports Hall of Fame. The Kentucky High School Athletic Association's highest football award is named the Roy Kidd Award.

Coach Kidd is survived by his wife Sue. They were married for 62 years and have 3 children, six grandchildren, and four great-grandchildren. He was a member of First Baptist Church in Richmond.

Roy Kidd was highly respected as a coach and a leader throughout the Commonwealth of

Kentucky. He was a man who of integrity who contributed greatly to his players by the lessons he taught both on and off the football field. I am honored to lift up his contributions to Kentucky before the United States Congress.
