### Chamber Action

*Routine Proceedings, pages S5093–S5122*

**Standing with Israel:** By a unanimous vote of 97 yeas (Vote No. 261), Senate agreed to S. Res. 417, standing with Israel against terrorism. **Page S5102**

**Korean American VALOR Act:** Committee on Veterans' Affairs was discharged from further consideration of H.R. 366, to amend title 38, United States Code, to treat certain individuals who served in Vietnam as a member of the armed forces of the Republic of Korea as a veteran of the Armed Forces of the United States for purposes of the provision of health care by the Department of Veterans Affairs, and the bill was then passed. **Page S5103**

**Fargo National Cemetery:** Committee on Veterans' Affairs was discharged from further consideration of S. 2854, to require the Secretary of Veterans Affairs to enter into an agreement with the city of Fargo, North Dakota, for the conveyance of certain land of the Department of Veterans Affairs at Fargo National Cemetery, and the bill was then passed. **Pages S5103–04**

**Historian Emerita of the United States Senate:** Senate agreed to S. Res. 420, designating Betty K. Koed as Historian Emerita of the United States Senate. **Page S5104**

**National Chemistry Week:** Senate agreed to S. Res. 421, designating the week of October 15 through 21, 2023, as “National Chemistry Week”. **Page S5104**

**Gold Star Children's Day:** Senate agreed to S. Res. 422, designating August 1, 2023, as “Gold Star Children's Day”. **Page S5104**

**Whitaker Nomination–Cloture:** Senate began consideration of the nomination of Michael G. Whitaker, of Vermont, to be Administrator of the Federal Aviation Administration for the term of five years, Department of Transportation. **Page S5101**

## **MISCELLANEOUS MEASURES**

*Committee on Foreign Affairs:* Full Committee held a markup on H. Res. 559, declaring it is the policy of the United States that a nuclear Islamic Republic of Iran is not acceptable; H.R. 340, to impose sanctions with respect to foreign support for terrorist organizations, including Hamas and the Palestinian Islamic Jihad; H.R. 3266, to require the Secretary of State to submit annual reports reviewing the curriculum used by the Palestinian Authority, and for other purposes; H.R. 3774, to impose additional sanctions with respect to the importation or facilitation of the importation of petroleum products from Iran, and for other purposes; H.R. 5826, to require a report on sanctions under the Robert Levinson Hostage Recovery and Hostage-Taking Accountability Act, and for other purposes; H.R. 2973, to require the Secretary of Defense to develop, in cooperation with allies and partners in the Middle East, an integrated maritime domain awareness and interdiction capability, and for other purposes; H. Res. 599, urging the European Union to designate Hizballah in its entirety as a terrorist organization; and H.R. 1809, to require the development of strategies and options to prevent the export to Iran of certain technologies related to unmanned aircraft systems, and for other purposes.

### **THE ROLE OF TECHNOLOGY IN AVIATION SECURITY**

*Committee on Homeland Security:* Subcommittee on Transportation and Maritime Security held a hearing entitled "The Role of Technology in Aviation Security". Testimony was heard from Austin Gould, Assistant Administrator, Requirements and Capabilities Analysis, Transportation Security Administration, Department of Homeland Security; Mario Wilson, Assistant Administrator, Acquisition Program Management, Transportation Security Administration, Department of Homeland Security; and Tina Won Sherman, Director, Homeland Security and Justice Team, Government Accountability Office.
