Mr. GRIFFITH. Mr. Speaker Pro Tempore, I rise today to honor the life of James Dale 'Jim' Politis, who passed away on October 10th, at the age of 76.

A native of Chicago, Jim joined the Air Force in 1966 for four years, before attending Olympia Community College in Washington State. In 1974, he joined the family business at CB Centers of America. He met and married his wife Janice (Jan) a year later and they remained married for 47 years. Eventually, while living in Knoxville, Tennessee, Jim and his wife started their own business, J&F Distributing.

The family moved to Riner, Virginia in 1992, where they owned and operated the Brush Creek Buffalo Farm, Jan's family farm, raising Buffalo. They also ran the Brush Creek Buffalo Store in Riner.

Jim was on the Montgomery County Board of Supervisors from 1998 until 2013, serving as Chair for four of those years. During his time on the Board of Supervisors, I represented the Riner area, both when I served in the Virginia House of Delegates and then as a Member of the U.S. House of Representatives. I had the pleasure of working closely with him on a number of issues of concern.

One of the issues that Jim worked on was the legalization of Industrial Hemp. This is the product used to make fiber. The fiber product does not include very much THC (the active ingredient that gives the marijuana plant its potency). Industrial Hemp, thanks in part to Jim's lobbying efforts, was legalized in the 2014 Farm Bill.

He is survived by his wife Jan, Stepmother Lorraine Politis, Children James D. Politis II (Stephanie), Jeannetta Politis (Luis Prado-Roman), Jason Politis (Callie), grandchildren Emma, Andrew, Gavin, and Jenna Rae. Siblings Evelyn Bluemke, Karen Kaufman (Kevin), Sue Kaufman, Michael Kaufman (Debbie); as well as many nieces and nephews. I wish them all my deepest condolences on the loss of their loved one.

May Jim remain in the hearts of his loved one for years to come. He will not be forgotten for the positive impact he made on the Montgomery County community.

### DECLARATION OF MURDER

Before assuming his role in the Dallas Field Office, Mr. Smarr led as the Deputy SAIC in Houston, TX, where he oversaw the Secret Service's investigative and protective portfolio covering all southeast Texas and the country of Mexico. SAIC Smarr has dedicated his life to the integrated mission and responsibilities of the United States Secret Service and fulfilled his role with honor. I thank SAIC Smarr for all he had done to protect and serve our great Nation. I wish him the best in his well-deserved retirement.

**CLOSE AGENCY LOOPHOLES TO  
THE JONES ACT**

Mr. GARAMENDI. Mr. Speaker Pro Tempore, today I reintroduce the "Close Agency Loopholes to the Jones Act of 2023," which would close nearly 50 years of anti-Jones Act decisions—known as "letter rulings"—by U.S. Customs and Border Protection (CBP).

As chairman of the House Armed Services Subcommittee on Readiness and having served as ranking member of the Subcommittee on Coast Guard and Maritime Transportation from 2013 to 2018, I am committed to rebuilding the U.S.-flagged fleet including international and Jones Act vessels. For decades, Congress has stood idly by while federal regulators chipped away at the Jones Act, allowing foreign vessels paying poverty wages to take jobs from Americans working in our maritime industry. That must stop.

In December 2020, Congress enacted my amendment to the Outer Continental Shelf Lands Act as section 9503 of the William M. (Mac) Thornberry National Defense Authorization Act for Fiscal Year 2021 (Public Law 116–283) affirming that the application of the Constitution, laws, and civil and political jurisdiction of the United States to the Outer Continental Shelf also applies to non-mineral energy resources and exploring for, developing, producing, transporting, or transmitting such resources. As I stated in my remarks on September 24, 2020 (Congressional Record, Vol. 166, No. 166), Congress always intended U.S. law to apply to any form of exploration, development, production, transportation, and transmission of energy resources under the Outer Continental Shelf Lands Act of 1953.

On January 25, 2021, President Biden's first executive order (no. 14005) directed federal agencies to maximize the use of American mariners, American-built ships, and U.S.-flagged vessels under the Jones Act. In re-

sponse to my amendment enacted in the FY21 NOAA, U.S. CBP issued a headquarters ruling letter "HQ H309186" on January 27, 2021, correctly holding that the transportation of "scour protection" materials from the Port of Providence, Rhode Island to a wind project on the Outer Continental Shelf off the southeast shore of Martha's Vineyard is a coastwise activity under the Jones Act.

On March 17, 2021, the national trade association for the offshore wind industry sent a letter to the Commissioner of CBP requesting that the agency withdraw HQ H309186. In this letter, the offshore wind industry mischaracterized my September 2020 remarks from the CONGRESSIONAL RECORD as somehow supporting its request that CBP withdraw the January 27, 2021, letter ruling. On March 25, 2021, CBP issued a revised headquarters ruling letter (HQ H317289) contradicting its January 2021 letter ruling and the President's stated policy, allowing foreign vessels to construct energy projects on the Outer Continental Shelf.

To be clear, my September 2020 remarks in the CONGRESSIONAL RECORD stated that my amendment to Outer Continental Shelf Lands Act simply clarified that all forms of offshore energy development are indeed subject to the same U.S. laws that apply to the offshore oil and gas industry. That does not mean that I accept the validity of the many administrative loopholes to the Jones Act created by decades of bad letter rulings and poor enforcement by CBP. Rather, I have long held that many of the activities regulators have incorrectly allowed the offshore oil and gas industry to engage in using foreign-flagged vessels are clear violations of the plain text of the Jones Act and original Congressional intent.

It is now clear to me that the regulators at CBP are unwilling to fully implement the Jones Act, as directed by President Biden's Executive Order 14005. My 'Closing Agency Loopholes to the Jones Act' would finally force federal regulators to enforce the law as Congress intended in 1920, maximizing job opportunities for American mariners, U.S.-flagged vessels, and domestic shipyard workers. In effect, my legislation would also compel CBP to implement the President's stated policy by fully enforcing the Jones Act.

On April 26, 2023, the House Committee on Transportation and Infrastructure passed two key sections from my bill in the "Coast Guard Authorization Act of 2023" (H.R. 2741). Sections 8 and 9 from my bill are now incorporated as Section 312 (Notification) and Section 313 (Publication of Fines and Penalties) of H.R. 2741.

Section 312 requires foreign-flagged vessels purporting to operate under a Jones Act exemption to notify CBP and post online its legal basis for operating on the Outer Continental Shelf. Currently, CBP uses an honor system for foreign vessels operating on the Outer Continental Shelf and their legal basis for doing, which undermines the agency's ability to enforce the Jones Act properly and enables outright fraud. Section 313 requires CBP to publish online any penalties against foreign-flagged vessels operating illegally on the Outer Continental Shelf, including for failing to notify the agency of the purported Jones Act exemption in advance.

For this Congress, I also require in my bill that offshore energy developers on the Outer Continental Shelf pay a prevailing wage.

Under current law, project developers operating in the United States' Exclusive Economic Zone at sea can pay poverty wages, exploiting foreign workers and undermining American mariners' ability to compete for this work. After decades of failed promises, we are finally building the clean energy economy of the future. American mariners are ready, willing, and able to work in the burgeoning offshore wind industry. But they cannot be expected to compete against foreign-flag vessels paying poverty wages to workers with no legally guaranteed collective bargaining rights or labor standards.

Mr. Speaker Pro Tempore, I encourage all members of the House to cosponsor this critical and long overdue legislation.

I often think of the Abraham Lincoln quote when thinking of David, "the best way to destroy an enemy is to make him a friend." Instead of vilifying each other, we got to know each other and came to have deep respect for one another.

It is remarkable to me how much our lives mirrored one another. After attending Roanoke College and Wake Forest University law school, he returned home to practice law, as I did to Salem after attending law school. He served as Chairman of the Roanoke City Republican Committee while I was Chairman of the Salem Republican Committee. I am thankful that he was a strong supporter of my many political campaigns over the years.

During his life he was appointed Escheator by Governor Allen for Roanoke City, 1994, for 23rd Judicial District, 2001. He also served as Vice President of Legal Affairs, Blue Ridge Housing Development Corporation; Chairman, Roanoke City Fair Housing Board; and Member, Roanoke City Parks and Recreation Citizen Advisory Board.

A devout member of New Century Church in Roanoke, Virginia, David served many years as a volunteer greeter. After being diagnosed with stage four cancer in 2016, David used his remaining years to grow closer to Christ, finding peace and joy in his diagnosis.

David is survived by his son Kirk Nixon (Darlene Smith) and granddaughter Ella Nixon; daughter Jessica (Nick Blandy), grandchildren Finn and Declan Blandy; siblings, Carolyn "Kack" Lynch, John, and Debbie Nixon; twin sister, Denise "Cee" and Alan Campbell; as well as many nieces, nephews,

great-nieces, and great-nephews; and, his many friends, some of whom David considered like family. I pray for all of his loved ones during this difficult time.

David was a good Republican and a good Christian. He loved his family and friends deeply and lived his last days to the fullest, despite his diagnosis.

RECOGNIZING AND HONORING THE UNITED STATES AIR FORCE 555TH CIVIL ENGINEERING SQUADRON, KNOWN AS "TRIPLE NICKEL," RED HORSE UNIT

Mr. SESSIONS. Mr. Speaker Pro Tempore, it is my privilege to recognize and honor the United States Air Force 555th Civil Engineering Squadron, "Triple Nickel," as one of the original RED HORSE units for their distinguished service and commendable achievements during the Vietnam War.

In the thick of the Vietnam War, on October 1, 1965, the U.S. Air Force activated the first RED HORSE squadrons, notably the 555th and 554th Civil Engineering Squadrons (CES), which would soon earn their nicknames, "Triple Nickel" and "Penny Short," respectively. Initially designated as "Prime BEEF Heavy Repair" units, these squadrons quickly distinguished themselves, prompting leaders to coin the term "RED HORSE," an acronym for Rapid Engineer Deployable, Heavy Operations Repair Squadron—Engineering. Their mission was crucial—to establish a long-term civil engineering presence and provide major repair capabilities in the combat zones of Southeast Asia.

The deployment of RED HORSE units was a strategic move at a critical juncture in the war when the demands on Army and Navy construction units far exceeded their capacity. With the Army and Navy construction forces fully engaged, RED HORSE units emerged to fill the need. Upon deployment to Cam Ranh Air Base, South Vietnam, the Triple Nickel unit immediately began operations by hitting the beach with supplies and heavy equipment.

Civil engineer units from across the United States were assigned to various Air Force installations throughout Vietnam, including Cam Ranh, with some of the most distinguished officers and airmen being selected for RED HORSE duty. The 1969 roster that served in the 555th CES was composed of four hundred civil engineer personnel, arriving in Vietnam at the height of the war and responding to urgent infrastructural needs following the Tet Offensive of 1968, which delivered damaging blows to American installations up and down the peninsula.

Cam Rahn Air Base required significant infrastructure to sustain the war effort—from paved landing strips to dormitory housing for the troops. Triple Nickel not only repaired and constructed new facilities on Cam Ranh Air Base but also saw action at various American and Vietnam installations throughout the peninsula—from the Delta to the DMZ. In Vietnam, over two thousand RED HORSE troops deployed annually where they built both horizontal and vertical facilities to support the Air Force's mission and engaged in numerous humanitarian projects for local communities.

As the Vietnam War began to wind down in the early 1970s there were calls to deactivate units that had been formed during the war. However, thanks to the foresight of certain military and Congressional leaders who recognized the inherent value RED HORSE provides to the Air Force in both peace and war, multiple units remain in National Guard and Reserve organizations.

In the aftermath of the Vietnam War, the bonds formed during the conflict were not only maintained but strengthened. Now, veterans of Triple Nickel who served together in Vietnam occasionally gather to celebrate the friendships, accomplishments, and bonds that were forged in the challenging environment of a war-torn country.

It is my distinct honor to recognize the 555th Civil Engineering Squadron, "Triple Nickel," for the critical role they held in the Vietnam War and the enduring bond they maintain today.

Mr. DAVIS of Illinois. Mr. Speaker Pro Tempore, today, I wish to pay my deepest respects to Dr. Iris Shannon—a nurse, educator and administrator. I met and got to know Iris Shannon in the late 1960s when I began to work in healthcare, first at the Dr. Martin Luther King Health Center, the Westside Health Planning Organization and Mile Square Health Center.

I knew Iris as a competent, involved nurse, as Director of Nursing at Mile Square, as Director of Nursing at Rush Medical Center and as a Nursing Professor at Rush Medical School. The late 1960s and early 1970s were very serious health interest years and health activity due to the civil rights activity, changes in health law and the leadership of Democrats in government. These changes in health took place at all levels of government and Iris was what I call an activist.

There were meetings about health all over the place and practically all of the time. Iris was often present at many of these meetings, sharing her knowledge, her expertise and her wisdom. Iris worked with nurse groups, administrative groups, community groups, women

groups, black power group and the list goes on.

If it was about health and health care needs, Iris was there. Iris was an organizer, a joiner, a promoter, a practitioner, a scholar, a teacher, a mentor and a role model, not loud, but a leader who became President of the American Public Health Association.

Iris made her mark during what I call "movement time", a period when Black Americans were greatly moving out of the shadows of society. As I mentioned earlier, Dr. Shannon was not loud, but she was proud and as black as the ace of spades, if you know what I mean.

Iris possessed Black pride, expressed Black principles, stood up for Black people and exuded Black excellence. Iris was a caring and wonderful nurse, a great scholar, teacher and administrator, a visionary leader and an amazing friend.

I am so glad to have known and worked with her. Dr. Iris Shannon was a role model to so many and will be missed by the multitudes, but her legacy of service shall endure.

Eden Housing also develops high-quality housing communities for low-income families, seniors, veterans, and persons with disabilities throughout my district, the wider Bay Area, and California. Eden Housing properties ensure that residents receive supplemental resident and enrichment programs to support their

well-being. These services include wellness checks, physical education, and financial workshops.

Over the course of its history, Eden Housing has developed nearly 12,000 affordable housing units across 155 properties in California, with more than 100,000 residents calling Eden Housing properties home. Since its inception, Eden Housing has also awarded over 620 scholarships to residents totaling more than \$1 million in support of their academic and professional goals.

It has been my privilege to support Eden Housing's work by passing a direct appropriation of \$1 million for the development of a veterans' park in Livermore. Their hard work was also recently recognized by the Department of the Treasury's Community Development Financial Institutions Fund award of \$10 million.

In sum, Eden Housing is pivotal to improving California neighborhoods through nurturing relationships with residents and diverse community partners. I am grateful for the 55 years of hard work that Eden Housing has undertaken to become a leader in the establishment of affordable housing in our state. I ask that my colleagues join me in celebrating Eden Housing's legacy and wish it many more productive years to come.
