# EXTENSIONS OF REMARKS

Mr. BILIRAKIS. Mr. Speaker, I rise today to bring to the attention of the Congress and Citizens of the United States a praiseworthy statement signed by thousands of our staunch ally, the United Kingdom, whose thought leaders and public figures declared solidarity with Israel and the Jewish people during one of the greatest periods of catastrophe, suffering, and trial since the Nazi Holocaust. As Co-Chair of the Congressional Hellenic-Israel Alliance, as well as the International Religious Freedom Caucus, I feel it a duty highlight and commend these significant gestures.

At a time when the world is in urgent need of moral clarity, leaders of media, government, business, sport, and the arts of the UK have risen masterfully to the occasion to establish British Friends of Israel with its clear-eyed statement—the October Declaration, signed by, as of this moment, nearly 100,000 of some UK's most influential, accomplished, and notable citizens. Many excerpts best express what much of the world holds true regarding our Jewish brothers and sisters who are tragically confronting the ugliness of anti-Semitism in real time. In part, the Declaration reads:

"We unequivocally condemn all acts of terrorism against civilians in Israel, especially the massacre on 7 October 2023.

"On 7 October 2023 the State of Israel and her citizens, both Jews and non-Jews, were subjected to a brutal terrorist attack, which resulted in the murder, torture, rape and kidnapping of over 1.500 people.

"More Jews were killed on that day than on any other day since the Holocaust. We are aware that Jews are not the only victims of this tragedy. Hamas knew that there would be consequences to 7 October, but the consequences did not weigh with Hamas.

"Its ongoing terrorist operation is calculated to cause maximum fear and distress. The people of Israel have been subjected to a near constant bombardment of rockets from Gaza and Lebanon. Civilians of all kinds—including the elderly, disabled, women, children, and babies—have been targeted in a direct breach of the rules of war.

"We call for all the hostages taken on 7 October to be released immediately. It is an essential step on the path to peace and the cessation of hostilities.

"We stand in support of British Jews and condemn acts of anti-Semitism.

"British Jews should not live in fear because of actions taken by the state of Israel to defend itself. The British state must do everything in its power to protect them.

"We ask the media, members of all political parties and everyone in public life to call out Hamas for what it is: a terrorist organisation.

"Hamas, whose actions have led directly and indirectly to the tragic deaths of many Palestinian civilians as well as Israelis, is a proscribed terrorist organisation in the UK as well as in many other states. The Home Secretary and the Prime Minister have iden-

tified Hamas as a terrorist organisation. Failure to use the correct language—describing Hamas as 'militants' or 'fighters', for instance—creates the false impression that Hamas and Israel's armed forces are morally equivalent and is an affront to the group's victims—the dead, their families, and those currently being held hostage.

Mr. Speaker, in our time, who could have anticipated the need to take such a stand in nations like the United States and the United Kingdom against unspeakable events that unfolded exactly one month ago today. But regrettably, denial of the atrocities and the willingness of some to side with Hamas have exposed a layer of society that raises concerns about the value placed on Jewish lives.

The idea for British Friends of Israel came from leading British public figures including journalists Laura Dodsworth, Allison Pearson, Toby Young, legal scholar Francis Hoar, Think Tank head Emma Webb and others who recognize the duty to express solidarity with global Jews. The speed at which the media narrative shifted from the savagery of Hamas attacks to concern about the destruction in Gaza is disheartening.

We have witnessed bias and antagonism by public figures, some in this Congress, some in the media, and some at leading American universities in the face of these atrocities. This is beyond troubling.

In the words of Sir Tom Stoppard, "Before we take up a position on what's happening now, we should consider whether this is a fight over territory or a struggle between civilization and barbarism."

Let us stand united with British Friends of Israel and The October Declaration. By lending our voices, we send a powerful message of support to our Jewish brothers and sisters in Israel and around the world. The stakes are critical in the fight for Civilization over barbarism.

HONORING THE 30TH ANNIVER-SARY OF THE PIKES PEAK FIRE-ARMS COALITION OF COLORADO

Mr. LAMBORN. Mr. Speaker, I rise today to honor the 30th anniversary of the Pikes Peak Firearms Coalition of Colorado, a leading voice for firearms rights in my Congressional District. The organization's purpose is to advocate, support, and protect the right to keep and bear arms as enumerated in the Second Amendment to the U.S. Constitution and Article II, Section 13 of the Colorado Constitution and to promote the safe, responsible, and lawful use of firearms.

Initially formed in 1992 as the Colorado Springs Chapter of the Firearms Coalition of Colorado, in 1993 the group formed their own local organization as the Pikes Peaks Firearms Coalition and incorporated as a Colorado non-profit. Since then, they have advocated for firearm rights before the Colorado Springs City Council, the El Paso County Board of Commissioners, and the Colorado General Assembly. The effect of their advocacy is farreaching. They sponsor groups that teach young people the safe handling and storage of firearms. Additionally, they provide financial support to local gun ranges including the Cheyenne Mountain Shooting Complex at Fort Carson and previously assisted in cleanup efforts for the U.S. Forest Service Rampart Range shooting area while it was in operation. In their monthly meetings, they promote the safe and lawful use of firearms. They invite speakers to present programs on various firearm issues, equipment, training, and techniques. Hundreds of people have benefited from the Pikes Peak Firearms Coalition of Colorado's educational and practical approach.

At their core, Pikes Peak Firearms Coalition members believe that the Second Amendment protects an individual's right to keep and bear arms in defense of their home, person, and property and to protect against a tyrannical government. Ultimately, they believe the firearms issue to be entered entwined with civil rights, and object to all anti-gun proposals which limit the ability of the elderly, the poor, the handicapped, or other legally armed citizens to defend themselves. Finally, they firmly believe that to control crime, we must focus on the perpetrator rather than his instrument. The irresponsible banning of a weapon based solely on emotion only serves to empower criminals, as law-abiding citizens, by definition, do not break the law.

I would like to offer my sincere congratulations on 30 years of advocacy to a group that upholds and protects the Second Amendment so well.

Throughout its history, the Eisner Memorial Red Bank Public Library has supported and been supported by the community. Sigmund Eisner was a prominent Red Bank resident and longtime benefactor of the library. The library's current location is the former Eisner residence, which was gifted to the library by his sons. The family continues to support the library today.

The Eisner Memorial Red Bank Public Library maintains outstanding resources and accessibility for its patrons. Over the years, the library has expanded its collection and offerings. It has evolved with technology and the changing needs of its visitors and pivoted during the COVID-19 pandemic to still meet the needs of the community while observing health protocols and precautions.

Ms. McCOLLUM. Mr. Speaker, I rise to address my votes on bills passed through the House of Representatives under suspension of the Rules the week of October 30. 2023: H. Res. 559, H.R. 340, H.R. 3774, and H. Res.

I voted no on H. Res. 559 because it contained language that could insinuate U.S. support for potential military action against Iran at a moment when de-escalation is necessary. This legislation was overly broad, and without an opportunity for proper debate on the House Floor, this bill has the potential to give license to the United States to use any means, including military action, against Iran without Congressional approval.

I voted no on H.R. 340, the Hamas International Financing Prevention Act, because it was intentionally amended to delay humanitarian aid to Gaza, where people are suffering without access to food, drinking water, fuel, and medical care. The United States has rightly designated Hamas as a terrorist organization since 1997—but holding Hamas accountable cannot come at the expense of Palestenian civilians living in Gaza, roughly 40 percent of which are under 14 years of age. This is dangerous, as civilians must be protected under international law.

I voted no on H.R. 3774, the SHIP Act, because the bill contains overly broad language that would have serious impacts on the global economy and the U.S. economy as well. Sanctions are one of the most important and impactful diplomatic tools that we have in managing our relationships and security around the globe. The Executive Branch that administers them needs to be able to adjust and scale sanctions for them to be effective. The waiver within this bill provides the Executive with limited flexibility—rendering the waiver provision nearly unusable.

I voted yes on H. Res. 798 condemning the support of Hamas, Hezbollah, and other terrorist organizations at institutions of higher education because every student deserves a safe environment in which to learn and live. This resolution fails to mention the concurrent rise in anti-Muslim and anti-Arab hate. It is a glaring omission not to include other protected classes. Antisemitism and Islamophobia are on the rise in the U.S., and hatred in all its forms is unacceptable and must not be tolerated anywhere.

All people deserve safety and security, and the only sustainable path forward is one where international human rights and international law are at the forefront and democratic ideals are upheld. Peace must remain our utmost goal in the days, weeks, and months ahead.

RECOGNIZING THE HEROIC SERV-ICE OF KADRI CAKRANI DURING THE HOLOCAUST

Mr. DAVIS of Illinois. Mr. Speaker, I wish to take this opportunity to recognize the humanitarian efforts of Albanian Commandant-General Kadri Cakrani.

On Saturday, November 11, 2023, the Albanian and Southeastern European Studies Program at DePaul University will host an event entitled, The Cakrani Family of Albania: Repairing the Fabric of History, that will honor the work of General Cakrani in protecting Jews during the Holocaust and advancing Democracy in Albania. Illinois is the home of many relatives of General Cakrani, including my constituents Elizabeth Cakrani Vrato, Evan Metaj, and Abigail Vrato—his granddaughter, great-great-grandson, and great-granddaughter, respectively.

During the German occupation of Albania. Commandant-General Cakrani led the protection of over 600 Jewish refugees and residents in the Berat region from Nazi capture during the Holocaust. At risk of death, General Cakrani lied to Nazi officials about the whereabouts of Jews hiding in Albania and guided efforts to shelter Jews in safe hiding locations, including his own home. His courage and leadership contributed to Albania being the only European country that ended World War Il with more Jewish residents than at the start of the war. Further, General Cakrani sheltered three American Army nurses and secretly returned them to Allies after their plane crashed in Albania.

In 1951, General Cakrani moved to the United States after President Harry Truman granted him political asylum. He worked with the U.S. Intelligence to try to bring Democracy to Albania for the remainder of his life. The lives and safety of families and individuals depended on General Cakrani's silence about his efforts during his lifetime. The DePaul event is a step to recognize his humanitarian work during and after the war.

The Auschwitz Memorial Museum, the United States Holocaust Museum, the Illinois Holocaust Museum, the Jerusalem Post, and the Israel Hayom have all recognized General

Cakrani's service and bravery. Illinois Governor J.B. Pritzker recently issued an executive proclamation recognizing November 11, 2023, as Kadri Cakrani Day in Illinois.

I wish to add my voice to those recognizing the service and bravery of Commandant-General Kadri Cakrani in the protection of Jews during the Holocaust and his work to promote Democracy in Albania. I wish his family well as they honor his work this week at the DePaul event on Kadri Cakrani Day in Illinois.

Sergeant First Class Montgomery was born in Tucson, Arizona, and graduated high school in Spring Creek, Nevada. He enlisted in the U.S. Army as a 19D Cavalry Scout and attended One Station Unit Training in Fort Knox, Kentucky, graduating with honors. His long and distinguished military career includes deployments in Operations Enduring Freedom and Iraqi Freedom, where he earned numerous awards and accolades including the Bronze Star, the Meritorious Service Medal, the Army Commendation Medal, the Valorous Unit Award, and the Iraq Campaign Medal with 3 Stars, reflecting his exceptional service to our country. He has now earned the Purple Heart, an award reserved only for those who are wounded or killed in service to our nation. In July of 2015, Sergeant First Class Montgomery was medically discharged from the United States Army and now resides in Colorado's Third District with his six wonderful children: Rain, Porter, Lexington, Izabella, Kai, and Koda.
