**Measures Introduced:** Twenty-seven bills and four resolutions were introduced, as follows: S. 3263–3289, S.J. Res. 49–50, and S. Res. 458–459.

**National Native American Heritage Month:** Senate agreed to S. Res. 459, recognizing National Native American Heritage Month and celebrating the heritages and cultures of Native Americans and the contributions of Native Americans to the United States.

**Condemning Hamas:** Committee on Foreign Relations was discharged from further consideration of S. Res. 408, condemning Hamas for its premeditated, coordinated, and brutal terrorist attacks on Israel and demanding that Hamas immediately release all hostages and return them to safety, and the resolution was agreed to, after agreeing to the following amendments proposed thereto:

Wagner amendment (No. 102 printed in part B of H. Rept. 118–269) that prohibits use of funds to finalize or implement the proposed interpretive guidance of the Financial Stability Oversight Council titled “Authority To Require Supervision and Regulation of Certain Nonbank Financial Companies”;

Williams amendment (No. 104 printed in part B of H. Rept. 118–269) that prohibits the SBA from creating any new business lending program; and

**Pages H5660–61**

Tenney amendment (No. 101 printed in part B of H. Rept. 118–269) that prohibits funding to finalize, implement, or enforce the FAR Council’s proposed “Federal Acquisition Regulation: Disclosure of Greenhouse Gas Emissions and Climate-Related Financial Risk” rule (by a recorded vote of 220 ayes to 202 noes, Roll No. 642). **Pages H5658–59, H5662**

Rejected:

Tenney amendment (No. 100 printed in part B of H. Rept. 118–269) that sought to reduce the salary of White House Press Secretary Karine Jean-Pierre to \$1 (by a recorded vote of 165 ayes to 257 noes with one answering “present”, Roll No. 641).

H. Res. 847, the rule providing for consideration of the bill (H.R. 4664) was agreed to Tuesday, November 7th.
