Mr. GREEN of Tennessee. Mr. Speaker, I rise today to honor the distinguished career and faithful service of Patrol Captain Donnie Dill, and to congratulate him on his retirement.

Born and raised in Stewart County, Tennessee, Donnie dedicated his career to serving his fellow Tennesseans and the public good. He started this mission in October 1990, when he joined the Clarksville Police Department (CPD). Over the course of four years, he faithfully enforced the law and stood on the frontlines, protecting citizens and the community at-large. After his tenure with CPD, he used the following year to serve Montgomery and Stewart Counties as a law enforcement officer and public servant.

Because of his outstanding service in law enforcement, Donnie was hired to serve on the 23rd Judicial District Drug Task Force. With jurisdiction over Stewart, Houston, Humphries, Cheatham, and Dickson Counties, including portions of Interstate-40—a known drug pipeline—Donnie worked to disrupt, intercept, and remove dangerous substances.

Donnie also served as a law enforcement officer for the City of Dover and Stewart County, his home.

In 2002, Donnie joined the Tennessee Valley Authority (TVA) Police, a federal law enforcement agency responsible for protecting critical infrastructure, employees, and assets within the TVA system. TVA facilities provide power and critical services for millions of people across seven states, making them a prime target for criminal activity. While serving as a federal law enforcement officer, Donnie protected and preserved these assets and employees, helping the Tennessee Valley flourish.

From 2003 to 2007, Donnie also served in the United States Fish and Wildlife Service through the Department of the Interior. Tennessee is blessed with abundant natural resources, including bountiful lakes and rivers and beautiful landmarks, all needing careful maintenance and protection. Following his work for the Fish and Wildlife Service, Donnie joined the United States Forest Service, where he has served faithfully ever since. For his excellent service, he was promoted to Patrol Captain in 2021 for the Land Between the Lakes National Recreation Area.

Beyond his vast experience in law enforcement, Donnie excelled as a leader and mediator, winning over people from diverse backgrounds and opinions on forest management and enforcement. He frequently served as the go-between for various contentious issues and ensured that all sides were heard. Because of his deep roots in the community and his dedication to the public good, Donnie is a uniquely gifted public servant who used his gifts to serve others.

On behalf of the United States Congress, I thank Patrol Captain Donnie Dill for his exceptional public service, and I congratulate him on his well-earned retirement. I wish Donnie and his family the best in his future endeavors, and I hope he knows that his legacy will outlive his outstanding career.

#### TRIBUTE TO LUISA BUADA, R.N., B.S.N, M.P.H. ON HER RETIREMENT

Ms. ESHOO. Mr. Speaker, I rise today to honor an extraordinary woman, Luisa Buada, who brought culturally sensitive, integrated primary and preventive health care to thousands in a highly underserved community. She brought this care regardless of ability to pay or immigration status and collaborated with community partners to address the social determinants of health.

Luisa Buada was the founding Executive Director of Clinicas de Salud in the Salinas Valley and the Berkeley Primary Care Access Clinic, and cofounded LifeLong Medical Care in Berkeley as part of a merger with Over 60 Health Center in 1996.

In the early 2000's in the wake of the closure of the Charles Drew Health Center by the federal government, a group of community leaders and I came together to explore creating a new, vital health care system to support the low-income communities of East Palo Alto and Menlo Park. Residents and representatives of Stanford Health Care and San Mateo County met regularly for months to form what is now the Ravenswood Family Health Network, a Federally Qualified Health Center that now cares for approximately 21,000 patients. Of these, 7,576 are children and adolescents, 90 percent are low-income, and 88 percent identify as an ethnic minority. About 63 percent are enrolled in public health coverage, and 27 percent are uninsured.

Luisa Buada was the consultant in the development of Ravenswood, and despite her insistence that she was only temporary, after serving 12 months as Interim Chief Executive Officer she became Ravenswood's Permanent CEO in November 2003. Luisa received her Bachelor of Science degree in Nursing from the University of California, San Francisco School of Nursing in 1977 and her Master's degree in Public Health Policy and Administration from the University of California, Berkeley in 1990. In March of 2010, Buada was inducted into the San Mateo County Women's Hall of Fame. In 2013 she received the California Senate Woman of the Year Award for the 13th District and was a 2016 San Francisco Chronicle and St. Mary's College Vision-

ary of the Year Award Honoree. She received the 2016 John W. Gardner Exemplary Leadership Award from the American Leadership Forum of Silicon Valley and in 2018 she received the California State Assembly Woman of the Year award for the 24th District. She has earned and deserves all these honors.

Mr. Speaker, I ask the entire House of Representatives to join me in honoring Luisa Buada as she begins her retirement. She has been an extraordinary leader who brought health services to many thousands who otherwise would not have been cared for. She is a national treasure that I shall treasure all the days of my life.

Under Thelda's guidance, the City invested in Sky Harbor International Airport and water infrastructure, and she played a crucial role in strengthening and expanding the City's transit system. Her vision for the City's infrastructure and planning was truly ahead of its time, and the newly-dedicated "Thelda Williams Transit Center" in North Phoenix is a testament to her advocacy.

Thelda was also deeply committed to improving the lives of incarcerated people by helping them see a positive future for themselves. During her tenure at the Maricopa County Sheriff's office, Thelda took charge of developing a drug rehabilitation program for inmates, establishing a juvenile high school, as well as initiating several other adult programs.

Thelda was also a passionate voice for animal welfare, leading several city policy changes to protect pets. At MCSO, she spearheaded a program to allow inmates to care for and rehabilitate abused animals and get them ready for adoption. Phoenixians and their four-legged friends still enjoy the "Thelda Williams Paw-Pup Park," the first dog park in downtown Phoenix.

We lost Thelda at the age of 82 on November 14, 2023, but her legacy is reflected in the countless lives she touched with her compassionate leadership. Godspeed.

Mr. WITTMAN. Mr. Speaker, I rise today in recognition of America's fifth President, James Monroe, and to celebrate the Bicentennial of the Monroe Doctrine.

President James Monroe was born on April 28, 1758, to a middle-class family in what would eventually become Virginia's First District. Monroe was a fierce advocate for American independence from the very beginning. At only 18 years old, he enlisted in the Continental Army, where he fought and was wounded while serving under General George Washington.

In the earliest years of our fledgling nation, Monroe would distinguish himself as master diplomat and lay the foundations of United States foreign policy. As Minister to France, he helped negotiate the Louisiana Purchase, doubling American sovereign territory. After being appointed Secretary of War, he masterfully defended the country during the War of 1812, and managed the acquisition of Florida, all while forging alliances and boosting the United States' standing on the world stage. His skill at statecraft was recognized by the public and he was elected President in 1816.

President Monroe's crowning achievement as a leader was the creation of his namesake Monroe Doctrine. On December 2, 1823, the United States took the important step of recognizing and establishing trade and defense treaties with the newly independent republics

of Latin America. By vowing to aid these countries against invasions by European colonial powers, Monroe began a proud American tradition of a bold foreign policy that promotes freedom and democratic values abroad.

I am honored to represent Virginia's First District, the place Monroe once called home. I am inspired by Monroe's devotion to fundamental American values, and his committed belief that our rights and the freedoms we derive from them deserve to be shared not just by our countrymen, but by all people.

Mr. Speaker, I ask you to join me in recognizing President James Monroe and the Bicentennial of his most outstanding work of statesmanship, the Monroe Doctrine. Corbett is the last surviving member of the "Triple Nickles," which was assigned to one of the most dangerous operations to save lives from the aftermath of a clandestine Japanese balloon attack in the Western United States.

Today, he is a retired schoolteacher, Bank Director for Citrus & Chemical Bank, two-time Florida Track Coach of the Year, member of the Florida High School Athletic Association Hall of Fame and member of the Florida Veterans Hall of Fame.

This revolutionary and game-changing program ensured that remote underserved Alaska Villages, would have a real and economically viable stake in the vast and valuable federal fisheries harvested in close proximity to their communities. Justine Gunderson played her own invaluable role in making it happen.

In 1976, Justine Gundersen made Nelson Lagoon her home with her late husband, Paul Gundersen. "The Lagoon," is nestled on the north side of the Alaska Peninsula, on a narrow sand spit, 580 miles southwest of Anchorage and 70 miles north of Cold Bay. Nelson Lagoon, which the Unangax people originally used as a seasonal fish camp, has developed into a close-knit, year-round community with commercial fishing as its economic backbone.

Since the inception of the CDQ program, Justine has been a cornerstone, holding a position on the APICDA board since its earliest days. Her guidance helped lay the foundation for the APICDA board and played a pivotal role in shaping the trajectory of the entire program.

Justine's list of accomplishments is extensive, serving on influential bodies such as the Advisory Panel for the North Pacific Fishery Management Council, the Alaska Seafood

Marketing Institute Board, the Aleutians East Borough Assembly, and the Nelson Lagoon Advisory Board.

What truly distinguishes Justine is not merely the duration of her service, but the unwavering commitment that propels it—a resolute determination to ensure that the state's villages, regardless of their size and remoteness, receive the attention they deserve. With the accumulating of nearly 50 years of service, Justine has become a beacon of knowledge, dedicating herself to educating others about village life.
