### Chamber Action

*Routine Proceedings, pages S5831–S5881*

**Measures Introduced:** Twenty-eight bills and two resolutions were introduced, as follows: S. 3430–3457, and S. Res. 491–492. **Pages S5851–52**

#### Measures Reported:

S. 3430, to amend titles XVIII and XIX of the Social Security Act to expand the mental health care workforce and services, reduce prescription drug costs, and extend certain expiring provisions under Medicare and Medicaid. (S. Rept. No. 118–121)

S. 2973, to amend titles XVIII and XIX of the Social Security Act to establish requirements relating to pharmacy benefit managers under the Medicare and Medicaid programs, with an amendment in the nature of a substitute. (S. Rept. No. 118–122)

**Removal of United States Armed Forces From Hostilities in Syria:** By 13 yeas to 84 nays (Vote No. 333), Senate rejected the motion to discharge the Committee on Foreign Relations of S.J. Res. 51, directing the removal of United States Armed Forces from hostilities in Syria that have not been authorized by Congress. **Pages S5834–37**

Ford Federal Direct Loan Program and the Federal Family Education Loan (FFEL) Program”, by a yea-and-nay vote of 210 yeas to 189 nays, Roll No. 705. **Pages H6720–24, H6724–25**

H. Res. 906, the rule providing for consideration of the bills (H.R. 4468) and (H.R. 5933) and the joint resolution (H.J. Res. 88) was agreed to Tuesday, December 5th.

**Censuring Representative Jamaal Bowman:** The House agreed to H. Res. 914, censuring Representative Jamaal Bowman, by a yea-and-nay vote of 214 yeas to 191 nays with 5 answering “present”, Roll No. 706. Consideration began yesterday, December 6th. **Pages H6725–26**
