### Chamber Action

*Routine Proceedings, pages S6013–S6029*

**Measures Introduced:** Three bills and four resolutions were introduced, as follows: S. 3554–3556, and S. Res. 511–514. **Page S6022**

**Measures Reported:**

S. 912, to require the Secretary of Energy to provide technology grants to strengthen domestic mining education. (S. Rept. No. 118–139) **Page S6022**

**Measures Passed:**

**Overtime Pay for Protective Services Act:** Committee on the Judiciary was discharged from further consideration of S. 3427, to extend the authority to provide employees of the United States Secret Service with overtime pay beyond other statutory limitations, and the bill was then passed. **Page S6025**

**Disaster Contract Improvement Act:** Senate passed S. 310, to establish an advisory group to encourage and foster collaborative efforts among individuals and entities engaged in disaster recovery relating to debris removal. **Pages S6025–26**

**GAO Database Modernization Act:** Senate passed S. 679, to amend chapter 8 of title 5, United States Code, to require Federal agencies to submit to the Comptroller General of the United States a report on rules that are revoked, suspended, replaced, amended, or otherwise made ineffective. **Page S6026**

**Technical Correction to the Shoshone-Paiute Tribes of the Duck Valley Reservation Water Rights Settlement Act:** Senate passed S. 950, to amend the Omnibus Public Land Management Act of 2009 to make a technical correction to the water rights settlement for the Shoshone-Paiute Tribes of the Duck Valley Reservation, after agreeing to the committee amendment. **Pages S6026–27**

**Eliminate Useless Reports Act:** Senate passed S. 2073, to amend title 31, United States Code, to require agencies to include a list of outdated or duplicative reporting requirements in annual budget justifications, after agreeing to the committee amendment in the nature of a substitute. **Page S6027**

**NWR Modernization Act:** Senate passed S. 1416, to provide guidance for and investment in the upgrade and modernization of the National Oceanic and Atmospheric Administration Weather Radio All Hazards Network. **Pages S6027–28**

**National Weather Service Communications Improvement Act:** Senate passed S. 1414, to improve the instant messaging service used by the National Weather Service. **Page S6028**

**Reuse Excess Property Act:** Senate passed S. 2685, to make data and internal guidance on excess personal property publicly available, after agreeing to the committee amendment in the nature of a substitute. **Pages S6028–29**

**National Lung Cancer Awareness Month:** Senate agreed to S. Res. 512, designating November 2023 as “National Lung Cancer Awareness Month” and expressing support for early detection and treatment of lung cancer. **Page S6029**

**Wright Brothers Day:** Senate agreed to S. Res. 513, recognizing December 17 as “Wright Brothers Day” and commemorating the 120th anniversary of the first powered flight. **Page S6029**

**Florida State University Seminoles Women’s Soccer Champions:** Senate agreed to S. Res. 514, congratulating the Florida State University Seminoles for winning the 2023 National Collegiate Athletic Association Division I Women’s Soccer Championship. **Page S6029**

**Removal of Injunction of Secrecy:** The injunction of secrecy was removed from the following treaty:

The Treaties with the Republic of Cuba and the Government of the United Mexican States on the Delimitation of Maritime Boundaries (Treaty Doc. No. 118–1).

The treaty was transmitted to the Senate today, considered as having been read for the first time, and referred, with accompanying papers, to the Committee on Foreign Relations and ordered to be printed. **Pages S6021–22**

**Fonzone Nomination—Agreement:** Senate resumed consideration of the nomination of Christopher Charles Fonzone, of Pennsylvania, to be an Assistant Attorney General. **Page S6020**

A unanimous-consent agreement was reached providing for further consideration of the nomination at approximately 11 a.m., on Tuesday, December 19, 2023; that the motions to invoke cloture filed during the session of the Senate of Wednesday, December 13, 2023, ripen at 2:15 p.m.; that if cloture is invoked on either of the nominations of Christopher Charles Fonzzone, or Sara E. Hill, of Oklahoma, to be United States District Judge for the Northern District of Oklahoma, all post-cloture time be considered expired and Senate vote on confirmation of the nominations immediately following the invoking of cloture; that upon disposition of the nominations, Senate execute the order of Tuesday, December 5, 2023, with respect to the nomination of Elizabeth H.
