Cybersecurity Risk Management, Strategy, Governance, and Incident Disclosure Rule—Agreement: A unanimous-consent-time agreement was reached providing that notwithstanding rule XXII and 5 U.S.C. 802, and at a time to be determined by the Majority Leader, in consultation with the Republican Leader, no later than January 31, 2024; if S.J. Res. 50, providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Securities and Exchange Commission relating to "Cybersecurity Risk Management, Strategy, Governance, and Incident Disclosure", is discharged from the Committee on Banking, Housing, and Urban Affairs, it be in order for Senator Tillis, or his designee, to move to proceed to the consideration of the joint resolution; that if the motion is agreed to, there be 10 hours of debate equally divided between the proponents and opponents of the joint resolution; that upon the use or yielding back of that time, Senate vote on passage of the joint resolution; and that all other provisions under chapter 8 of title 5, United States Code, remain in effect except the 60 session day clock.
