### NEW PUBLIC LAWS

H.R. 1734, to require coordinated National Institute of Standards and Technology science and research activities regarding illicit drugs containing xylazine, novel synthetic opioids, and other substances of concern. Signed on December 19, 2023. (Public Law 118–23)

H.R. 3315, to exempt for an additional 4-year period, from the application of the means-test presumption of abuse under chapter 7, qualifying members of reserve components of the Armed Forces and members of the National Guard who, after September 11, 2001, are called to active duty or to perform a homeland defense activity for not less than 90 days. Signed on December 19, 2023. (Public Law 118–24)

S. 788, to amend the Permanent Electronic Duck Stamp Act of 2013 to allow States to issue fully electronic stamps under that Act. Signed on December 19, 2023. (Public Law 118–25)

S. 2747, to amend the Federal Election Campaign Act of 1971 to extend the Administrative Fine Program for certain reporting violations. Signed on December 19, 2023. (Public Law 118–26)

S. 2787, to authorize the Federal Communications Commission to process applications for spectrum licenses from applicants who were successful bidders in an auction before the authority of the Commission to conduct auctions expired on March 9, 2023. Signed on December 19, 2023. (Public Law 118–27)

H.J. Res. 62, providing for the reappointment of Michael Govan as a citizen regent of the Board of Regents of the Smithsonian Institution. Signed on December 21, 2023. (Public Law 118–28)

H.J. Res. 63, providing for the appointment of Antoinette Bush as a citizen regent of the Board of Regents of the Smithsonian Institution. Signed on December 21, 2023. (Public Law 118–29)

H.J. Res. 64, providing for the reappointment of Roger W. Ferguson as a citizen regent of the Board of Regents of the Smithsonian Institution. Signed on December 21, 2023. (Public Law 118–30)
