Mrs. KIGGANS of Virginia. Mr. Speaker, I include in the RECORD remarks submitted at the request of a Virginia Beach constituent, Rabbi Dr. Israel Zoberman of Temple Lev Tikvah, and are a reflection of his views:

I have returned from the torn Land of Israel where I grew up, following a visit throughout July of a shaking, even shocking experience. Israel is undergoing a trauma whose lasting impact is impossible to predict. However, the current internal crisis threatening Israeli democracy, the Middle East's sole one, is due to the most extreme coalition government in Israel's history attempting to alter its Western liberal orientation by disabling the Supreme Court's standing as an independent Judiciary. Consequently, the unprecedented mass demonstrations for months in opposition to the proposed radical agenda which I watched in disbelief and participated in, have reflected a powerfull popular response determined to preserve Israel as both the Jewish and democratic state envisioned by its founders. Already adversely affected are the Israeli economy, military, public health, the woman's status, education, Pride community and society at large, while Israel's enemies, Iran and its proxies, become further emboldened. The special relationship between Israel and the United States is at risk as well as the essential bond between Israel and American Jewry

With heartfelt, even prophetic pathos and deep grasp of the multi-layered Israeli scene since its inception and prior, veteran Israeli author Ari Shavit offers us a concise manifesto for urgent action with the goal of "Saving Israel," his recent book's alarming title (Saving Israel. Rishon LeZion: Miskal-Yedioth Ahronoth Books and Chemed Books. 2023). He begins with a statement of both profound gratitude and grave concern, "the State of Israel is a miracle. No other nation did what we have: To build anew a national home following two thousand years. No progressive democracy succeeded to flourish as we have, following a Shoah and living under a volcano. Despite all the troubles, problems, weaknesses, difficulties and blemishes-The Zionist dream has been realized. The people of Israel lives and the state of Israel lives. Our sons and daughters have in our ancestral land what our grandfathers and grand-mothers did not: Sovereignty, freedom, prosperity, pride and progress. Being a technological, economic, military and political super-power, Israel of the 21st century is a strong country capable of shaping its own fate and march toward a brilliant future. But the deep 2023 crisis threatens the Israeli miracle and erasing our astonishing successes, leaving us homeless.

Shavit does not mince words. On the one hand, heaps praise upon Israel's successes though Israel is not a global, as the author claims, but a regional superpower. In light of trying beginnings and facing monumental challenges that were likely to doom the fragile creation: Attacks from a collection of su-

perior military establishments while absorbing penniless immigrants from west and east three times larger in size, into a war zone with meager resources. On the other hand, he bemoans the Jewish people's destructive tendencies that brought down Jewish sovereignty and led into long exile and ultimately a consuming Holocaust. "And the Jewish people has multi-talents though sorrowfully it lacks the talent to be a people. It tends toward extremism, internal strife and self-destruction . . . Israel needs to be both powerful and ethical, both national and liberal, both Jewish and democratic. Only a combination of resoluteness and openness will guarantee that not weakness nor zealousness will bring us again to the pit's

The author is convinced that the goal is within reach though the hour is late and the Israelis with all their complexities and tribal tendencies ought not further delay. He thus concludes, "The good and silent great Israeli majority will not remain still. The democratic Jews will not let a wondrous national and human enterprise to go down. For all of us have a stake in this special place. And we all know that there wouldn't be a Fourth Commonwealth. The Third Commonwealth is the Jewish people's last opportunity. With determination, love and faith we'll defend Israel and rebuild the house."

Mr. FITZPATRICK. Mr. Speaker, I rise today in recognition of the achievements of a remarkable constituent from my district, Dr. John Germiller. Dr. Germiller is an attending sur-

geon and Director of Clinical Research in the Division of Otolaryngology at Children's Hospital of Philadelphia, and an Associate Professor at Perelman School of Medicine at the University of Pennsylvania. In a first in the nation breakthrough, Dr. Germiller's team was able to restore the hearing of an 11-year old boy named Aissam who was born deaf through a revolutionary gene therapy surgery.

The type of deafness experienced by Aissam affects over 200,000 people worldwide, a genetic disability which was previously deemed untreatable. Through a procedure at the Children's Hospital of Philadelphia, Dr. Germiller was able to carefully inject a harmless virus carrying the corrected genes into Aissam's ear, which strengthened the tiny hairs within the inner ear that are required for full hearing ability. Dr. Germiller's study does not only provide a beacon of hope to adults and children affected by this type of genetic deafness, but also serves as the first step in utilizing gene therapy to help people experiencing other disabilities and diseases.

Dr. Germiller's career serves as a beacon of ingenuity and innovation, and his achievements inspire myself and others. I am sure that his contributions will have a lasting impact on the field of medicine. I thank Dr. Germiller for his tireless service to our community, our Nation, and the world.

COMMEMORATION OF THE 34TH ANNIVERSARY OF BLACK JANU-ARY

Mr. COHEN. Mr. Speaker, I rise today to mark the 34th anniversary of the "Black January" killings in Azerbaijan.

January 20, 2024, marks the 34th anniversary of the military invasion and vicious massacre of civilians in the city of Baku, Azerbaijan by the forces of the Soviet Army on January 20, 1990. On the night of January 20, 1990, approximately 26,000 Soviet troops stormed Azerbaijan's capital city in tanks and armored vehicles. The Soviet military bull-dozed and open fired on innocent Azerbaijanis and peaceful protestors, including women and children. The attack resulted in 147 people killed, around 800 injured, 841 arrested, and 5 missing. I offer my thoughts and prayers to the families of those who gave their lives for the independence of Azerbaijan.

Despite these merciless acts, the Azerbaijani people continued to fight for their freedom and became independent in 1991. The United States was one of the first countries to recognize Azerbaijan's independence and fully established diplomatic relations on February 28, 1992. As the co-chairman of the Congressional Azerbaijan Caucus, I recognize the sacrifices of the Azerbaijani people in their steps toward a free-market economy and encourage a recommitment to the democratic values for which many Azerbaijanis sacrificed their lives.

RECOGNIZING A HIDDEN HERO OF THE HOLOCAUST: KADRI CAKRANI

Ms. SCHAKOWSKY. Mr. Speaker, I rise today as we approach International Holocaust Remembrance Day to remember all the lives lost in this horrific event so many decades ago, and also to acknowledge the efforts of a particular and only more recently recognized hero of this period: Kadri Cakrani.

During World War II, Kadri Cakrani served as Commandant-General in the City of Berat, in Albania. Although his nation was occupied by Axis forces, Commandant Cakrani was able to utilize his position of relative authority to save lives

Commandant Cakrani rallied soldiers under his command and the local citizenry to help shelter hundreds of Jewish people who would otherwise have been killed by Nazi forces. Cakrani repeatedly lied to Nazi officials, claiming no knowledge of Jews within his area of authority. At the same time, he was coordinating the movement of families from one side of Berat to the other to ensure they were not discovered.

Commandant Cakrani even went so far as to shelter Jews within his own home during this period. In 1943, Cakrani successfully sheltered three U.S. Army nurses (Wilma Dale Lytle, Ava Ann Maness, and Helen Porter) trapped in the area after a plane crash returning them safely to the Allied powers.

The risks that Kadri and those working with him faced while they carried out these brave actions were enormous. Eventually, the rise of Communist leader Enver Hoxha forced Kadri Cakrani to flee the country in November of 1944. Cakrani eventually found his way to the United States, where President Harry Truman granted him political asylum and where he then settled down for the remainder of his life.

Kadri Cakrani passed away in 1972, but his efforts to bend the arc of history towards justice have been only recently rediscovered. Cakrani had safely fled to the United States, but many of the heroes that worked beside him remained behind the Iron Curtain in an Albania under communist rule. As a result, to protect those who would otherwise still be at risk, Kadri did not talk about these accomplishments.

Today, Albania is a free and democratic society. Scholars have pieced together the story of this remarkable man and those who worked beside him for good. On behalf of the residents of the 9th Congressional District of Illinois, I want to share my deepest gratitude to Kadri Cakrani and those who worked with him to save so many lives. These efforts and risks deserve recognition and remembrance, and I am so pleased to be able to share his story. Our world is better off because of the role that Kadri Cakrani played in it while he was here.

REINTRODUCTION OF THE HOME INVESTMENT PARTNERSHIPS RE-AUTHORIZATION AND IMPROVEMENT ACT

Mr. GARAMENDI. Mr. Speaker, I am thrilled to reintroduce the "HOME Investment Partnerships Reauthorization and Improvement Act," with Representative JOYCE BEATTY (D-OH03).

I thank our original cosponsors for their support, as well as U.S. Senator CATHERINE CORTEZ MASTO (D-NV) for sponsoring the companion bill. This updated legislation would significantly increase federal funding available for affordable housing across the country to tackle the housing crisis in states like California.

With historically high housing costs, a minimum wage worker in California must work an 88-hour week on average to afford a modest one-bedroom rental at a fair market rate. No American working full-time should live in poverty or be forced into homelessness. Congress and the U.S. Department of Housing and Urban Development (HUD) must support collaborative solutions to incentivize affordable housing production and rental assistance to address the drastic shortage of housing options in California and across the country. The HOME Investment Partnerships Pro-

gram (HOME) is the largest federal affordable housing block grant and is HUD's flagship program to support private developers and nonprofits building new affordable housing. Since established by Congress in 1990, the HOME program has helped state and local housing agencies support a wide variety of housing needs, from financing new construction and home repairs to funding down payment and rental assistance. HOME funding is the primary federal tool available for state and local governments to build affordable rental and owner-occupied housing for low-income to extremely low-income families with private developers. Moreover, HOME is a great federal investment, leveraging \$4.76 in non-federal public and private funds for every dollar in HOME fundina.

Since 1992, the HOME program has supported more than 1.36 million units of affordable housing for renters, home buyers, and homeowners. In California, the HOME program has invested \$5.27 billion into affordable housing across the state; built or preserved 121,727 homes; given rental assistance to 43,810 families; supported 277,318 jobs; and generated \$19.2 billion in local economic development

Despite these incredible investments, this essential program was last reauthorized in 1994 and needs critical updates to better address today's housing crisis. Our legislation would not only reauthorize the HOME program for the first time in three decades, but also make several much-needed improvements.

Specifically, our bicameral "HOME Investment Partnerships Reauthorization and Improvement Act" would authorize \$5 billion in HOME funding for fiscal year 2024 and boost the funding for the program by five percent annually through fiscal year 2028. This critical investment would reverse the chronic underfunding of the affordable housing investment program, which Congress appropriated only \$1.5 billion in fiscal year 2023.

In addition, our bill would allow HUD to make loan guarantees under the HOME program, leveraging limited federal resources to allow state and local participating jurisdictions to tap more generous private financing to build new affordable housing. It would also improve HUD's ability to provide downpayment assistance to homebuyers and home repair assistance to homeowners under the HOME program. Moreover our bill would unlock HOME funds for nonprofits, community land trusts, and other shared equity homeownership partnerships to make more and better affordable

housing available to those Americans most in need

Mr. Speaker, I urge all Members of Congress to cosponsor the "HOME Investment Partnerships Reauthorization and Improvement Act" to bring this critical HUD program into the 21st century and provide state and local partners with the financing needed to construct and rehabilitate affordable rental housing and provide homeownership opportunities for working families. Lastly, I want to thank my former Legislative Assistant, Mr. Tigran Agdaian, for his critically important role in developing this legislation during the 116th Congress while on my staff.

INTRODUCTION OF THE MARI-JUANA IN FEDERALLY ASSISTED HOUSING PARITY ACT

Ms. NORTON. Mr. Speaker, today, I introduce the Marijuana in Federally Assisted Housing Parity Act. Senator CORY BOOKER is introducing the companion bill in the Senate. This bill would permit the use of marijuana in federally assisted housing, including public housing and Section 8 housing, in compliance with the marijuana laws of the state (including the District of Columbia) where the property is located.

Individuals living in federally assisted housing should not be denied admission, or fear eviction, for using a legal product. Adult-use marijuana, medical marijuana or both are currently legal in 38 states and the District of Columbia, and over 90 percent of Americans support legalized medical marijuana. Under current federal law, users of drugs that are illegal under federal law, including marijuana, are prohibited from being admitted into federally assisted housing. Moreover, federal law allows landlords to evict residents of federally assisted housing for using illegal drugs.

The federal government has begun to change its approach to marijuana. In 2018, the Food and Drug Administration approved Epidiolex, which is derived from marijuana. Epidiolex is used to treat children who suffer from seizures. Notably, the medicine does not contain tetrahydrocannabinol, or THC, the psychoactive component in marijuana. For the last several years, Congress has prohibited the Department of Justice (DOJ) from using federal funds to prevent jurisdictions from implementing their medical marijuana law's. This bill would similarly allow individuals to use marijuana in federally assisted housing in compliance with a state's marijuana laws. The Department of Housing and Urban Development (HUD), like DOJ, should not be allowed to prevent jurisdictions from implementing their marijuana laws.

Under this bill, HUD must develop regulations that restrict smoking marijuana in federally assisted housing in the same manner and the same locations as HUD restricts smoking tobacco in federally assisted housing.

I urge my colleagues to support this bill.

Michael was born and raised in Buffalo, New York, but moved to Warminster, Pennsylvania in 1971 where he has remained ever since. He graduated from Temple University with a Bachelor of Arts Degree in Sociology with a concentration in Criminology. After graduation he began his career in 1977 with the Doylestown Borough Police Department where he remained for over 30 years.

During his tenure with Doylestown Borough, he held the ranks of Patrol Officer, Patrol Sergeant, Detective Sergeant, and Lieutenant. Michael Cummings during his tenure in Doylestown Borough had many notable accomplishments. As a patrol officer Michael was instrumental in forming what was to become a three dog K–9 unit. Michael, along with his police K–9 Bergey, went a step further and trained to compete at a regional and national level with the United States Police Canine Association.

As a sergeant, Michael was trained as a polygraph operator. In that capacity he served many police departments in providing testing for both criminal cases and new police hires. Michael Cummings was one of the first Drug

Abuse Resistance Education (DARE) Instructors in Bucks County teaching the anti-drug curriculum to 6th graders in the elementary schools in the Borough.

Michael was also the supervisor of the Doylestown Borough Detective unit. He supervised the more serious cases that occurred in the Borough. One of these cases resulted in the arrest of a Columbian national and the seizure of 102 kilos of cocaine, hundreds of thousands of dollars confiscated, and property forfeitures Michael was awarded a commendation from the Commissioner of the Philadelphia Police Department as well as other local and state authorities for his work on this case. In addition, Michael was awarded the Delaware Valley Association of Police Professionals Officer of the year as the Bucks County recipient.

The Central Bucks County Region realized a need for a special response team for the handling of critical incidents. Michael Cummings was trained as a Negotiator and was appointed by the members of the executive Board to supervise the Crisis Negotiation Team servicing 20 municipalities in the Central and Lipper Bucks region of the county.

and Upper Bucks region of the county. In 2009 Michael became Police Chief of New Hope Borough. In his 15 years as chief he led numerous initiatives to better the force and community as a whole. He worked with the Borough Council to replace an aging fleet of patrol vehicles and upgraded equipment to include Mobile Date Terminals, greatly enhancing effectiveness in the field.

Chief Cummings standardized and streamlined hid department in numerous ways during his tenure. He set out to issue every officer the same side arm replacing an inefficient and disjointed system of different manufacturers and models. He was successful in obtaining funds to purchase Glock pistols that have since been upgraded to include red dot sights and mounted lights.

The record system for the Parking Enforcement Department was unorganized. Chief Cummings was able to work with a parking enforcement company to install software that made it possible to track all tickets and automatically send out letters to violators. When many of the parking tickets were discovered to be unreadable, Chief Cummings obtained handheld parking devices that took pictures. The error rate went to zero as the registration plates could be verified by pictures. He was also tasked with the implementation of a new parking system that used kiosks and a parking application. This new parking system has resulted in an increase in parking revenue.

Faced with the cost of looking up vehicle registrations becoming cost prohibitive, Cummings was able to install a Mobile Data Terminal connected to the Bucks County Radio Center in the station. Now vehicle registrations from all over the country can be accessed not only in a timely fashion but without cost.

Chief Cummings championed de-escalation during his tenure. He made sure that all full-time New Hope Borough Officers received 40-hour Crisis Intervention Training. In 2022 a body cam program was instituted with the help of a grant from the Pennsylvania Commission on Crime and Delinquency (P.C.C.D.). He was able to obtain another PA P.C.C.D. grant to replace and outdated records management system. In 2023 the New Hope Borough Police Department became an PA accredited police department. To date, only 19 boroughs in the state have obtained this designation.

Chief Cummings is not only the Police Chief but the Emergency Management Coordinator for New Hope Borough. He was appointed by the Borough Council and the Governor to this position. In this role he has been involved in all the floods, winter storms and hurricanes since 2010. His expertise allowed him to work with the New Hope Solebury District Superintendent to develop a multi-faceted response program to deal with any threat that could be presented at the school district buildings. Officers, School Staff and Emergency responders were all involved and trained.

Chief Cummings has served as the head of the Central Bucks Crisis Negotiators Team Leader, the President of the Bucks County Chiefs Association, and the President of the Delaware Valley Hostage Negotiators Association. Despite numerous leadership positions, Michael attends all events. He oversees all operational plans for 5K races, parades, festivals, protests, and other large gatherings.

Chief Cummings is proud of his work as a liaison to the LGBQTA+ community and enjoys a strong affiliation with New Hope Celebrates the Umbrella organization. He has supervised the annual Pride Celebration in New Hope culminating in a parade that draws 10,000 people. Michael's expertise and dedication to public safety has resulted in 15 incident free years of celebration.

I am eternally grateful to Chief Cummings for the life of committed service he has given to our community, district, and country. His selfless example is a beacon of civic stewardship for the next generations of law enforcement to emulate. Michael's proficiency and devotion will be sorely missed, but I am excited for his entry into this new chapter and wish him nothing but the best in his future endeavors.

He then enrolled in the Jefferson County Jail Academy and the Lamar University Police Academy, graduating in 1985. Before joining the Texas Department of Public Safety (DPS), Major Huff began his lengthy career in law enforcement, serving with the Orange County Sherriff's Office and the Bridge City Police Department

In 1989, Major Huff attended DPS Recruit School as part of Class A–89 and was inducted as a state trooper on February 16, 1990. On June 1, 1997, Major Huff joined the prestigious Texas Rangers, the oldest law enforcement organization on the North American continent with statewide jurisdiction.

His fellow Rangers have characterized Major Huff as a "Ranger's Ranger." He is known as an expert in crime scene processing and has taught advanced criminal investigation courses to state, local, federal, and even foreign law enforcement officers. Over the past four decades, his work has resulted in the conviction of numerous violent criminals, justice for countless families, and safer Texas communities. Major Huff, however, has said that his greatest accomplishment has been overseeing the development of new Rangers and their promotion through the ranks of the storied law enforcement agency.

Dean was then promoted to Sergeant, supervising the jail, as a Patrol Supervisor, Commanded the Interagency Narcotics Force, and was appointed as team leader for the Sheriff's SWAT team. In 2005, Dean was recognized with a Certificate of Valor, the highest law enforcement award for valor in the State by the California State Attorney General Lockyear for his actions during a domestic violence incident.

Dean has been a vocal advocate for our first responders serving on many different Statewide boards where he impacted public safety policy. As a member of the California State Sheriff's Association, Dean served on

the legislative committee, influencing new laws. Dean was appointed and served as the Chair of the Detention and Corrections Committee and served on the Corrections Standards Authority and then the Board of State and Community Corrections.
