National Security Act: By 70 yeas to 29 nays (Vote No. 48), Senate passed H.R. 815, to amend title 38, United States Code, to make certain improvements relating to the eligibility of veterans to receive reimbursement for emergency treatment furnished through the Veterans Community Care program, after taking action on the following motions and amendments proposed thereto: **Pages S859–953**

By 66 yeas to 33 nays (Vote No. 46), Schumer (for Murray) Amendment No. 1388, in the nature of a substitute. **Page S907**

By 66 yeas to 33 nays (Vote No. 45), three-fifths of those Senators duly chosen and sworn, having voted in the affirmative, Senate agreed to the motion to waive all applicable sections of the Congressional

Budget Act of 1974 and any other applicable budget points of order for consideration of the bill. Subsequently, the point of order against all the emergency designation provisions contained in Schumer (for Murray) Amendment No. 1388 (listed above), was not sustained, and thus the point of order fell.
