Senate passed H.R. 7463, Extension of Continuing Appropriations and Other Matters Act.

## Senate

### Chamber Action

*Routine Proceedings, pages S1051–S1091*

**Measures Introduced:** Twenty-nine bills and two resolutions were introduced, as follows: S. 4, 3832–3859, and S. Res. 569–570. **Pages S1076–77**

#### Measures Reported:

S. 1939, to amend title 49, United States Code, to authorize appropriations for the Federal Aviation Administration for fiscal years 2024 through 2028, with an amendment in the nature of a substitute.

#### Measures Passed:

***Extension of Continuing Appropriations and Other Matters Act:*** By 77 yeas to 13 nays (Vote No. 67), Senate passed H.R. 7463, making further continuing appropriations for fiscal year 2024, by the order of the Senate of Thursday, February 29, 2024, 60 Senators having voted in the affirmative, and after taking action on the following amendment and motions proposed thereto:

##### Rejected:

By 37 yeas to 53 nays (Vote No. 63), Paul/Braun Amendment No. 1614, to establish prohibitions relating to the purchase or sale of State or municipal securities. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, was not agreed to.)

By 14 yeas to 76 nays (Vote No. 64), Marshall motion to commit the bill to the Committee on Appropriations, with instructions.

***Justice for Murder Victims Act:*** Senate passed S. 3859, to ensure that homicides can be prosecuted under Federal law without regard to the time elapsed between the act or omission that caused the death of the victim and the death itself.

***Victims' VOICES Act:*** Committee on the Judiciary was discharged from further consideration of S. 3706, to amend section 3663A of title 18, United States Code, to clarify that restitution includes necessary and reasonable expenses incurred by a person who has assumed the victim's rights, and the bill was then passed.

***National Speech and Debate Education Day:*** Senate agreed to S. Res. 570, designating March 1, 2024, as "National Speech and Debate Education Day".

#### Measures Considered:

***Proposed Foreign Military Sale to the Government of Turkiye:*** By 13 yeas to 79 nays (Vote No. 62), Senate rejected the motion to discharge the Committee on Foreign Relations of S.J. Res. 60, providing for congressional disapproval of the proposed foreign military sale to the Government of Turkiye of certain defense articles and services.

#### Veto Messages:

***Waiver of Buy America Requirements for Electric Vehicle Chargers:*** By 50 yeas to 47 nays (Vote No. 61), two-thirds of the Senators voting not having voted in the affirmative, S.J. Res. 38, providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Federal Highway Administration relating to "Waiver of Buy America Requirements for Electric Vehicle Chargers", was rejected, the veto of the President was sustained.

**Radiation Exposure Compensation Reauthorization Act—Agreement:** A unanimous-consent-time agreement was reached providing that at a time to be determined by the Majority Leader, in consultation with the Republican Leader, but no later than Friday, March 8, 2024, Senate begin consideration of S. 3853, to extend the period for filing claims under the Radiation Exposure Compensation Act and to provide for compensation under such Act for claims relating to Manhattan Project waste, and to improve compensation for workers involved in uranium mining; that there be up to one hour for debate equally divided between the two Leaders, or their designees; and that upon the use or yielding back of time, Senate vote on passage of the bill, all without intervening action or debate, with 60-affirmative votes required for passage. **Page S1068**

**Signing Authority—Agreement:** A unanimous-consent agreement was reached providing that Senator Schatz be authorized to sign duly enrolled bills or joint resolutions from February 29, 2024 through March 5, 2024. **Page S1089**
