National Slam the Scam Day: Senate agreed to S. Res. 584, designating March 7, 2024, as “National Slam the Scam Day” to raise awareness about pervasive government imposter scams and to promote education to prevent government imposter scams. **Page S2333**

150th Anniversary of the Harrison Residence: Senate agreed to S. Res. 585, recognizing the 150th anniversary of the Harrison residence, home of Brigadier General and President Benjamin Harrison and First Lady Caroline Harrison. **Page S2333**

Consolidated Appropriations Act, 2024: By 75 yeas to 22 nays (Vote No. 84), Senate agreed to the motion to concur in the amendment of the House

of Representatives to the amendment of the Senate to H.R. 4366, making consolidated appropriations for the fiscal year ending September 30, 2024, after taking action on the following motions and amendments proposed thereto:

Rejected:

By 43 yeas to 50 nays (Vote No. 80), Lee motion to concur in the amendment of the House to the amendment of the Senate to the bill, with Lee Amendment No. 1623 (to the House Amendment to the Senate amendment), to prohibit the use of funds to initiate or decline a Federal criminal charge based on impermissible considerations. **Pages S2324–25**

By 37 yeas to 59 nays (Vote No. 81), Schmitt motion to concur in the amendment of the House to the amendment of the Senate to the bill, with Schmitt Amendment No. 1626 (to the House Amendment to the Senate amendment), to strike the provision making amounts available to the National Telecommunications and Information Administration for salaries and expenses, administration, and oversight of programs administered by the Administration that were funded under the Infrastructure Investment and Jobs Act. **Pages S2325–26**

By 32 yeas to 64 nays (Vote No. 82), Scott (FL) motion to refer the bill to the Committee on Appropriations with instructions to report the same back to the Senate in 1 day, not counting any day on which the Senate is not in session, with changes that remove all Community Project Funding and Congressionally Directed Spending. **Page S2326**

By 45 yeas to 51 nays (Vote No. 83), Hagerty motion to concur in the amendment of the House to the amendment of the Senate to the bill, with Hagerty Amendment No. 1634 (to the House Amendment to the Senate amendment), to place a restriction on the use of funds relating to the decennial census. **Pages S2326–27**

Expanding Access to Capital Act: The House passed H.R. 2799, to make reforms to the capital markets of the United States, by a recorded vote of 212 ayes to 205 noes, Roll No. 78. Consideration began Wednesday, March 6th. **Pages H1038–48**

Rejected the Houlahan motion to recommit the bill to the Committee on Financial Services, by a yea-and-nay vote of 205 yeas to 213 nays, Roll No. 77. **Pages H1039–40, H1043–44, H1046–47**

Rejected:

Houlahan amendment (No. 6 printed in part B of H. Rept. 118–407) that sought to require the Advocate for Small Business Capital Formation to include in its report to Congress and the SEC [Sec. 2603(b)] the effects of the failure of Silicon Valley Bank on

community banks and small business lending (by a recorded vote of 200 ayes to 203 noes, Roll No. 73);

Pages H1039–40, H1043–44

Tlaib amendment (No. 7 printed in part B of H. Rept. 118–407) that sought to ensure exemptions or benefits provided by H.R. 2799 may only apply to companies that do not impose junk fees on customers (by a recorded vote of 204 ayes to 212 noes, Roll No. 74); **Pages H1040–41, H1044–45**

Lynch amendment (No. 8 printed in part B of H. Rept. 118–407) that sought to provide that the Act will take effect only when the SEC, in consultation with State securities regulators, certifies to Congress that nothing in the Act will increase fraud (by a recorded vote of 208 ayes to 211 noes, Roll No. 75); and **Pages H1041–42, H1045**

Waters amendment (No. 9 printed in part B of H. Rept. 118–407) that sought to require any investment adviser, private fund, or an investment company that is subject to the bill to annually and publicly disclose their investments into women-owned, minority-owned, veteran-owned, rural-domiciled, and other businesses (by a recorded vote of 206 ayes to 217 noes, Roll No. 76). **Pages H1042–43, H1045–46**

H. Res. 1052, the rule providing for consideration of the bills (H.R. 2799) and (H.R. 7511) was agreed to Wednesday, March 6th.
