It was on a spring day in April of 1824 in the Town of Newfane in Niagara County, New York that the vision of businessmen and political leaders came to fruition. At the residence of Mr. James Van Horn the town held its first meeting where they determined the outline of its boundaries, administrative officers and the honor of giving it the name 'Newfane'. Although the origin of the name of the Town of Newfane is a matter not yet settled, it is generally understood by the citizens of Niagara that it was suggested to commemorate the beauty of this town's prospect and likeness to the Town of Fane in Vermont.

In celebrating Newfane's legacy, it is important to recognize the varied economic life that supported its growth during the previous two centuries. The viability of Newfane's early commerce depended in large part on the creation of the Erie Canal and the impact of its diverted waters. On Main Street a few decades later, it boasted bustling mills, taverns, and clothing shops, which continued with a general store and thriving lumber yard. Due to the robust economic activity in Newfane, the community strengthened and saw the emergence of schools, a diverse number of churches opened their doors, and more public buildings emerged consistent with main street, small-town America.

Today, Newfane is known and loved for its rural landscapes and scenic shores of Lake Ontario. Its nature trails and picturesque sunsets over Lake Ontario attract visitors from all over the country. The town is home to a robust, generational farming community with apple orchards, livestock, horticulture, wineries, and commercial crop farms that provide essential goods to residents and surrounding communities. Located on Lake Ontario, the town offers several miles of scenic coastline. Residents enjoy the town's numerous parks and beaches, as well as Olcott Harbor which serves as a safe harbor to boaters and home to marinas and fishermen on the lake.

I would be remiss if I did not recognize the Town of Newfane for its thriving sport fishing industry. Men and women come from all directions to enjoy the town's world class fisheries for salmon and trout. The Town of Newfane is proud to be a key contributor to Niagara County's \$30 million a year sport fishing industry.

I applaud the Town of Newfane for their commitment to preserving 200 years of history. Throughout the past 200 years, Newfane has proven that America's heartland has never lost its spirit. Sincerest congratulations once

Mr. COURTNEY. Mr. Speaker, I rise today to commemorate the distinguished career and public service of Police Chief John Kelley from the town of Vernon, Connecticut that is drawing to an honorable end on March 22, 2024. Chief Kelley's devotion to duty in the U.S. Army Reserve and the Vernon Police Department focused on defending our nation and ensuring public safety has always been about caring for and serving others. As a resident of Vernon for over forty years, I have had the privilege to personally witness the positive impact he has had on our town, which is deep and meaningful.

A Vernon native, Chief Kelly grew up in a family whose patriarch Robert Kelley served in town fire service for 42 years, 21 of which as Fire Chief. I also knew Bob Kelley and worked with him on fire department issues during my time as town attorney and state representative. Bob was a true gentleman who led his department by example, a trait that his son followed, with great success. John Kelley attended Vernon schools and graduated from Rockville High School. After high school, he then enrolled at the University of Connecticut in Storrs, where he studied Criminal Justice and Sociology, which obviously signaled the direction he would follow later in life. After graduation his journey of public service began. He enlisted in the U.S. Army Reserve, where he honorably served for 6 years.

Chief Kelley began his career in public safety when he was hired by his hometown police department on January 29, 1996. His diligent work resulted in a cascade of training awards and frequent promotions. He excelled in all aspects of his work. For example, he received the Samuel J. Luciano award for graduating first in his class and the TFC Allan J. Tuskowski award for overall excellence in training. In his career he took on a vast expanse of roles, including serving as a Patrol Division, a K–9 handler, Detective Sergeant, Lieutenant, and Captain of the Vernon Police Department, all before 2015. Additionally, he graduated from the FBI National Academy (273rd session) and the Command Training Series, Executive Development program at Roger Williams University.

Given the respect and high regard he earned through the ranks of the Police department, he was the ideal candidate for Chief of Police upon the retirement of his predecessor, Chief James Kenny. As Chief, Kelley made major contributions to the improvement of the Police Department. He oversaw the implementation of technological advancements, the upgrade of body and dash cameras, upgraded duty handguns and rifles, formed a peer sup-

port team, and played a key role in the POSTC accreditation assessment. He was so proactive that the POSTC accreditation was accomplished over two years ahead of schedule. Chief Kelley uniquely understands the value of teamwork in public service. Most recently in his tenure, Chief Kelley implemented hundreds of thousands of COVID–19 Federal American Rescue Plan dollars in Vernon PD projects, increasing the town's emergency response capability and upgrading its technology.

Not only did Chief Kelley dedicate immense portions of his time and effort to helping his town, but he also equipped these individuals with the tools and resources to help themselves in times of need. As Kelley put it himself, "The Vernon Police Department is committed to excellence and the delivery of professional police services while providing its members with the equipment and training needed to successfully complete the mission". He educated many community members and in turn increased their self-sufficiency in moments of need. The impact of Chief Kelley's career will live on for many years after his departure. His legacy will instill a confident and prepared police force that will carry out its mission to foster a safe community that he and his family supported throughout many decades.

Although John Kelley is retiring from his role as Police Chief on March 22, 2024, his involvement in the region will continue as he transitions to working as an armed school security officer in Ellington Public Schools on March 25. Not one to be idle, Mr. Kelley has allotted himself a mere three days of rest between retirement and the return to work. From his experience and education, one can easily see Chief Kelley's promising future as a school security officer. His pleasant demeanor and commitment to the wellbeing of other Vernon residents will surely inspire the future generations of Americans to follow in his footsteps. It will be an honor to continue to serve alongside John Kelley in his new role, protecting and educating Northeastern Connecticut students who benefit from his example of how to treat other individuals with respect and achieve academic success.

Mr. Speaker, it is an honor to recognize and immortalize the career and accomplishments of John Kelley. From the U.S. Army Reserve to the Vernon Police Department, to his future role as an armed school security officer in Ellington, Chief Kelley has always put his life on the line for the safety of others. He is a reliable and amiable individual whose devotion to his community shines through in every aspect of his being. One may hope that his humility and thoughtfulness are emulated by future generations of Americans. He was a man of deep conviction who never faltered in his mission, no matter the cost.

He was one of the bravest, most principled men I have ever met, and his memory will never be forgotten. The United States must continue Navalny's legacy and stand up against Putin's efforts to trample freedom in Europe and around the world.

May we never stop fighting to secure peace and democracy for all those who seek it, just as Navalny so courageously did.

Mayor Trujillo was born in Guadalajara, Mexico, and at the age of five, her family immigrated to Arvin, California. During her summers, she worked alongside her family harvesting fruits and vegetables in the fields of the San Joaquin Valley, learning the values of hard work and perseverance from a young age. Mayor

Trujillo attended Sierra Vista Elementary, Haven Drive Middle School, and Arvin High School, and was involved in numerous activities in the Arvin community during her childhood. Mayor Trujillo dedicated her life to serving the Arvin community for more than 60 years. She served as the Vice-President of the Arvin Chamber of Commerce from 2013 to 2018, Chair of the Arvin City Planning Commission from 2015 to 2018, and was a member of the Arvin City Council from 2016 to 2018. In 2020, she was elected as the Mayor of the City of Arvin. As the first woman, Latina, and immigrant in this position, her election represented a significant milestone in our community's history. During her tenure, Mayor Trujillo was deeply committed to serving the community's most vulnerable, including the youth, senior, and homeless populations. She was instrumental in bringing new jobs to the city, improving resources for the homeless population, and leading domestic violence awareness campaigns. She significantly expanded various services for Arvin residents, including the new Bakersfield College Arvin Campus, the first Urgent Care Center and food bank, and the Arvin Kiwanis Club for youth leadership development. Mayor Trujillo was a trailblazing leader, passionate about the well-being of all residents of the community. Mr. Speaker, I ask all my colleagues in the House of Representatives to join me in honoring the incredible life of Mayor Olivia Trujillo. Her service to the Arvin community will be felt for generations to come. My thoughts and prayers are with her family during this difficult time.

A dedicated advocate at all levels of government for the health care delivery system, Deborah has served as Cedars-Sinai's legislative steward in Los Angeles, Sacramento, and Washington, D.C. Cedars-Sinai is a leading provider of care to Californians on Medi-Cal, the state's Medicaid program, and Deborah has played a major role in expanding this program so that the most vulnerable in our community have access to health care services.

Deborah led efforts to improve hospital financing and successfully advocated for funding to expand medical research and graduate medical education while playing a paramount role in establishing joint research efforts between Cedars-Sinai and the Uniform Services University at the Department of Defense. She

was also instrumental in securing entitlements to build the new Cedars-Sinai Marina del Rey Hospital, contributing to the development of the institution's new campus. This initiative allowed Cedars-Sinai to expand its services and further its mission of education, research, and patient care.

Beyond her work in the health care sphere, Deborah is also active in numerous civic and community organizations. She currently is the Board Vice President for Hillel International and the past Board Chair of USC Hillel and Hillel 818. Additionally, Deborah serves on the Boards of Directors of the Beverly Hills Chamber of Commerce, the Los Angeles Business Council, the West Hollywood Chamber of Commerce, Hillel 818, Hillel at the Claremont Colleges, Pitzer College, the Maple Counseling Center, and the Getty House Foundation.

Deborah has received numerous accolades for her tireless service to our community.
