HONORING RALPH WHITE

Mr. KEATING. Mr. Speaker, I rise today in honor of the life of Ralph White.

Born on October 25, 1931, to parents Ralph and Victoria White, Ralph was raised in East Boston and Westwood, Massachusetts. After graduating from Boston Trade High School in 1950, Ralph joined the U.S. Marine Corps and bravely served our country. While serving in Korea with the First Marine Division as a rifleman, Ralph was wounded in action defending his post. For his bravery, Ralph was awarded a Bronze Star and the Purple Heart.

Once Ralph recovered, he returned to the U.S. and married the love of his life, Geraldine "Geri" in Kingsland, Georgia, on November 4, 1952. He first met Geri in high school after she moved down the street from Ralph and his family in 1946. Ralph was still enlisted when they married and the couple spent their first few years of marriage living along the East Coast on several military bases before settling in Walpole, Massachusetts, in 1956.

Together in Walpole, Ralph and Geri raised their four children—Susan, Nancy, Lori, and William—and Ralph quickly established himself as a pillar of the community. He was commander of the Thomas H. Crowley American Legion Post 104, and as an avid baseball fan, Ralph coached Post 104's baseball team for nearly six decades in addition to coaching Walpole High School's baseball team for several years. To celebrate Ralph's contributions to the Walpole community, the town dedicated the sport complex at Bird Middle School in his honor in 2015.

Following his service with the U.S. Marine Corps, Ralph began working as a corrections officer at Boston's Charles Street Jail. Ralph then worked at the Walpole State Prison before becoming a state parole officer. After he was shot on the job and survived life-threatening injuries, Ralph, along with several other retired state employees, founded Mass Retirees in 1968, and Ralph served as the association's president until 2013.

Throughout his 45 years as president, Ralph played a crucial role in advancing many of the laws that protect and support public retirees in Massachusetts, including the cost-of-living adjustment. Several decades ago, with Ralph leading the charge, Mass Retirees successfully petitioned the Commonwealth to change its laws to allow all retired public employees to receive a regular and cumulative cost-of-living adjustment. Today, Mass Retirees continues to advocate for key issues affecting Massachusetts retirees, such as public pensions and health insurance. Ralph was pivotal in growing the association into the critical resource that it now serves as for its 52,000 members.

In addition to his work with Mass Retirees, Ralph served as an elected member on the State Retirement Board for many years and

was a founding member of the Commonwealth's Pension Reserves Investment Management (PRIM) Board, which he served on for two decades.

Sadly, we lost Ralph too soon on January 26, 2024, at the age of 92. Whether it be his service with the U.S. Marine Corps, his years coaching youth baseball, or his nearly six decades of work on behalf of retirees, Ralph leaves behind an extraordinary legacy as a tireless advocate and mentor to many.

Mr. Speaker, I am proud to honor the life of Ralph White, and I ask that my colleagues join me in recognizing his life's commitment to serving his community, the Commonwealth of Massachusetts, and our country.

Sergeant Westbrooks answered the call of duty at the Perry County Courthouse in 1944 at the young age of seventeen. He completed basic training at Fort McClellan, Alabama, whereupon he served as a non-commissioned officer in World War II and the early days of the Korean War. Prior to leaving Korea in 1948, Sergeant Westbrooks trained members of the South Korean Army in Chan-ju, which later proved instrumental to the defense from the brutal communist invasion in 1950.

Upon completing his service overseas, Sergeant Westbrooks returned to finish his schooling, which had been cut short by the war, and on the same day his son graduated from Perry County High School, Sergeant Westbrooks earned his GED. Ever the servant leader, he is deeply involved in his community and an active member of Faith Baptist Church in Linden, Tennessee. He is also an excellent guitarist and a former player in Minnie Pearl's Grinder's Switch Skillet Lickers, which performed in Odessa, Texas.

A proud veteran, Sergeant Westbrooks is an active VFW member, and he regularly represents WWII veterans at events across West and Middle Tennessee. While he traded in his military fatigues for civvies, he never stopped serving his country, and you can still find him in Perry County, Tennessee, wearing his World War II and Korea Veterans hats with pride.

Sergeant Westbrooks and the love of his life, Mrs. Aline Hinson Westbrooks, celebrated 74 years of marriage earlier this year. Together, they have three children: Deborah Hardin, Kerry Westbrooks, and Lisa Stayrook.

Technical Sergeant Earl Westbrooks has lived an admirable life marked by service, both

to his community and his country. On behalf of the House of Representatives and as a fellow veteran, I commend him for his service to our district, the state of Tennessee, and the United States of America.

She then joined as IAM Assistant Political and Legislative Director before becoming the Chief of Staff to the International President.

Monica has dedicated decades of her work to expanding the reach and inclusion of the Labor Movement. Fluent in Spanish, Monica was among the founding members of the IAM's Spanish Leadership Working Group, and was crucial in developing materials and resources for IAM in Spanish. As Co-Chair of the Women of Labor organization, she helped lift and encourage women in the Labor Movement. Finally, she was a member of the Executive Committee of IndustriALL Global Union, representing over 50 million workers in 140 countries.

Throughout it all, Monica has been an unwavering voice for working families. It has been my great pleasure to work closely with her on many projects and priorities over the years, and I know I speak for many when I say that she has been a tremendous asset to the Labor Movement.

Immediately prior to joining Rutgers in 1968, Professor Baker was a research associate at the Brookings Institute. He had also worked at the Special Operations Research Office and was a graduate of the University of Pennsylvania, where he earned his B.A., M.A. and Ph.D.

Crucially, no matter the post or project, Amy fostered a spin of innovation and culture of collaboration that will long endure.

Amy's work has also extended to representing the United States in many capacities at the North Atlantic Treaty Organization (NATO) and other international organizations. Amy's leadership in both domestic and international situations often placed her as a top leader and often as the only woman in key technical roles where she established herself as a respected authority.

I've been proud to work with Amy to ensure that Congress provides the hardworking team at Naval Air Station Patuxent River with the resources it needs to conduct this essential work. She has been an excellent host during my many visits to the base over the years, and I—like many others—will be sad to see her go. Her leadership in building capabilities for the Department of Defense has always been forward-looking and provided our Nation with the tools necessary to remain at the forefront of development and testing of the most complex weapons systems in the world.

Mr. Speaker, I ask that all my colleagues join me in thanking one of the smartest, most dedicated people I know: Amy Markowich. Although she is stepping back as Executive Director, I know that her commitment to serving her fellow Americans will never waver. For that, she has the gratitude of her Congress and her country. Michael is survived by his loving family, including his wife Sylvia and six children, Michael Luciano, Sofia, Maryella, Christopher, Jack, and Emma. His dedication to his family was evident and I am blessed to have had such a wonderful friend in Michael.

Michael should be remembered for his decades of service to Long Branch and New York City as a firefighter, most notably his selfless actions following the September 11th attacks on the World Trade Center, which contributed to his health battles. I know I join with his family, friends, and fellow firefighters in paying tribute to his memory and the ultimate sacrifice he paid in service to our community.

INTRODUCTION OF THE PAUL LAURENCE DUNBAR COMMEMORATIVE COIN ACT

Ms. NORTON. Mr. Speaker, today, I introduce the Paul Laurence Dunbar Commemorative Coin Act, which would direct the Secretary of the Treasury to mint and issue coins in honor of Paul Laurence Dunbar. This bill would recognize one of the first influential African American poets in American literature and benefit the Dunbar Alumni Federation, the alumni association for the Paul Laurence Dunbar Senior High School in the District of Columbia, which is historic for being the first public high school for African Americans in the United States. I am a proud graduate of Dunbar, a storied African American high school in our country.

Paul Laurence Dunbar was born on June 27, 1872, to formerly enslaved parents, and went on to pen such classics as *Majors and Minors* and *Lyrics of Lowly Life*. He also composed the lyrics to *In Dahomey*, the first all-African American musical produced on Broadway. By the late 1890s, Dunbar had become a prominent author, having had his poems published in major national newspapers, including *The New York Times*. Dunbar died on February 9, 1906, at age 33.

Paul Laurence Dunbar Senior High School was established in 1870 as the Preparatory High School for Colored Youth. It was the first college preparatory high school for African American children in the United States. The school was renamed for Dunbar in 1916.

The Dunbar Alumni Federation was organized in 2002 to provide scholarships and other financial support to students and graduates of Paul Laurence Dunbar Senior High School. The Federation has alumni from more than 35 graduating classes, and supports the school through its scholarship efforts, community activities and other endeavors.

This bill would authorize the Secretary of the Treasury to mint 50,000 five-dollar coins,

400,000 one-dollar coins and 750,000 half-dollar coins, with a surcharge on each coin. The surcharges would benefit the scholarships and similar activities of the Dunbar Alumni Federation.

I urge my colleagues to support this bill.

BIRTHDAY OF ALLEN Q. JONES

Mr. RESCHENTHALER. Mr. Speaker, I rise to celebrate the life and legacy of Allen Q. Jones, who celebrates his 100th birthday on April 11, 2024.

Allen was born in Uniontown, Pennsylvania, and attended Uniontown High School during the early years of World War II, receiving a draft notice shortly before graduation. In 1943, Allen departed for training with the U.S. Army's 717th Tank Battalion. The following year brought him through Forts Chaffee, Knox, and Meade before leaving for Europe aboard the S.S. Cristobal on Christmas Eve, 1944. Corporal Allen Jones and the 717th Tank Battalion crossed the River Rhine in the spring of 1945 and remained in Germany until the end of the war. Once he returned to the United States, he attended Waynesburg College and joined the Veterans of Foreign Wars (VFW) Post 21 in Connellsville, Pennsylvania.

Allen stayed active in the VFW for over 70 years, winning leadership elections at the local and national levels. He began his tenure as Fayette County Commander but soon rose to the rank of District 23 Commander. Allen's peers elected him Pennsylvania State Commander in 1986, where his work ethic earned national acclaim. He served on the VFW National Home's Board of Trustees for two years before winning the Board President election in 1995. Allen gained further distinction at the 1999 VFW National Convention when the delegates appointed him to the National Council of Administration. His leadership tenure ended in 2016 after a one-year commission as National Chief of Staff.

Allen's call to service inspired him to become an active member of the Connellsville Area School District community throughout his adult life. He taught science and special education for 30 years and served as president of the Connellsville Area Education Association after retiring from teaching in 1984. Allen also coached multiple sports teams at Connellsville Junior High School. He led the Connellsville Junior High East boys basketball team through an undefeated season in 1970, culminating in winning the Western Pennsylvania Interscholastic Athletic League Junior Championship. He also won a league championship in 1984 while coaching the Connellsville Junior High girls basketball team. The Connellsville School Falcon Foundation recognized Allen's years of commitment to student-athletes by inducting him into their Hall of Fame in 2016.

Allen married Nancy Carol Dayton in 1950 and shared 70 happy years of marriage before her passing in 2021. The couple raised two children together: Marcia Knight and Charles "Chuckie" Jones. Over the years, their family grew to include two granddaughters and one great-granddaughter.

Allen's selfless service left a mark on southwestern Pennsylvania and made his community a better place. Few people share his remarkable ability to connect with and mentor

young students. His story is the epitome of a life well-lived.

Mr. Speaker, on behalf of the people of Pennsylvania's 14th Congressional District, I

wish Allen Q. Jones a happy 100th birthday surrounded by friends and family.
