Mr. BARR. Mr. Speaker, I rise to recognize an exceptional man, Mr. Jim Host, of Lexington, Kentucky. Mr. Host will receive the 2024 Tom Jernstedt Lifetime Achievement Award at the 2024 Men's Final Four in Phoenix, Arizona. This award is presented to honor individuals who have made a meaningful impact on college basketball.

Mr. Host grew up in Ashland, Kentucky. He earned one of the first two baseball scholarships given by the University of Kentucky in 1955. He graduated from the University of Kentucky with a degree in radio arts and played one year of pro baseball as a pitcher for the Chicago White Sox. A shoulder injury ended his baseball career. He was the youngest person to serve in Governor Louie Nunn's cabinet, as Commissioner of Public Information and Commissioner of Parks. He ran for Lieutenant Governor of Kentucky in 1971. Mr. Host served as Governor Ernie Fletcher's Secretary of Commerce from 2003-2005. His service to Kentucky continued as the first Executive Director of Rupp Arena, founding chairman of the Kentucky Horse Park, and chairman of the Louisville Arena Authority.

Mr. Host was founder and CEO of Host Communications. His nationally known sports marketing company brought business knowledge and fresh ideas to college sports marketing. He began working with the NCAA in the mid-1970's and transformed the promotion of college basketball and the post-season tournament. Before his involvement, there was no "Final Four" label and not even an official program for the tournament. With his entrepreneurial and innovative skills, he introduced corporate sponsorships, the national radio network, and many other successful ideas that made college basketball what we enjoy today.

Mr. Host has earned many well-deserved accolades. He is a member of the UK Alumni Association Hall of Distinguished Alumni, the UK Athletics Hall of Fame, the National College Basketball Hall of Fame, and the National Tourism Hall of Fame. He was named Kentucky's Entrepreneur of the Year in 1998. From the Naismith Memorial Basketball Hall of Fame, he received the Chairman's Cup Award, the John Bunn Lifetime Achievement Award, and is a lifetime trustee.

For his outstanding service to the Commonwealth of Kentucky and for his latest award, the 2024 Tom Jernstedt Lifetime Achievement Award, it is my honor to call him my friend and to recognize his accomplishments before the United States House of Representatives.

Ms. VAN DUYNE. Mr Speaker, I rise today to celebrate a great American success story that has taken place in the 24th Congressional District that I represent in North Texas As a member of the House Small Business Committee who represents countless job creators with growing businesses, I appreciate the role of our small business owners in creating opportunity and prosperity for North Texans. I rise to recognize one such company, Southland Holdings in Grapevine, Texas, which recently realized the American dream, starting as a family business and recently reaching the milestone of becoming publicly traded on the New York Stock Exchange. Oscar and Rudy Renda, Sr., and their three other brothers, along with their parents, immigrated to the United States from Italy in 1956. Sponsored by their uncle, Ernie Renda, a Pearl Harbor survivor and construction veteran, Ernie tirelessly worked to bring his family to America. The Renda brothers grew up influenced by their Uncle Ernie's strong work ethic and a profound passion for construction. Oscar embarked on his career as a high school coach and history teacher but always harbored a deep passion for construction instilled by Uncle Ernie. In 1974, he realized his dream by founding Oscar Renda Contracting (ORC). A

year later, his brother Rudy joined him, and they began building small-diameter water and wastewater pipelines across the Dallas/Fort Worth metroplex, employing former high school students as their initial crew, many of whom remain with the company today.

Over the next few years, ORC refined its expertise in constructing large-diameter water and wastewater conveyance pipelines and treatment plants. Much of the company's early experience centered around building projects for the City of Dallas. From this local experience, the company gradually expanded its operations with larger and more complex projects across Texas and neighboring states. Through these years, the next generation led by Frank and Rudy Renda gained invaluable experience working alongside skilled crew members from an early age. During their college years at Texas Tech University, Frank and Rudy crossed paths with Tim Winn, which further led to a discovery of shared goals, values, and aspirations that have been the foundation of Southland's success.

Frank, Rudy, and Tim assumed control of the company in 1999, and the following year, entered a joint venture with Southland Contracting, established by Charlie Griffith in 1981. Charlie's unfortunate and premature death led Frank, Tim, Rudy, and Clay, Charlie's son, to assume leadership of the company, and in 2002, Oscar Renda Contracting acquired Southland Contracting. Their shared vision, unwavering commitment, and steadfast principles motivated them to establish Southland Holdings in 2006. Frank Renda assumed the role of CEO, while Rudy Renda and Tim Winn became co COO's. This strategic move laid the groundwork for the company's remarkable growth in the following decade. In the coming years, Southland Holdings welcomed Mole Constructors, Johnson Brothers Corporation, and American Bridge Company into the Southland Holdings family. This family of companies has accomplished remarkable feats in various sectors, including connecting the United States through transportation projects, establishing water pipelines and treatment facilities to transport water across vast regions. tunneling through challenging geological conditions, and contributing to the construction of some of the nation's most iconic structural landmarks.

Once again, Frank, Rudy, and Tim achieved an ambitious goal, with Southland becoming publicly traded on the New York Stock Exchange under the ticker symbol SLND. On March 2, 2023, the three of them had the honor of ringing the bell at the NYSE, just a few miles away from where Frank and Rudy's ancestors immigrated into the country at Ellis Island. Frank remarked, "Amidst the ringing of the bell and the applause, I couldn't help but feel a profound sense of gratitude, not only for myself and my partners, but also for our dedicated employees and our family that paved the way to this momentous occasion."

Today, Southland boasts nearly 3,000 employees across North America and the Bahamas. They have performed work in seven countries and thirty-eight states, generating approximately \$1.2 billion in annual revenue. Frank expressed gratitude for the journey, emphasizing that it was only possible through hard work, dedication, sacrifice, and trust. The Southland family is building a construction legacy, carrying forward the values of the generations that came before them, and that is just the beginning of the Southland story.

During his 40 years in our community, Mr. Pham produced hundreds of magazines, documentaries, and audio records to preserve Vietnamese history and culture in the United States in service of future.

Since 2001, Mr. Pham served as Director of the Immigrant Resettlement & Cultural Center, Inc. (IRCC) and had extensive experience in our community of working with the Vietnamese immigrant population. He oversaw IRCC operations, including personnel, finance, as well as funded volunteer programs. IRCC was the very first community-based organization in Santa Clara County offering education and social services to the Vietnamese community.

Since 2015, Mr. Pham helped host the "Thank You, America" annual event where Vietnamese Americans express gratitude and appreciation to the United States for rescuing them at sea and providing them a new home. Through IRCC and Dan Sinh Media, which he created, and which broadcasted programs nationwide through The Overseas Vietnam Radio Network, Mr. Pham worked to develop a health information network to help meet the health needs of Vietnamese Americans in our community.

Mr. Speaker, I commend Mr. Nam Pham's commitment to bettering the lives of immigrants in our diverse, thriving community. His legacy in our community lives on through his projects. We have been lucky to have him, and he will be missed.

After an honorable discharge, he pursued further education and acquired an associate degree in Fire Science and Technology. He married his wife, Noreen, in 1987 and moved to Ledyard where they raised four children. His time in the naval service and his training in fire science, led Tony to pursue a career as a firefighter at the Submarine Base fire department. Unsurprisingly, he took to the task, and he continued to work at the Submarine Base as a firefighter for over 20 years. Mr. Speaker, the mission of the subbase department is very specialized, given the highly complex and value of A large fleet of fast attack submarines homeported there. Tony handled that portfolio with highest degree of professionalism and proficiency it required. Not one to settle for just that task. Saccone took it upon himself to take a second job at the Gales Ferry Fire Company, where he also excelled and has since tirelessly served his community up to this day.

Chief Saccone's involvement in both fire departments extended beyond the details of his job description. He rapidly accelerated through the ranks and became the Fire Captain at the U.S. Naval Submarine Base and Chief of the Gales Ferry Fire Company. His leadership skills are exhibited in his character; as Captain and Chief of these departments, he prioritized mutual trust, respect, and communication between him and the crews. He led by example, expecting the same excellence of his team as of himself. His organizational skill proved to be an asset when Chief Saccone managed a \$250,000 budget for Gales Ferry and balanced it each year since beginning his position as Chief in 2008. It is through the leadership of Saccone that Gales Ferry and the Submarine Base Fire crews can provide high quality service to their communities.

As a natural leader, Chief Saccone recognized his potential to extend his service to his community and town from a political position. himself. He raises others, is a team player, and an individual of incalculable quality. Chief Saccone's involvement in his community and country reflects his commitment to American democratic values For the sake of America, I hope that citizens see Chief Saccone's story and continue his legacy as unswaying champions of American democracy. Mr. EDWARDS. Mr. Speaker, I rise today to honor Hendersonville, N.C. resident and 102-year-old Army veteran, Lt. Col. Edwin Cottrell, in recognition of his service and heroism as a fighter pilot in World War II.

Ed flew 65 missions in 1944 and 1945 as a P-47 pilot with the 493rd Fighter Squadron of the 48th Fighter Group of the 9th Army Air Force

Many of Ed's missions were flown during the Battle of the Bulge, when U.S. troops on the ground were defending against a strong German counteroffensive. His missions included bombing German artillery and Tiger Tanks, as well as taking out bridges. His service saved countless of his comrades' lives.

The engine of Ed's P-47 was shot up by a German Me-109 fighter during a mission on Dec. 17, 1944. With oil splattered across his plane's windshield and only 10 out of 18 engine cylinders still functioning, Ed was guided to the nearest friendly airfield over the radio, only to have his engine freeze just before landing. He maneuvered a dead-stick landing, rolled to a stop, and kissed the ground when he got out of the P-47. To this day, he credits the reliability of the P-47's Pratt & Whitney engine for getting him back to base.

Ed's service did not end with WWII. He went on to serve in the Air Force reserves for 28 years. He worked as a director of athletics at a school for boys and later coached multiple sports at West Chester State College in Pennsylvania, where he went on to become the associate dean.

In his adopted town of Hendersonville, Ed is a local legend. Ever the adventurer, he chose to go skydiving for his 100th birthday.

RECOGNIZING CHRISTOPHER SANTANGELO'S 27 YEARS OF FEDERAL LAW ENFORCEMENT SERVICE

Ms. MALLIOTAKIS. Mr. Speaker, I include in the RECORD the following Proclamation recognizing Christopher Santangelo, President of the New York City Chapter of the Federal Law Enforcement Officers Association on his retirement after 27 years of federal law enforcement service on April 27, 2024.

Whereas Mr. Santangelo, who grew up in Bay Ridge, Brooklyn from childhood until his early 30s, is a product of a New York City Education. He graduated from Kingsborough Community College with an AAS degree in accounting, earned a BS in accounting from Brooklyn College, and obtained an MS from John Jay College.

Whereas Christopher Santangelo began his federal law enforcement career in January 1997 with the United States Park Police in Washington, D.C. where he was stationed to protect the White House in our nation's capital

Whereas from mid-1998 to early 2000, Mr. Santangelo was assigned to the New York Field Division, where he led the JBU unit to numerous arrests, earning him the Officer of the Month award five times. Additionally, Mr. Santangelo was assigned to one or more NYPD narcotics task forces and served as a plainclothes officer with the U.S. Park Police in Operation Weed and Seed, covering areas in Brooklyn, Queens, and Staten Island.

Whereas in April 2000, Mr. Santangelo became a special agent for the Bureau of Alcohol, Tobacco, and Firearms and was assigned to the New York Field Division, Group V—HIDTA. Mr. Santangelo survived the World Trade Center attacks and participated in the recovery efforts for several months. As a result of his unwavering dedication, Mr. Santangelo was awarded a commendation for meritorious service for his actions during the September 11, 2001, World Trade Center attacks and the subsequent evidence recovery.

Whereas after transferring to the U.S. Department of Agriculture in June 2002, Mr. Santangelo conducted investigations into fraud, waste, abuse, and mismanagement related to USDA programs and operations. Mr. Santangelo conducted or participated in hundreds of program crime investigations, including inquiries into the Food and Nutrition Service's (FNS) EBT program, violations of the Animal Welfare Act, violations of the Sherman Act, farm loan fraud, prohibited agricultural product smuggling, and agroterrorism. He also served as the antimoney laundering subject matter expert (SME) for the Northeast Region.

Whereas for his investigative excellence, Mr. Santangelo is a past award recipient of the Council of Inspectors General (CIGIE) Investigative Excellence Award for leading a multi-million-dollar civil investigation into the Supplemental Nutrition Assistance Program Error Rate. Additionally, Mr. Santangelo received recognition from the NYPD Detective Endowment Association for his participation and assistance while being assigned part-time to the NYPD Counter Terrorism Bureau in Brooklyn, New York, from 2002 to 2005.

Whereas in February 2017, Mr. Santangelo transferred to the Federal Deposit Insurance Corporation, Office of Inspector General, New York Field Division, where he investigated failed banks and former members of the board of directors of failed banks. Mr. Santangelo successfully investigated global financial institutions for market manipulation in Foreign Currency (FX) trading, as well as in the High Yield Junk and Variable Rate bond markets. Additionally, Mr. Santangelo was the co-case agent in United States v. Rishi Shah, Shradha Agarwal, Brad Purdy, et al., in which the former executives were convicted in a \$1 billion corporate fraud case, resulting in him receiving the Attorney General Award in January 2024.

Whereas in June 2022, Mr. Santangelo was promoted to the SSA position within the

FDIC-OIG, New York Regional Office, which covers New York, New Jersey, Pennsylvania, and all of New England while also serving as the lead SSA for investigations in the Eastern District of New York (encompassing Brooklyn, Queens, Staten Island, Nassau, and Suffolk Counties), leading or coordinating investigations into bank insiders, borrowers, and accountants suspected of committing bank, wire and elder fraud. Furthermore, Mr. Santangelo personally directed disaster relief and romance scam investigations in the Smithtown-Hauppauge-Kings Park area related to Hurricane Sandy, as well as investigations related to the CARES Act.

Whereas since 2009 Mr. Santangelo has served as the President of the New York Chapter of the Federal Law Enforcement Officers Association, Vice President of the Federal Law Enforcement Foundation, and is a member of the Fraternal Order of Police Lodge No. 53.

Whereas our Nation is forever indebted to Christopher Santangelo and offers its sincerest gratitude and warmest wishes in his retirement.

Mr. Kain was a leader in his community and was recognized as Woodford County Chamber of Commerce's Businessman of the Year in 1992. A generous man, he supported education, medical care and research, and many other charitable efforts to make the community and the nation a better place.

More importantly than his business and community successes, Mr Kain kept his family at the forefront of his life. He had nine children, twenty-two grandchildren, and eighteen great-grandchildren. He is survived by his wife Alice Stewart Kain and children Vickie Fister, Patrick Kain, David Kain, Steve Kain, Bob Kain, and Bill Kain. He was preceded in death by his daughters Becky Grimes and Suzanne Hockensmith and his son Jack Kain, Jr.

Jack Kain was a great man who loved his family, his community, his country, and his God. He was respected by his community and his colleagues in the automobile industry throughout America. It is my honor to call him my friend and to recognize his life before the United States House of Representatives.

INTRODUCTION OF THE CIVIL WAR DEFENSES OF WASHINGTON NATIONAL HISTORICAL PARK ACT

Ms. NORTON. Mr. Speaker, today, on the anniversary of the week of the start of the Civil War, I introduce the Civil War Defenses of Washington National Historical Park Act. which would recognize and preserve the Civil War Defenses of Washington located in the District of Columbia, Virginia and Maryland. The Defenses of Washington, including forts, unarmed batteries and rifle trenches, created a ring of protection for the nation's capital during the Civil War. This bill would redesignate the 22 Civil War Defenses of Washington currently under National Park Service jurisdiction as a national historical park, and allow other sites associated with the Defenses of Washington that are owned by D.C. or a unit of state governments to be affiliated with the national historical park through cooperative agreements. This bill would also require the Secretary of the Interior to facilitate the history of the Civil War, including the history of the Defenses of Washington and the Shenandoah Valley Campaign of 1864, being assembled, arrayed and conveyed for the benefit of the public for the knowledge, education and inspiration of this and future generations. In 2018, the House Natural Resources Committee Subcommittee on Federal Lands held a hearing on this bill. Although the Department of the Interior opposed this bill, I feel strongly that the Defenses of Washington need additional recognition and should be redesignated as a national historical park.

The Defenses of Washington were constructed at the beginning of the war, in 1861, as a ring of protection for the nation's capital and for President Abraham Lincoln. By the end of the war, these defenses included 68 forts, 93 unarmed batteries, 807 mounted cannons. 13 miles of rifle trenches and 32 miles of military roads. The major test of the Defenses of Washington came with the Shenandoah Valley Campaign of 1864, when Confederate Lieutenant General Jubal Early, directed by General Robert E. Lee, sought to attack the nation's capital from the north, causing Union forces threatening to attack Richmond, the capital of the Confederacy, to be withdrawn. General Early was delayed by Union Major General Lew Wallace at the Battle of Monocacy on July 9, 1864, and was stopped at the northern edge of Washington at the Battle of Fort Stevens on July 11-12, 1864. The Shenandoah Valley Campaign ended when Union Lieutenant General Philip Sheridan defeated General Early at the Battle of Cedar Creek, Virginia on October 19, 1864.

Nearly all the individual forts in the Defenses of Washington-on both sides of the Potomac and Anacostia rivers—were involved in stopping General Early's attack, and the Battle of Fort Stevens was the second and last attempt by the Confederate Army to attack Washington

Taken together, these battles were pivotal to the outcome of the war and the freedom and democracy that the war represented for this country. It is therefore fitting that we recognize the Defenses of Washington by redesignating them as a national historical park.

I urge my colleagues to support this bill.

After earning her doctorate from the University of Massachusetts in 1971. Dr. Smith's journey brought her to Michigan State University where she joined the faculty of the Department of Education. Throughout her tenure at MSU, Dr. Smith distinguished herself as a trailblazer and champion of equity, especially for women of color.

Her footprint at MSU is immeasurable. In 1972, she played a pivotal role as a member of the steering committee for the Black Women Employees Association of MSU, where she passionately advocated for the hiring of more Black women professors. Her achievements, including becoming the first Black woman to attain full professorship at MSU and being recognized on the university's Distinguished Wall of Professors, serve as a testament to her contributions and enduring influence.

She lent her leadership and expertise as she served as the Director of African American and African Studies, as a member on the MSU Athletic Board, and on the university's presidential search committee. In 2007, Dr. Smith retired from MSU as professor emeritus in the Department of Counseling, Educational Psychology, and Special Education.

Dr. Smith's incredible legacy extends beyond the classroom. She was the first Black President of the Michigan Counseling Psychology and Supervision Professional Organization. She has also been a proud member of Alpha Kappa Alpha, the first intercollegiate historically African American sorority, since 1958. She served as the organization's 18th Great Lakes Regional Director and has truly embodied her sisterhood's mission to cultivate and encourage high scholastic and ethical standards and to be of service to all mankind.

Dr. Smith continues to show her commitment to education and serving others as a member of her local chapter of the Links, Incorporated, an organization dedicated to promoting quality education, civic responsibility, and enhancing the quality of life of their communities. She is also a cherished member of her church, The Friendship Baptist Church, where she lives their cote value of serving without restraint.

With profound gratitude for her extraordinary contributions to Michigan State University and her lifelong mission to uplift her community, it is my honor to recognize her service here, in the People's House.
