**Encouraging the European Union to Determine that the European Union Should Sanction the Iranian Revolutionary Guard Corps Now As a Terrorist Entity Resolution:** H. Res. 288, urging the European Union to expeditiously designate the Islamic Revolutionary Guard Corps as a terrorist organization under Common Position 931, and for other purposes, by a  $\frac{2}{3}$  ye-and-nay vote of 411 yeas to 14 nays, Roll No. 133; and
