Dustoff Crews of the Vietnam War Congressional Gold Medal: Committee on Banking, Housing, and Urban Affairs was discharged from further consideration of S. 2825, to award a Congressional Gold Medal to the United States Army Dustoff crews of the Vietnam War, collectively, in recognition of their extraordinary heroism and life-saving actions in Vietnam, and the bill was then passed, after agreeing to the following amendment proposed thereto: [Page S3666](#)
