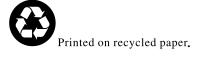

Mrs. BEATTY. Mr. Speaker, I rise to mark the solemn anniversary of George Floyd's untimely passing—a moment etched in history that shook our Nation to its core and reverberated across the globe, igniting a resounding call for justice. Mr. MORELLE. Mr. Speaker, I rise today to recognize Jewish American Heritage Month. Our Nation benefits from the historical achievements and diversity of Jewish people every day, and I am proud to join many of my colleagues in celebrating May as Jewish American Heritage Month.

Since first immigrating to the United States in 1654, Jewish Americans have accomplished countless achievements. Great minds, such as Ruth Bader Ginsburg and Elie Wiesel, have made irrevocable impacts on both our culture and society. The Jewish American people continue to make our Nation proud by serving in the highest ranks of our military, achieving groundbreaking advancements in science, revolutionizing music and art, and much more.

My community of Rochester, NY, is steeped in Jewish culture. Since the mid-1800's, Jewish families have settled in the region, making Rochester their home for generations to come. FINANCIAL INNOVATION AND TECHNOLOGY FOR THE 21ST CENTURY ACT

Ms. McCOLLUM. Mr. Chair, I rise in opposition to H.R. 4763, the Financial Innovation and Technology for the 21st Century Act.

While I am opposed to this bill, I am not opposed to the concept of crypto itself. But I have concerns about how crypto is currently regulated and believe that H.R. 4763 falls short of creating an effective regulatory framework. H.R. 4763 would also result in the massive deregulation of the securities market, not just for crypto but for traditional securities as well. This deregulation would remove protections provided by existing securities law to protect crypto investors and consumers and remove disclosure requirements that are designed to help investors make informed decisions. Additionally. H.R. 4763 would preempt state laws, disarming state regulators in Minnesota who are often on the frontlines against fraud.

H.R. 4763 lacks necessary protections for crypto consumers and investors. As of today, the crypto asset industry does not comply with existing securities laws and regulations, allowing consumers to be defrauded. In fact, the Consumer Financial Protection Bureau (CFPB) received more than 8,300 complaints related to crypto between 2018–2022. Roughly forty percent of those complaints were reporting frauds and scams. This bill will only exacerbate this issue. We must reject H.R. 4763 and work to create a regulatory framework that will protect everyday investors and consumers.

Crypto is the currency of choice for our foreign adversaries, terrorist groups, drug and human traffickers, child sex abusers, and ransomware attackers. These bad actors chose to use crypto because they know the industry does comply with securities laws and regulations, allowing the groups to circumvent regulatory, supervisory, and enforcement regimes. Congress should be considering legislation that will make it harder for these bad actors to access currency, not allowing loopholes to persist. We must ensure to be sure that crypto is not used as the black market for bad actors.

Crypto asset platforms, where customers buy and sell crypto assets, are known to use vertical product and service integration, creating conflicts of interests for the platforms. Some crypto asset platforms blend exchange, brokerage, market making, and clearing agency functions in their platform. This vertical integration of products and services has long been prohibited in traditional markets because it leads to risks for investors. We saw this loophole exploited in 2022 when FTX's CEO, Sam Bankman-Fried, used its affiliated trading firm, Alameda Research, as a market maker, allowing FTX to transfer billions of dollars in customer accounts to Alameda. Sam Bankman-Fried is now serving a 25-year prison sentence for defrauding consumers. H.R. 4763 bakes in these existing conflicts of interest, allowing crypto asset platforms like FTX to continue to work against their customers' best interest for their own gains.

Rather than putting forward a bill that would severely undermine the functioning of our capital markets, Congress should instead consider a comprehensive regulatory framework for crypto that will promote the responsible development of these digital assets while protecting American consumers and investors. I urge my colleagues to reject H.R. 4763.

Mr. EDWARDS. Mr. Speaker, I include in the RECORD the following newsletter to give an update to my constituents to bring awareness to issues surrounding the border and fentanyl crises, antisemitism and Americans' financial privacy

Dear Friend,

It's been more than a year since the House passed H.R. 2. the Secure the Border Act, the strongest border security bill in history.

H.R. 2 would reimplement President Trump's effective border policies and end this administration's border crisis, which continues to jeopardize our national security and sovereignty.

In fact, a record-breaking number of nationals from our adversary, China, are illegally crossing our border. In April, the Customs and Border Patrol found that in this fiscal year alone, they have encountered 27,583 Chinese nationals, a nearly 8,000 percent increase from fiscal year 2021.

With the rising threat of the Chinese Communist Party (CCP), border security is paramount to national security and I will not relent in the fight to secure America's borders.

I recently spoke on the House floor about how the fentanyl pouring in through our borders has taken lives in our own communities in the mountains and urged that this administration put the American people first and close our southern border once and for all.

THE U.S. MUST STAND WITH ISRAEL

As our ally, Israel, is defending itself from terrorist organizations, it is critical that we continue to stand with and support Israel.

The president recently announced he would stop military aid to Israel at a time when this aid is needed to target Hamas terrorists and avoid more civilian casualties in what looks like an attempt to appease the growing pro-Hamas sentiment among the left.

In light of this administration's misguided decision to halt military aid to Israel, a bipartisan group of colleagues and I demanded that the president provide answers on his decision to withhold shipments to Israel.

Furthermore, the International Criminal Court (ICC) issued baseless arrest warrants for Israeli officials, equating them to the terrorists who committed the horrific attacks of Oct. 7. The ICC's decision is great news to terrorists around the globe and is a slap in the face to the only free-standing democracy in the Middle East.

If I have my way, the United States will never abandon Israel, especially not while it is fighting for the right to exist and the rights of Jewish people everywhere, and no country should recognize any legitimacy of a pro-terrorist international court.

PROTECTING AMERICANS' RIGHT TO FINANCIAL PRIVACY

President Biden released a framework to evaluate the establishment of a central bank digital currency (CBDC), which can be used as a surveillance tool and weaponized against the American people.

In China, the Communist Party has been using a CBDC to track the spending habits of its citizens and we cannot allow this level of financial surveillance in America.

That's why I cast NC-11's vote for the CBDC Anti-Surveillance State Act. This bill protects Americans' right to financial privacy by halting unelected bureaucrats from issuing a CBDC and is the first anti-central bank digital currency legislative effort ever introduced in Congress.

#### WNC BACKS THE BLUE

During the past three years, the Defund the Police movement and anti-police policies have led to a surge in violent crime across the country.

In the U.S. House of Representatives, we recently celebrated National Police Week and honored America's law enforcement heroes by passing legislation to support our men and women in blue.

Some of the bills that I voted for to support our police officers include bills that would:

Require ICE to detain illegal immigrants who are arrested, charged or convicted with assaulting a law enforcement officer or other first responder.

Make sure officers can protect themselves and others by allowing concealed weapon possession in more areas open to the public.

Direct the attorney general to report to Congress on how the border crisis affects law enforcement at various levels.

Make sure there is adequate data collection to address the rise of attacks on police officers.

While this year's police week might be over, I will continue to back policies that support America's law enforcement officers who risk their own lives to protect and serve citizens day after day.

HOUSE COMMITTEE INVESTIGATES CHINA'S ROLE IN THE FENTANYL CRISIS

Following a months-long bipartisan investigation, the House Select Committee on the Chinese Communist Party (CCP) revealed its findings of the CCP's role in the deadly fentanyl epidemic that has killed hundreds of thousands of Americans.

The fentanyl crisis is one of the most devastating disasters that our nation has faced and has made its way to the mountains of Western North Carolina. Fentanyl kills more than 200 Americans daily on average, which is the equivalent to a packed Boeing 737 crashing every single day. After all, the amount of fentanyl that is considered a potentially deadly dose is as small as the amount that fits on the tip of a pencil.

This dangerous drug is the leading cause of death for Americans aged 18–49 and has led to millions more suffering from addiction while continuing to destroy families and communities. The fentanyl crisis is not just limited to the United States, as fentanyl and other mass-produced synthetic narcotics from the People's Republic of China (PRC) are devastating nations around the world.

This is why the U.S. must swiftly act on the following findings from the select committee's investigation to address the root cause of this global crisis.

The select committee's investigation found that the PRC government, under the control of the CCP:

Directly subsidizes the manufacturing and export of illicit fentanyl materials and other synthetic narcotics through tax rebates.

Gave monetary grants and awards to companies openly trafficking illicit fentanyl materials and other synthetic narcotics.

Holds ownership interest in several PRC companies tied to drug trafficking.

Fails to prosecute fentanyl and precursor manufacturers.

Allows the open sale of fentanyl precursors and other illicit materials on the extensively monitored and controlled PRC internet.

Censors content about domestic drug sales but leaves export-focused narcotics content untouched

Strategically and economically benefits from the fentanyl crisis.

The takeaways from these findings are that the U.S. needs to take the following decisive actions to address the fentanyl crisis: establish a Joint Task Force—Counter Opioids; provide law enforcement and intelligence officials with the authorities, tools and resources they need; strengthen U.S. sanctions authorities; enact and use trade

and customs enforcement measures and close regulatory and enforcement gaps.

INFLATION CONTINUES TO WREAK HAVOC ON WESTERN NORTH CAROLINIANS' WAY OF LIFE

Our economy continues to suffer due to this administration's fiscal policies.

Inflation was at 1.4 percent when Biden took office and has risen nearly 20 percent since then. High prices are forcing Americans to spend more than \$12,000 more a year to afford the same basics compared to three years ago.
