Luis was born in Sao Jorge, Azores, Portugal in 1959. His family briefly lived in Angola, Africa before returning to the Azores and immigrating to California in 1969. After the passing of his father, his family returned to Portugal before emigrating back to the U.S. and settling in Lowell. After graduating from Lowell High School in 1980, Luis would embark on a professional career where he would go on to found Qualitronics, Inc., co-found Accutronics, Inc., high-end electronics manufacturing companies, that have employed many people in our region. Before retiring, Luis sold both of his companies—a testament to his tremendous career in business.

In addition to his impressive professional career, Luis never forgot where he came from. He is extremely involved in the Portuguese community, so much so that he established the Hélio and Amélia Pedrosa/Fundação Luso-Americana Endowed Chair in Portuguese Studies at UMASS Dartmouth as well as the Saab-Pedrosa Center for Portuguese Studies at UMASS Lowell. He also played an instrumental role in spearheading the effort to bring 24-hour Portuguese programming to local television to serve Lowell and other communities. He is a founding member of the Greater Lowell Community Foundation (GLCF), where he recruited many individuals, including myself, to serve on its board and support nonprofits in Lowell and beyond. For 27 years, the GLCF has transformed the lives of countless individuals, families and nonprofit organizations in our community by fostering community growth and development through funding, leadership, and collaboration. Luis is also the creator of the Portuguese American Scholarship through the Greater Lowell Foundation which assists graduates of Lowell High School. Through Luis's leadership and efforts, he has made the City of Lowell a better place to live, work and raise a family.

Luis's kindness and wisdom make him a trusted figure for individuals to lean on when experiencing hardship. Most notably, Luis played an integral role in assisting a young woman who was studying at Middlesex Community College to receive her nursing degree. After a car accident left her vehicle totaled, she reached out to Luis, who without hesitation was able to assist her in finding a new vehicle so she could continue her studies and fulfill her practicum.

Throughout his life, Luis has been the recipient of numerous recognitions from distinguished organizations for his work in our community. He has been recognized as the Massachusetts Alliance of Portuguese Speakers Person of the Year, as well as being named a recipient of the prestigious George L. Duncan Award of Excellence. He was selected to receive the Order of Prince Henry the Navigator Award and the International Institute American Dream Award and was inducted into the Lowell High School Distinguished Alumni Hall of Fame. In the face of so many well-deserved accolades, Luis has remained humble, accessible, and down to earth—a surprise to no one who has had the pleasure of knowing him.

#### CELEBRATING NEGRO ELECTION DAY

To enshrine its significance, the Massachusetts State Legislature passed S. 2703 on February 17, 2022, establishing the third Saturday in July as a state holiday.

In the words of Massachusetts State Senator Joan B. Lovely from Salem, "We must continue to commemorate the meaningful milestones African Americans have contributed to Massachusetts and our Nation today and in all the days going forward." It is with those words that I ask you to please join me in honoring the history and celebration of Negro Election Day.

After he was buried, it took 81 years to identify Clifford's remains.

In service of his country, Clifford made the ultimate sacrifice and we are eternally grateful for his courage in the line of duty. On June 29, 2024, Clifford will finally return home where he will be buried surrounded by family and loved ones in Florence, Colorado.

On behalf of the people of Colorado's Seventh Congressional District, it is my honor to recognize Clifford's service and sacrifice. We are thankful to have him home after all these years.

CELEBRATING COLMA'S 100TH  
ANNIVERSARY**HON. KEVIN MULLIN**

Mr. MULLIN. Mr. Speaker, I rise to honor the Town of Colma and join in celebrating the 100-year anniversary of the town's incorporation, and its unique history and significance to my district.

Nestled in the north of San Mateo County, California, Colma is the smallest incorporated community by living population in the county that has a remarkable story to tell. As a San Mateo County native, I'm very familiar with Colma and its fame as a necropolis. Referred to as the "City of Souls," Colma has approximately 1,500 residents but over 1.5 million graves, brandishing the motto "It's great to be alive in Colma." In the early 1900's, San Francisco was growing and developing at a rapid pace, and areas and space for burials became scarce. The San Francisco Board of Supervisors prohibited new burials within city limits, prompting cemeteries to relocate to the more spacious and convenient surroundings of Colma.

Today, Colma boasts 17 cemeteries altogether, including a pet cemetery. This astonishing number of remains includes notable figures such as Levi Strauss, the founder of the namesake blue jean company, Wyatt Earp, the infamous lawman of the Wild West, Joe DiMaggio and Willie McCovey, legendary baseball players, William Randolph Hearst, newspaper tycoon, Bill Graham, famed music promoter, and California political leaders like Governor Edmund "Pat" Brown. Their resting places, along with many others, attract visitors from near and far, making Colma a place of reflection and pilgrimage. Colma's cemeteries are not just places of mourning; they are also spaces of beauty and history. The grounds and historic monuments serve as a living museum, presenting the stories of countless individuals and preserving the history of the region. These cemeteries also significantly contribute to the local economy. Colma's unique position as a necropolis means that cemetery related industries like flower shops and monument businesses have sprung up across town. By supporting local employment and commerce, the town and its residents have utilized their unique circumstances to foster strength and sustainability within their community.

Colma's significance extends beyond its role as a final resting place. Long before incorporation, Ohlone natives settled in the area and the Spanish used the land for farming and ranching. During the Gold Rush, the area that is now Colma was crucial for its agricultural products, dairies, and ranches to feed the greater San Francisco Bay Area and the large influx of people. As the greater San Francisco Bay Area grew, so did Colma, incorporating as Lawndale in 1924. The name changed in 1941 due to a conflict with a post office of the same name in Southern California.

After World War II, Colma saw an increase in new housing subdivisions driven by returning veterans and continued adapting to changing needs and diversifying its economy. Colma is home to the famous "Serramonte Auto Row" of car dealerships, both foreign and domestic, right in the heart of the town and the

town is a retail brick and mortar shopping destination. The Colma BART station opened in 1996 and was the first expansion of the mass transit system deeper into San Mateo County beyond the original plans. I have also worked closely with him to secure district projects in the past several Water Resources Development Acts, including provisions to deauthorize the Wolf River to create a lake adjacent to the historic downtown Snuff District and to accommodate a floating entertainment dock at Cobblestone Landing. A

graduate of the University of Memphis with a Bachelor of Science degree in Civil Engineering (2003), he also has a Master of Business Administration (2008) from the University of Phoenix. A veteran of the U.S. Air Force, he served during Desert Storm/Desert Shield. Married to Memphis native Mandy, he and his three children have bright days ahead as he heads for an opportunity in the private sector. As Mayor Paul Young has said, his shoes will be hard to fill. His has been a job well done.

Eddie met the love of his life, Rose Marie Altieri on New Year's Eve in 1947. They married in Brockton on October 12, 1950. The couple raised two sons, E. Peter Guaraldi, Jr. and John Joseph Guaraldi. Eddie and Marie doted on their grandson, Peter James Guaraldi, throughout his childhood.

After his service, Mr. Guaraldi attended school to be a radio and electronic technician, eventually getting a job at Central Radio in Brockton. There, he fixed televisions and installed antennae, with the desire to open his own business. In 1951, that dream came true as Eddie opened Community Television in Brockton, running the family business for 44 years before working part-time alongside his eldest son until the age of 80.

Eddie was very involved in the South Shore and Brockton communities. For decades, he was a longtime volunteer and communicant at his local church Our Lady of Lourdes Church in Brockton. His volunteering at the Brockton Kids Road Races at D.W. Field Park for nearly 15 years helped make a positive impact on thousands of children and aspiring athletes. Mr. Guaraldi was also a regular at various veterans' meetings and events hosted by the Brockton VA Medical Center, and the Whitman Veterans of Foreign War Post, among others.

He and Marie were known for their love of travel, visiting many places around the world, including Europe, China, Japan, and South America.

Eddie is a man of many hobbies and talents, particularly his ability to repair electronics, appliances, and anything else his family needs fixing. He looks forward to supporting his favorite team, the New England Patriots, every Sunday during football season.

**SUPPORTING RACE-CONSCIOUS ADMISSIONS IN HIGHER EDUCATION**

Mr. DAVIS of Illinois. Mr. Speaker, as we end the 2024 session of the Supreme Court and prepare for students to return to school, I wish to reaffirm the need for race-conscious decisions in higher education to ensure that students of color receive fair consideration in admissions.

Affirmative action is an important equity tool to counteract the effects of discrimination and structural barriers to education facing students of color, a tool that emerged from the Civil Rights Movement in the 1960s. President John F. Kennedy first established affirmative action to promote racial equality and prevent unfair labor practices through an executive order in 1961 that created the President's Committee on Equal Employment Opportunity. The landmark Civil Rights Act of 1964 went further to prohibit discrimination and promote equal opportunity based on race, color, religion, sex, and national origin. Subsequent executive orders, laws, and holdings by the Supreme Court supported race- and gender-conscious actions to address discrimination and enforce the Civil Rights Act of 1964.

The consideration of race in college admissions promotes equal treatment without regard to race, color, religion, or national origin. The resulting campus diversity is a crucial element of quality higher education. Diversity curates higher learning opportunities and fosters a sense of belonging for traditionally-marginalized communities. Research shows that a strong sense of belonging has many positive outcomes for students, including improved persistence, retention, grades, and health. Diversity in higher education expands perspectives, promotes innovation, and prepares students to interact with our diverse citizenry.

One year ago, the Supreme Court gutted 50 years of race-conscious admissions in higher education with its decision in *Students for Fair Admissions Inc. v. President and the Fellows of Harvard*. In a 6–3 decision, the extremist-dominated court ruled that affirmative action violated equal protection under the 14th Amendment. The 14th Amendment manifested new freedom and rights at the federal level by establishing “equal protection under the laws” for all American citizens regardless of race. Shockingly and offensively, the conservative-dominated court manipulated an amendment intended to cultivate racial equality to stifle programs that correct systemic racial discrimination. I firmly agree with Justices Jackson and Sotomayor who opposed the ruling. Justice Sotomayor warned that “. . . racial inequality will persist in educational institutions so long as it is ignored.” Justice Jackson noted the contradictory nature of the absence of race in admissions decisions but not in military academies, prioritizing racial inclusion for military benefit rather than educational enrichment.

The 7th District of Illinois, Chicago, and Illinois are home to millions of families whose children deserve the same access to higher education opportunities that privileged individuals enjoy. Extremists' attacks on race-conscious admissions jeopardizes the future educational opportunities of Black and Brown children. A colorblind approach to the college admissions process does not acknowledge the entrenched racial struggles that minorities face in America. When institutions fail to acknowledge race, they fail to recognize the barriers to education associated with race that can perpetuate racial inequality in higher education. The Supreme Court's promotion of a colorblind society serves to protect the wealthy and well-connected.

I vow to fight for equal opportunity and justice. We must protect the tools that are key to securing our civil rights—like race-conscious admissions, free and fair elections, and voter protections—to ensure that our nation's progress in civil rights does not reverse. Advancement toward racial equality cannot be made without consideration of race.
