The city's name was changed to Chicago Junction, but the word "junction" did not fit on name boards at the time. In 1917, the town changed its name to Willard, after the then president of the Baltimore and Ohio Railroad, Daniel Willard. In 1960, Willard officially became the city's name. The city is an asset to the great State of Ohio through its many contributions in the fields of manufac-

turing and agriculture. It remains to this day a key junction for the rail company CSX Transportation.

Mr. Speaker, by remembering the 150th Anniversary of the City of Willard, community members recognize the outstanding achievements, maintain the pioneer attitude, and strive to better their city through the principles on which it was founded. I thank and congratulate Willard on this significant milestone.

Mr. TURNER. Mr. Speaker, I want to congratulate TAC (The Abilities Connection) Industries, a nonprofit organization located in my Congressional district, that provides job opportunities to people with disabilities through its participation in the AbilityOne Program. AbilityOne is a federal program that provides employment opportunities to approximately 40,000 people who are blind or have significant disabilities, including more than 2,500 veterans.

TAC Industries recently received the 2024 Innovation Award at Source America's annual X-Force conference in Orlando, Florida. This award honors a nonprofit that developed "in-

novative work methods, products or services." TAC Industries partnered with Clark State College in Springfield, Ohio, which is also in my district, to create the Fresh Abilities restaurant, a farm-to-table quick service restaurant on the campus, which functions simultaneously as an employment center and a training program for workers with disabilities.

Through their partnership, TAC developed a curriculum that included over 100 hours of classroom instruction and hands-on skill building. They utilized the college's classroom facilities for their employees' food safety training. In the restaurant, the employees were then trained in how to prepare meals, how to make sales, and develop customer service skills.

Employees at Fresh Abilities gained the unique experience of working in a safe, inclusive environment while getting the training and support they need to do their jobs to the best of their abilities. Clark State students, faculty and employees gained access to healthy food, and the college's administration was able to divert funds previously spent on food service to other student-focused areas.

For individuals with disabilities, the opportunity to pursue a fulfilling, meaningful career of one's own choosing with a path for advancement is important to their quality of life. I appreciate the work TAC Industries undertakes to provide these employment and vocational opportunities, and congratulate them on receiving this prestigious award.

Mr. BACON. Mr. Speaker, I rise today to honor the legacy of the Strategic Air Command (SAC) Elite Guard, as they celebrate their reunion this August.

Founded in 1956 by the visionary General Curtis Lemay, the Guard wasn't simply a security unit, it was the cornerstone of safeguarding our nation's most critical assets. Following WWII, the security surrounding our strategic air assets were woefully inadequate. Because of this, Lemay sanctioned Detachment "A" of the 3902nd Air Police Squadron at Offutt Air Force Base, which later became known as the SAC Elite Guard.

Having had the privilege of serving as a SAC intel briefer, I can attest to the elite men and women that served in the Guard. They were hand-picked, rigorously trained, and became guardians not just of installations and resources, but those who shielded our nuclear arsenal, and served as our planet's greatest deterrence.

The Guard's mission was threefold: securing SAC Headquarters, protecting the Commander and Vice Commander, and as SAC ambassadors at official dignitary functions representing SAC with honor. Serving during the Cold War had its many complications, and the weight of responsibility all service men and women carried was immense, yet the Guard never faltered. The Guard pushed themselves to the limit, both physically and mentally, and the weight of these responsibilities forged an unbreakable bond between them, because they knew even the smallest mistake could have devastating consequences.

In 2004 the SAC Elite Guard Association was formed by former SAC Elite Guardsmen Sgt Mike Paventi and Sgt Herbert "Bill" Marshall. The association's mission was to maintain a social connection to those men and women that served and protected SAC Headquarters. The Guard's reunion each year is a chance to honor the legacy they built together. A chance to remember all our fallen comrades, whose sacrifices will never be forgotten, and a chance to reconnect with the brothers and sisters in arms who shared the Guard's extraordinary experience.

Ms. DAVIDS of Kansas. Mr. Speaker, I rise today to celebrate the accomplishments of Mr. Ed Dwight.

In 1961, Mr. Dwight was a U.S. Air Force pilot when President John F. Kennedy selected him as a candidate for NASA's early astronaut corps. In the face of great pressure and prejudice, Mr. Dwight became the first Black astronaut candidate and advanced to the second phase of the training course. Despite his stellar accomplishments, qualifications, and graduation in the top half of a test pilot school, Mr. Dwight was not selected to be a part of the final astronaut group.

But, on May 20, 2024, at 90 years old, Mr. Dwight finally achieved spaceflight.

This story is perhaps a perfect representation of Mr. Dwight's drive and tenacity. He was born and raised in racially segregated Kansas City, Kansas. Mr. Dwight was the first Black male to graduate from Bishop Ward High School in Kansas City, a feat that did not come without experiencing hate and injustice. He earned his Associate of Arts in engineering

from Kansas City Community College and graduated cum laude from Arizona State University with a Bachelor of Science in aeronautical engineering before serving as a captain in the Air Force.

Even in the wake of disappointment following his rejection from the final 1963 astronaut group, Mr. Dwight did not retreat. Instead, he worked for IBM, started a construction company, opened his own barbecue restaurant, and finally, as if none of this was enough, earned a Master of Fine Art in Sculpture from the University of Denver. He's since become a highly respected artist. His sculptures focus on Black history and include memorials and monuments across the country.

The Kansas state motto is "ad astra per aspera," which means "through hardships to the stars." Mr. Dwight embodies everything it means to persevere and, literally, reach for the stars. He is a true example of the American dream, and I'm honored to have such an extraordinary individual call Kansas City home.

Throughout their lives, Mrs. Pope has been dedicated to her children and active in their activities. She served as den mother for Cub Scouts and troop leader for Girl Scouts, taught 4-H sewing, and was president of the Parent Teacher Association.

Mrs. Pope has been an active member of her community throughout her life. She worked as the bookkeeper for her husband's painting business and was a substitute teacher at the local elementary school. Mrs. Pope also dedicated more than 4,000 hours as a volunteer at the local hospital service league. Mrs. Pope and her husband were key participants in the establishment of the Mee Memorial Hospital Foundation. To honor their life of service to the community, they were named King City Citizens of the Year in 1997.

After her husband's passing in 2012, Mrs. Pope moved to Visalia to be closer to her family. She is the proud grandmother of 2 grandsons, 7 granddaughters, and 16 great-grandchildren. In addition to spending time with her family, she remains a thriving member of the Visalia community, enjoying playing piano concerts, painting, and spending time with friends.

Mr. CLEAVER. Mr. Speaker, I rise today with a heavy heart to announce the passing of Charles "Charlie" Olvera Lona on June 26, 2024. Charlie was a beacon of justice, advocacy, and hope in Kansas City's Westside community and beyond. I urge us all to celebrate and remember the life of this incredible activist, community leader, friend, brother, father, grandfather, and great-grandfather.

Born in Kansas City on October 14, 1946, to Wesley H. and Luz O. Lona, Charlie became an active community member of Kansas City's Westside neighborhood—a historic Mexican-American community—at birth. A graduate of Westport High School and Metropolitan Community College, Charlie took over his family business and transformed it into a Westside, and Midwest, staple.

Through dedication, effort, and business acuity, Charlie transformed his father's automotive repair shop into one specializing in building custom lowriders. His business, Lona & Sons Hydraulics, brought this unique aspect of Chicano culture to Kansas City. As Charlie allowed lowrider culture to make its mark on Kansas City, his skill and work brought attention from all over the United States.

Charlie's contribution to Kansas City's Chicano community did not stop at his business. He spent his life uplifting and empowering the residents of the Westside through his relentless advocacy and commitment to being a voice for the unheard. Worried that his fellow residents were being excluded from city affairs and left with disproportionately low resources, Charlie became a proud supporter of the Chicano Movement in the 1960s. He courageously marched, organized, and protested for

equal rights and better conditions for the Westside neighborhood and beyond. Charlie also founded the Kansas City chapter of the Brown Berets, a Chicano activist group inspired by the Black Panthers. Collaborating with other famous Chicano leaders like Rodolfo "Corky" Gonzales and Cesar Chavez, Charlie inspired Kansas Citians to join El Movimiento.

In addition to bringing nationwide movements to Kansas City, Charlie placed great value on local activism. His political influence helped elect many Chicano leaders to local government, allowing Westside residents to take part in the city affairs from which they long felt excluded. He also is responsible for the founding of the Aztlan Center for Chicano cultural education and empowerment, and for immensely expanding the impact of the Guadalupe Centers, a local social service agency for Latin Americans in the United States, that is now the longest continuously standing agency of its kind. Even as he neared the end of his life, Charlie never wavered in his fight for justice and equity.

Though Charlie has passed, his legacy and impact on Kansas City will remain long past our mortal lifetimes. I am reminded of Mark 10:45—"For even the Son of Man did not come to be served, but to serve, and to give his life as a ransom for many." Charlie's life was one dedicated to serving others in need, bettering the lives of countless people throughout. Charlie is survived by his loving family, friends, and the current and future generations of the Westside. As we celebrate and fondly appreciate the decades of devoted service from Charlie, let us be inspired by him to advocate for justice and uplift our community.

INTRODUCTION OF THE DEPARTMENT OF THE TREASURY OFFICER PROTECTION ACT OF 2024

Ms. NORTON. Mr. Speaker, today, I introduce the Department of the Treasury Officer Protection Act of 2024. This bill would help protect Treasury Department police officers and the public by allowing all the officers, including those who work at the Bureau of Engraving and Printing (BEP), to carry their government firearms home.

BEP officers are not allowed to take their government firearms home. However, BEP officers can be targets because they wear uniforms to and from work. Many BEP officers carry personal firearms to and from work because they are not allowed to take their government firearms home, and some are forced to leave those personal firearms in their cars while they are on duty, creating a possibly dangerous situation.

Allowing BEP officers to carry their government firearms home will put them in the same position as Mint officers. Although both agencies are under the Treasury Department under Treasury Department rules, Mint officers are allowed to carry their government firearms home, while BEP officers are not. There is no meaningful distinction between officers for these two agencies. They should be treated equally.

This bill would allow all police officers in the Treasury Department to carry their government firearms home to protect officers and the public, eliminating separate carrying rules for the Treasury Department's different law enforcement agencies.

I ask my colleagues to support this bill.
