The community of Trampas was settled in 1751 by 12 Spanish families who painstakingly carved out an existence in one of the most beautiful parts of our state and country. They relied on the strength of family, the power of community, and faith in God; so much so, that after more than 10 years of backbreaking work they raised up the San José de Gracia Church. The church, which is designated as a National Historic Landmark, is approaching its 250th anniversary.

After spending nearly a decade handcrafting, carving, shaping, lifting, and tenderly decorating; the community of Las Trampas spent the next 250 years upkeeping this gem of 18th Century culture, architecture, and faith. For 250 years, it was their faith that kept the candles burning, the vigas and planks intact, and the adobe plaster fresh and strong. For 250 years this community has worked as one to preserve their faith and heritage in such a way that is unmistakably New Mexican—and unmistakably a reflection of unwavering faith in God and in one another. The San José de Gracia Church is the only distinctly Spanish Colonial building that remains completely intact within the original historic district of Las Trampas.

Walking in, you are reminded of the original builders, members of the community from all walks of life, the fathers and mothers, the sons and daughters who lent any talent they could to their community for the sake of honoring God and creating a remarkable place to worship. The original floorboards, under which are buried countless members of the Trampas Community creak and pop as you approach the original 18th century altar. The altar, which is covered in frescos, is unlike anything else standing in this country—and still vibrant enough today to steal the breath and inspire awe from all who behold it. In addition to the faith that it has taken for a community to continue such painstaking work for so long—I also wish to honor the love that it took to keep this church alive. It is love that makes it more than just a structure, but a symbol of resilience, survival, and compassion. I wish that every single American could open their heart and draw from that example as we live and work with one another today and into the future.

For the countless hours spent on its construction, for the countless hands that plastered its 6-foot-thick adobe walls, for the thousands of hearts that looked to God for salvation in its pews, and for the 250 years that it has graced the mountains of northern New Mexico, I honor the San José de Gracia Church, and the community of Las Trampas. Mr. Speaker, members of Congress of the United States of America, I also pray that God grants at least 250 more.

Max was known by his friends and family as a "Renaissance man" who loved the outdoors, travel, history, and science. He is survived by his loving wife Linda Olivenbaum and daughter Marisha Anderson.

Living Jazz is launching new mentorship programs, reigniting localized jam sessions, and renewed partnerships with local schools and businesses.

In 2015, Captain Dillon was selected to instruct English Composition and Literature at West Point Military Academy. From 2017 to 2018, Major Dillon served as the operations officer for a 400-soldier Multiple Launch

Rocket System Battalion, preparing the battalion for deployment to Korea. Major Dillon was subsequently selected for the 75th Fire Brigade as the executive officer, and then hand-selected to be the fire support officer to manage fire support functions and operational plans for the largest field artillery brigade in the United States Army, with over 3500 soldiers. In this position, he developed and executed the largest combined, live, and virtual exercise in over five years, incorporating nearly 1,000 soldiers, to prepare the brigade for deployment in support of Operation Spartan Shield in 2020–2021. In 2020, Lieutenant Colonel Dillon became the division chief for the Army MultiDomain Targeting Center, responsible for building an Army-wide targeting enterprise of over 40 organizations and thousands of soldiers and civilians.

Throughout his career, Lieutenant Colonel Dillon demonstrated remarkable leadership and dedication, participating in deployments to Korea, Iraq, and Afghanistan. A lifelong learner, Lieutenant Colonel Dillon earned his Master of Arts in English Language and Literature from the University of Central Oklahoma and attended the United States Army Command and General Staff College.

His remarkable career and leadership in the Army significantly contributed to our Nation's defense. Born on April 9, 1933, Dr. Hare was a son of Oklahoma sharecroppers. Academically gifted, he excelled through the state's segregated school system, earning a bachelor's degree from Langston University. He went on to receive a master's degree and Ph.D. in Sociology from the University of Chicago, finishing his education with a second Ph.D. in clinical psychology at the California School of Professional Psychology.

Throughout his academic and professional career, Dr. Hare was a champion of Black history and power. In 1965, as a professor at Howard University, he published "The Black Anglo-Saxons," the first of his many groundbreaking works.

In 1968, he arrived at San Francisco State University, where he sought to develop an interdisciplinary program dedicated to understanding the Black experience. After significant pushback from the university's administration, which resulted in a five-month strike with students and faculty, Dr. Hare completed the proposal for the program. With its adoption, Dr. Hare became the first head of a Black Studies Department in the United States.

In 1969, Dr. Hare co-founded the Black Scholar magazine. Through this publication,

he granted me the privilege of writing an edition about the Non-Aligned Movement. The Conference on Non-Aligned Nations was held in Havana, Cuba and I received credentials as a journalist to cover this impactful summit on behalf of the Black Scholar and the Sun Reporter newspaper.

He also asked me to write an article about the nonviolent revolution in Grenada. Through our friendship, work, and his mentorship, he taught me what a Black perspective on foreign policy and international relations meant as an African American. For this, I am deeply grateful.

Dr. Hare was preceded in death by his loving wife, Dr. Julia (Reed) Hare, an activist and scholar who joined him on the frontlines of his academic efforts. In 1979, they founded a research institution, called the Black Think Tank, where they wrote several books about Black life in America.

Dr. Nathan Hare was an incredible scholar, whose contributions to Black academia and media have made a lasting impact on our world. He will be greatly missed by those who had the honor of knowing him and remembered by all who stand upon his shoulders. May he rest in eternal peace and power.

He earned multiple degrees, including a B.S. in Engineering Technology from the University of South Florida, a B.A. and M.A. from Florida Beacon Bible College, and a Ph.D. from Andersonville Theological College and Seminary. Licensed as a minister in 1986, he was ordained in 1988 and installed as Pastor of Macedonia Missionary Baptist Church in January 1989, where he faithfully led his congregation until September of 2024. Crews's legacy is marked by his deep faith, his commitment to education, and his unwavering service to his community and to his country. He is a man of conviction and compassion who has touched the lives of many through his ministry and mentorship.
