He supported the 2023-2031 San Carlos Housing Element, which aims to create a total of 1,164 new units of housing for low-income families and approved numerous other significant affordable housing developments. Ron also supported the San Carlos Avenue Pedestrian Improvement Project and the Bicycle and Pedestrian Master Plan, aiming to make San Carlos a place where people can freely and safely navigate across the city's streets.

Ron has worked to plan for the future of San Carlos and has also sought to enhance the city in the present. Ron supported multiple sustainability initiatives to adapt San Carlos in the face of the threat of climate change, from beginning to transition San Carlos' fleet of Public Works vehicles to an EV platform, to adopting a disposable foodware ordinance. tionary War hero, Dr. Joseph Warren. At the time of her founding, a sum of almost \$10,000 was raised to build a county courthouse that is still in use to this day.

Warren County has historically been an important locus of transportation and commerce. In the 1650s, Dutch settlers built a road to carry mined copper in the region across colony lines to New York. Today, "Old Mine Road" is a popular visitor attraction for both New Jersey residents and tourists from across the country. Through the 19th century, Warren County expanded in commercial importance, hosting a large part of the Morris Canal, which connected the New Jersey and Pennsylvania countryside to metropolitan markets on the eastern seaboard. Phillipsburg, New Jersey, also became a major hub for five major railroads.

The County also has a long history of industriousness and prosperity. In the 1830s, furnaces in Oxford, New Jersey, became the first in the Nation to use the hot blast process, while a Phillipsburg furnace was one of the first to employ the Bessemer process. Phillipsburg was also home to the first commercially successful diesel-electric train engines. In the 20th century, a heavy manufacturing plant in Phillipsburg provided critical machinery for the Allied World War II victory. Today, Warren County remains the leading manufacturing county among the 21 counties of New Jersey.

Agriculture has long been a staple of Warren County's prosperity and health. Warren County feeds New Jerseyans as the top producing County of milk, dairy, cattle, feed corn, and eggs. The county's proud tradition of family-owned farms continues to provide quality fresh produce to residents across New Jersey and Pennsylvania.

It is my honor to congratulate the communities of Warren County on their bicentennial celebration, as it continues to be a pillar of New Jersey and American agriculture, industry, and history.

Ms. SLOTKIN. Mr. Speaker, today I honor Rich Allen, a distinguished military veteran and the longest tenured employee at Lansing Community College. Rich Allen's life exemplifies dedication to both education and service. His story is one of unwavering commitment to his country and to higher education.

Born on June 11, 1945 in Fort Wayne, Indiana, Rich moved with his family to Michigan in the 1950s. He grew up in Michigan and graduated from Chelsea High School in 1963. After earning a Bachelor of Arts degree from Cleary University, Rich chose to enlist in the U.S. Army in 1967 during the height of the Vietnam War. He served with the Army Security Agency, a predecessor of today's National Security Agency, which was tasked with electronic intelligence and warfare. Agency operators played a critical role in intercepting and decoding enemy radio transmissions to provide vital intelligence to American forces.

As a Morse Intercept Operator, Rich underwent rigorous training, mastering Morse code. In 1968, he was deployed to Vietnam stationed at the 303rd Radio Research Battalion, an undercover unit for Army Security Agency operators. Rich performed critical tasks such as tracking enemy radio transmissions and triangulating positions to support military operations. His work, which often included helicopter reconnaissance to gather frontline intelligence, was crucial to the war effort, coordinating intelligence that informed artillery and airstrikes.

Rich's distinguished service earned him numerous commendations, including the Bronze Star Medal with an Oak Leaf Cluster, the Army Commendation Medal, and the Vietnam Service Medal, all recognizing his technical expertise and steadfast commitment.

After his honorable discharge in 1971, Rich returned to Michigan and enrolled at Lansing

Community College, marking the beginning of a 50-year career. While pursuing a degree in computer programming, he began as a student programmer in 1973 and soon transitioned to a full-time position in the Information Technology Department, where he helped advance the college's technological capabilities. From writing code on punch cards and using early computer systems to developing the college's first online system in 1975, his work laid the foundation for modern IT practices at Lansing Community College.

Over his tenure spanning more than five decades, Rich Allen has served under seven college presidents and held various job titles, adapting to each new wave of technology. His expertise and collaborative spirit has helped countless colleagues, earning him deep respect within the Lansing community.

Rich's legacy is marked not only by his military service and professional accomplishments but also by his dedication to his family. He finds joy in spending time with his son and grandchildren, fishing, camping, and gardening—a testament to living a well-rounded life. It is with profound respect and gratitude that I recognize his service.

TRIBUTE TO JOHN GOODWIN

Mr. MULLIN. Mr. Speaker, I rise to honor John Goodwin, Councilmember and current Mayor of the Town of Colma, upon his retirement after 35 years of serving the public.

Mr. Goodwin was born in a small community near Denver, Colorado, in 1960. His love of the outdoors and passion for serving others led him to begin his career as a National Park Service law enforcement ranger. For 27 years, Mr. Goodwin worked in National Parks across the continental United States, traveling from the Rocky Mountains in Colorado, to Mount Rainier in Washington State, to the Everglades in Florida, and finally to Golden Gate National Recreation Area in the San Francisco Bay Area.

Mr. Goodwin's extensive career as a National Park Service ranger is emblematic of his commitment to helping others. He put his life on the line numerous times, saving many others in the process as well as nearly losing his own from two devastating lightning strikes. Mr. Goodwin endured the physical and mental costs of the dangers of his career, including a decade-long battle with post-traumatic stress disorder. However, with the help of his family and friends, Mr. Goodwin persevered, seeking treatment at the West Coast Post Trauma Retreat and continuing his mission to help others. He later documented many of his unforgettable stories in his memoir "Echoes of the Badge: Stories from a National Park Service Career" where he poignantly shared the joys and tribulations of his 27 years as a ranger.

In 2016, after retiring from the National Park Service, Mr. Goodwin decided to continue his career of public service by successfully running for an elected seat on Town of Colma City Council. Referred to as the "City of Souls," this small community just south of San Francisco is unique in that much of its land is dominated by cemeteries—the population of

the dead is speculated to outnumber the living by a ratio of one thousand to one. During his tenure as a councilmember, Mr. Goodwin embarked on numerous initiatives to cultivate the vitality of the town. He pushed for increased multi-cultural recreation events, supported public art projects, championed flag-raising to honor the diversity of the town's residents, and offered his unwavering support for local businesses. He additionally welcomed Colma's Veteran's Village with open arms, providing 65 units of housing for formerly homeless veterans and their families. Mr. Goodwin served as Mayor of Colma in 2020, where he worked tirelessly to protect his constituents and the town's local businesses during the height of the COVID-19 pandemic. In 2024, he again took office as Mayor, serving the town on the 100th anniversary of the town's incorporation.

Mr. Goodwin has also demonstrated exemplary community service outside of his official leadership positions in Colma. He has volunteered and raised thousands of dollars for various mental illness and veteran support organizations, including the Wounded Warrior Project, the National Alliance on Mental Illness, the American Foundation for Suicide Prevention, and for 9/11 survivors.

Mr. Speaker, I ask the entire House of Representatives to join me in honoring the extraordinary service to the public that John Goodwin has presented over his 35-year career. All of the lives that he has touched are better off through his dedication and commitment.

Mr. CORREA. Mr. Speaker, I rise today to recognize La Purisima Catholic Church, a pil-

lar of our community that has served parishioners in the City of Orange for the last century.

Established in 1924 on Center Street as La Purisima Mission, the church opened through the generous donation of Mr. Remedios Mares and originally served local residents and seasonal workers from Mexico. In October of 1957, La Purisima Mission came under the spiritual caretaking of the Missionary Servants of the Most Holy Trinity, who oversaw the mission's growth partly due to the influx of new residents to the area from Orange's burgeoning aerospace industry. This period also saw an expansion of services provided to local residents, including the first "Fiestas" beginning in 1958 and the parochial school opened by Sisters of the Company of Mary in 1964.

In 1962, La Purisima's "old church" building was constructed. It was in this building where La Purisima was granted Parish status on May 8, 1964, by the Archdiocese of Los Angeles. La Purisima would join the newly formed Diocese of Orange on June 18, 1976.

The growth of Vietnamese and Hispanic American communities in and around the parish of La Purisima led to some of the first trilingual liturgies in the Diocese of Orange. Due to the popularity of the trilingual liturgies and the growth of the community at La Purisima, parishioners received permission in 1999 to begin efforts to build a larger church building that remains in use today, dedicated on June 4, 2005, by Bishop Tod Brown.

This year the La Purisima Catholic Church celebrates its 100th anniversary, a testament to its commitment to service in the community.

I ask my colleagues to join me in recognizing La Purisima Catholic Church's 100 years of service to the residents of the City of Orange, and in wishing them a bright future of faith and service.
