**Measures Introduced:** Thirteen bills and five resolutions were introduced, as follows: S. 2–3, 5639–5649, and S. Res. 938–942. **Page S7332**

**Counter-UAS Authority Extension Act:** Senate passed S. 5639, to extend the authority for the protection of certain facilities and assets from unmanned aircraft. **Pages S7252–53**

**Truth and Healing Commission on Indian Boarding School Policies Act:** Senate passed S. 1723, to establish the Truth and Healing Commission on Indian Boarding School Policies in the United States, after withdrawing the committee amendment in the nature of a substitute, and agreeing to the following amendment proposed thereto: **Pages S7254–67**

Schatz Amendment No. 3351, in the nature of a substitute. **Page S7261**

**Women's Suffrage National Monument Location Act:** Senate passed H.R. 1318, to authorize the location of a monument on the National Mall to commemorate and honor the women's suffrage movement and the passage of the 19th Amendment to the Constitution. **Pages S7274–75**

**General George C. Marshall House:** Senate passed S. 3195, to designate the General George C. Marshall House, in the Commonwealth of Virginia, as an affiliated area of the National Park System, after agreeing to the committee amendment in the nature of a substitute. **Pages S7275–76**

**Recognizing the Importance of Critical Minerals in Healthcare Act:** Committee on Energy and Natural Resources was discharged from further consideration of H.R. 6395, to amend the Energy Act of 2020 to require the Secretary of the Interior to in-

clude the Secretary of Health and Human Services in consultations regarding designations of critical minerals, elements, substances, and materials, and the bill was then passed. **Page S7276**

**Resiliency for Ranching and Natural Conservation Health Act:** Senate passed S. 1553, to amend the Federal Land Policy and Management Act of 1976 to improve the management of grazing permits and leases, after agreeing to the committee amendment in the nature of a substitute. **Page S7276**

**Clifton Opportunities Now for Vibrant Economic Yields Act:** Committee on Energy and Natural Resources was discharged from further consideration of H.R. 2997, to direct the Secretary of the Interior to convey to Mesa County, Colorado, certain Federal land in Colorado, and the bill was then passed. **Pages S7276–77**

**Jackie Robinson Ballpark National Commemorative Site Act:** Senate passed H.R. 8012, to establish the Jackie Robinson Ballpark National Commemorative Site in the State of Florida. **Pages S7287–88**

**Holcombe Rucker Park National Commemorative Site Act:** Committee on Energy and Natural Resources was discharged from further consideration of H.R. 6852, to designate Holcombe Rucker Park, in Harlem, New York, as a National Commemorative Site, and the bill was then passed. **Pages S7287–88**

**Wyoming Public Lands Initiative Act:** Senate passed S. 1348, to redesignate land within certain wilderness study areas in the State of Wyoming, after agreeing to the committee amendment in the nature of a substitute. **Pages S7288–97**

**Malheur Community Empowerment for the Owyhee Act:** Senate passed S. 1890, to provide for the establishment of a land health management program on Federal land in Malheur County, Oregon, **D1177**

after agreeing to the committee amendment in the nature of a substitute, and the committee amendment to the title.

***Gabriella Miller Kids First Research Act 2.0:*** Committee on Health, Education, Labor, and Pensions was discharged from further consideration of H.R. 3391, to extend the Gabriella Miller Kids First Pediatric Research Program at the National Institutes of Health, and the bill was then passed.

***Social Security Fairness Act:*** By 76 yeas to 20 nays (Vote No. 338), Senate passed H.R. 82, to amend title II of the Social Security Act to repeal the Government pension offset and windfall elimination provisions, by the order of the Senate of Friday, December 20, 2024, 60 Senators having voted in the affirmative, and after taking action on the following motions and amendments proposed thereto:

#### Rejected:

By 3 yeas to 93 nays (Vote No. 333), Paul Amendment No. 3346, to adjust the normal and early retirement ages for Social Security benefits and increase the maximum age for delayed retirement credits. (Pursuant to the order of Friday, December 20, 2024, the amendment having failed to achieve 60 affirmative votes, was not agreed to.)

By 28 yeas to 67 nays (Vote No. 334), Paul Amendment No. 3352, to provide for automatic continuing resolutions. (Pursuant to the order of Friday, December 20, 2024, the amendment having failed to achieve 60 affirmative votes, was not agreed to.)

By 32 yeas to 64 nays (Vote No. 335), Cruz Amendment No. 3360, in the nature of a substitute. (Pursuant to the order of Friday, December 20, 2024, the amendment having failed to achieve 60 affirmative votes, was not agreed to.)

**Page S7304**

By 34 yeas to 62 nays (Vote No. 336), Crapo Amendment No. 3331, to delay the repeal of the Government pension offset and windfall elimination provisions until additional changes are made to offset any negative impacts on the actuarial balance of the Social Security Trust Funds. (Pursuant to the order of Friday, December 20, 2024, the amendment having failed to achieve 60 affirmative votes, was not agreed to.)

By 66 yeas to 30 nays (Vote No. 337), three-fifths of those Senators duly chosen and sworn, having voted in the affirmative, Senate agreed to the motion to waive all applicable sections of the Congressional Budget Act of 1974 and applicable budget points of order for purposes of the pending measure. Subsequently, the point of order, pursuant to Section 311(a)(3) of the Congressional Budget Act of 1974, that the pending measure would cause an increase of \$197.81 billion in the level of Social Security deficits relative to the levels deemed for budget enforcement, was not sustained, and the point of order fell.

***American Relief Act:*** By 85 yeas to 11 nays (Vote No. 339), Senate passed H.R. 10545, making further continuing appropriations for the fiscal year ending September 30, 2025, by the order of the Senate of Friday, December 20, 2024, 60 Senators having voted in the affirmative.

***D.C. Robert F. Kennedy Memorial Stadium Campus Revitalization Act:*** Senate passed H.R. 4984, to amend the District of Columbia Stadium Act of 1957 to provide for the transfer of administrative jurisdiction over the Robert F. Kennedy Memorial Stadium Campus to the Administrator of General Services and the leasing of the Campus to the District of Columbia for purposes which include commercial and residential development.

***Taxpayer Resources Used in Emergencies Accountability Act:*** Senate passed S. 5098, to require certain agencies to develop plans for internal control in the event of an emergency or crisis, after agreeing to the committee amendment in the nature of a substitute.

***Government Service Delivery Improvement Act:*** Senate passed H.R. 5887, to amend chapter 3 of title 5, United States Code, to improve Government

service delivery, and build related capacity for the Federal Government. **Page S7313**

**SAFE Orbit Act:** Committee on Commerce, Science, and Transportation was discharged from further consideration of S. 3658, to promote space situational awareness and space traffic coordination and to modify the functions and leadership of the Office of Space Commerce, and the bill was then passed, after agreeing to the following amendment proposed thereto: **Pages S7314–15**

Schumer (for Cornyn) Amendment No. 3362, in the nature of a substitute. **Page S7314**

**Marine Debris Act:** Senate passed S. 5649, to amend the Marine Debris Act to improve the administration of the Marine Debris Program of the National Oceanic and Atmospheric Administration, to improve the administration of the Marine Debris Foundation. **Pages S7315–16**

**Think Differently Database Act:** Senate passed H.R. 670, to amend title IV of the Public Health Service Act to direct the Secretary of Health and Human Services to establish a clearinghouse on intellectual disabilities. **Page S7316**

**Henry Parham VA Clinic:** Committee on Veterans' Affairs was discharged from further consideration of H.R. 4955, to name the community-based outpatient clinic of the Department of Veterans Affairs in Monroeville, Pennsylvania, as the "Henry Parham VA Clinic", and the bill was then passed. **Page S7316**

**Duane E. Dewey VA Clinic:** Committee on Veterans' Affairs was discharged from further consideration of H.R. 8667, to rename the community-based outpatient clinic of the Department of Veterans Affairs in Cadillac, Michigan, as the "Duane E. Dewey VA Clinic", and the bill was then passed. **Page S7316**

**Louis A. Conter VA Clinic:** Committee on Veterans' Affairs was discharged from further consideration of H.R. 9124, to name the Department of Veterans Affairs community-based outpatient clinic in Auburn, California, as the "Louis A. Conter VA Clinic", and the bill was then passed. **Page S7316**

**U.S. Congressman Sam Johnson Memorial VA Clinic:** Committee on Veterans' Affairs was discharged from further consideration of H.R. 4136, to name the Department of Veterans Affairs community-based outpatient clinic in Plano, Texas, as the "U.S. Congressman Sam Johnson Memorial VA Clinic", and the bill was then passed. **Page S7316**

**Protecting America's Children by Strengthening Families Act:** Committee on Finance was discharged from further consideration of H.R. 9076, to reauthorize and modernize part B of title IV of the So-

cial Security Act to strengthen child welfare services, expand the availability of prevention services to better meet the needs of vulnerable families, and the bill was then passed. **Page S7317**

**FISHES Act:** Committee on Commerce, Science, and Transportation was discharged from further consideration of H.R. 5103, to require the Director of the Office of Management and Budget to approve or deny spend plans within a certain amount of time, and the bill was then passed. **Page S7317**

**Keeping Military Families Together Act:** Senate concurred in the amendments of the House of Representatives to S. 2181, to amend title 38, United States Code, to extend the entitlement to memorial headstones and markers for commemoration of veterans and certain individuals and to extend authority to bury remains of certain spouses and children in national cemeteries. **Page S7313**

**Pro Forma Sessions—Agreement:** A unanimous-consent agreement was reached providing that the Senate adjourn, to then convene for pro forma sessions only, with no business being conducted, on the following dates and times, and that following each pro forma session, the Senate adjourn until the next pro forma session: Monday, December 23, 2024, at 9:30 a.m.; Thursday, December 26, 2024, at 2:30 p.m.; Monday, December 30, 2024, at 12:30 p.m.; Thursday, January 2, 2025, at 12 noon; and Friday, January 3, 2025, at 11:45 a.m.; and that when the Senate adjourns following the Friday, January 3, 2025 pro forma session, it stand Sine Die, and next convene at 12 noon, on Friday, January 3, 2025, pursuant to the Constitution. **Page S7347**
