Mr. RULLI. Mr. Speaker, I rise today along with my colleague, The Honorable TROY BALDERSON, to congratulate the Indian Valley Braves on their victory over the Sandusky Perkins Pirates in the 2024 Ohio High School Athletic Association Division IV Football State Championship.

Attendance topped 7,000 in Tom Benson Hall of Fame Stadium that Saturday night, December 7, 2024. Amidst freezing and rainy conditions, the Perkins Pirates scored first to lead 7-0. The Braves responded with a touchdown but missed the extra point making the game 7-6. On the following kickoff, Sandusky Perkins fumbled, and Indian Valley recovered. They capitalized by driving down the field for a touchdown and successfully executed a two-point conversion pulling ahead 14-7. This back-and-forth battle characterized the game as neither team punted all night.

Heading into the fourth quarter, Indian Valley trailed Sandusky Perkins 36-29. The Braves drove back down the field and scored their fifth rushing touchdown of the game making the score 36-35. They took a risk by trying for a two-point conversion and were successful. The Braves' defense held strong and forced a turnover with just over four minutes of regulation left to play. They ran out the clock to clench the win with the final score reading 37-36.

This Division IV state final was historic as it marked the Braves' first football state championship in school history as well as the first for a Tuscarawas County school. The team finished with an overall record of 16-0 in the regular season and 5-0 in conference.

I ask my colleagues in the United States House of Representatives to join me in congratulating the Indian Valley Braves' players, coaches, staff, families, and friends as we cel-

brate this victory of an undefeated season and a state championship title. Go Braves.

### HONORING THE LIFE AND LEGACY OF REV. DR. WILLIAM R. SAUNDERS

Ms. SLOTKIN. Mr. Speaker, today I honor the remarkable life and legacy of Rev. Dr. William R. Saunders, a trailblazer who broke barriers as the first Black full-time chaplain in a correctional institution in the United States. His steadfast commitment to faith and community left a profound impact on Michigan and beyond.

Born in Selma, North Carolina in 1917, William Saunders dedicated his life to ministry and service. He earned a Bachelor of Theology degree from Lynchburg Theological Seminary and College in Virginia, pursued further studies at Hartford Seminary in Connecticut, and was later awarded an honorary doctorate from Temple University in Illinois.

He became a minister of the gospel and was ordained in 1941 by the late Doctor A.B. Johnson, Superintendent of Missions of the General Baptist State Convention of North Carolina. In 1948, he made his way to Michigan, where he served as Assistant Minister of Second Baptist Church in Detroit. It was during this period of his life, in 1952, that he married his beloved wife, Mary E. Debnam.

Two years later, in April 1950, Rev. Saunders made history when he was appointed Chaplain of the State Prison of Southern Michigan. His tenure spanned 34 years, working under eight wardens and alongside twelve other chaplains before retiring in 1985. In a role defined by his compassion and resolve, Chaplain Saunders ministered to incarcerated individuals, offering guidance, spiritual support, and hope for renewal.

Rev. Saunders' influence extended far beyond the prison walls. He founded and pastored Southside Baptist Church in Jackson, Michigan, and held leadership roles with numerous community organizations. He served as President of Family Service, President of Potential Developmental Homes, Inc., and Board Member of the Inner City Child Day Care Center. A committed civic leader, he was an active member of the NAACP, Civitan International, and the Jackson County Ministerial Association, where he served as Treasurer. His dedication to public service earned him recognition from President Gerald Ford for his contributions as a member of the United States Draft Board.

A passionate advocate for youth and education, Rev. Saunders supported the Boy Scouts of America and served on the Jackson Public School Advisory Committee, where he helped empower generations of young leaders.

Rev. Saunders' decades of tireless efforts to uplift others exemplified his compassion, integrity, and dedication to service. Though he passed away in 1987, his values live on through his three children, Theresa, William, and Anne (Percy Brown), as well as his two grandchildren, Jason and Haile.

HONORING DEPUTY JIM LAU

Mr. EDWARDS. Mr. Speaker, it is with sorrow and gratitude that I rise today to honor the life of Deputy Charles James "Jim" Lau for his service to our country and community as a security officer at the Macon County Courthouse in Western North Carolina. Jim drowned in the floodwaters of Hurricane Helene and was found dead on September 28.

Jim lived a life dedicated to public service in every role he undertook. Jim served in the U.S. Air Force, rising to the rank of Master Sergeant and fighting in the Vietnam War, before beginning his successful career in law enforcement.

As a member of the Volusia County Sheriff's Office in Florida, Jim spent over 20 years working as a deputy, working primarily in the Major Case and Crime Scene units and pioneered a crime scene program which trained hundreds of deputies.

Jim was described by the Sheriff's Office as a hard worker, dependable and was well-liked. After full retirement from the police force in 2005, Jim moved with his then wife Millie to Franklin, North Carolina to be closer to family; Millie died in 2007 after a battle with breast cancer.

Even in his retirement, Jim felt called to serve others and chose to serve his community as a volunteer with REACH of Macon County, a domestic violence, rape crisis, and human trafficking center, and as a security officer at the Macon County Courthouse.

On Friday, September 27, Jim showed up to work to serve the people of Macon County amidst the devastation of Hurricane Helene, with the worst storm conditions Western North Carolina has seen in recorded history. Jim was reported missing after he failed to return from lunch and his body was found in his truck, still trapped in the floodwater, the following day.

Jim was known as a family man and loved nothing more than being a grandfather. Jim leaves behind his wife, Judie; children, Kimberly, Destiny, Cameron, Brittany and Tyler; and many grandchildren and extended relatives.

After decades of working to protect others, Jim made the world a better and safer place, and I thank him for his lifetime of public service. I offer my deepest condolences to the Lau family and will continue to keep them in my thoughts and prayers.

"Sister Bernie" came into the world on December 8, 1938. She was born in Boston,

Massachusetts, and raised in Massachusetts. Her Catholic faith and interest in caring for others resulted in her joining the Medical Missionaries of Mary at age 19. She went to study nursing at Ireland's Lady of Lourdes Hospital.

After completing her training as a nurse and midwife, she served several missions in Africa, which included stints in Tanzania, Ethiopia and the Central African Republic.

In 1978, Sister Kenny moved to Southwest Virginia. Soon thereafter, she founded the Health Wagon in Norton, Virginia.

Southwest Virginia is a sprawling rural area, and access to health care services has always been a challenge for the local communities. For many people, it takes hours of driving to simply reach a hospital.

Sister Kenny founded the Health Wagon to address this challenge head on. The Health Wagon consisted of a Volkswagen Beetle filled with medical tools and supplies. Sister Kenny traveled in her Beetle throughout the coalfields region to meet the health care needs of the local communities.

She administered services to struggling residents free of charge in her quest to heal their bodies as well as heal their souls. She underscored the emotional aspects to health care, saying "in most health care the emotional part is ignored." She added: "health care is social; it's a way of identifying what's inside a person."

Thanks to Sister Kenny's support, the Remote Area Medical (RAM) project, a popular and overwhelmingly successful venture that delivers free health care to various underserved communities in America, has hosted clinics in Southwest Virginia.

Because of Sister Kenny's strong leadership and fierce advocacy, the Health Wagon has sustained operations to this very day. The group takes pride in providing compassionate, quality health care to the medically underserved people in the mountains of Appalachia.

The indispensable endeavor to deliver vital health care to Appalachian communities, including the region's coal miners, would not have been so emphasized today if it were not for Sister Kenny. I join the people of Southwest Virginia and all of Appalachia in mourning her loss, but the lasting impact she had on the region will forever be cherished.

As director of operations at the Madison County Detention Center, which includes Madison Juvenile Detention Center, Michelle was known for her positive influence on inmates and as a source of comfort and strength for young people.

Michelle's family and friends described her as a second mother to juvenile inmates, employees, and members of her community, even bringing juvenile inmates Christmas presents, making sure no one felt left out. On the morning of Friday, September 27, in the midst of Helene's destruction, Michelle thought only of serving others and attempted to get to work from her home in Yancey County.

Michelle was quickly surrounded by the rising flood waters after going outside to enter her car and became caught in the current; Michelle's neighbor, Chris Robinson, jumped into the flood water and made attempts to save Michelle's life but she was fatally injured by the falling trees and waves of debris in the water. Michelle was 48 years old. Michelle made a lasting impact on the law enforcement community and on those who were lucky enough to know her.

The Division of Juvenile Justice and Delinquency Prevention of the North Carolina Department of Public Safety posthumously awarded Michelle the Raising of the Bar award, for her lifetime of public service and going above and beyond to help create better outcomes for incarcerated youth.

Michelle spent nearly 18 years working at the sheriff's office and came from a family dedicated to public service. Michelle leaves behind the love of her life and husband, Isaac Quintero; daughter, Ashlyn Quintero; son, Isaac Quintero; and many extended family members.

I thank Michelle for her contributions to Western North Carolina and for the positive influence and safe environment she provided for youth in her care.

I offer my deepest condolences to the Quintero family. I will continue to keep them and their loved ones in my thoughts and prayers. Michelle will be remembered for her lifetime of service and in every life she touched.

#### RECOGNIZING MARK R. BAKER

Mr. GRAVES of Missouri. Mr. Speaker, it is my privilege to recognize Mark R. Baker, who is retiring after more than a decade of distinguished service as the President and Chief Executive Officer of the Aircraft Owners and Pilots Association.

Mark's leadership in support of the general aviation community has been invaluable to hundreds of thousands of pilots and aircraft owners and the endeavors they support through flight. His unwavering commitment to promoting and protecting the freedom to fly—a freedom truly unique to the United States—has helped facilitate the wide range of general aviation flight missions, including business, disaster relief, philanthropy, and personal transportation.

Mark has been the most impactful leader in AOPA's 85-year history, serving as a tireless and effective advocate for general aviation. He has consistently provided legislators and regulators with valuable insights on important issues such as medical certification reform, strengthening our national network of airports, aviation and education career opportunities for youth, advancing flight deck technology, ensuring fair and transparent pricing for pilots, and improving aviation safety. Among the important legislation he has helped shape is the very first general aviation title in an FAA reauthorization bill, setting an important precedent for the future.

Mark's passion for aviation began as a child growing up in Minnesota, when he and his younger brothers, Scott and Jim, rode their bicycles to the local airport to watch airplanes and take penny-a-pound airplane rides. He took a ground school class in high school and earned his private pilot certificate soon after. Flight instructor Waldo Anderson, who is now 90 years old and still flying, mentored and inspired Mark as he worked to earn additional pilot certificates and ratings.

As a teenager just starting college, Mark found additional mentors in his employers, Knox Lumber founders Don DeCoster, Larry Platt, and Mel Maurer. The World War II veterans quickly recognized Mark's strong work ethic, which he learned from parents Ralph and Bev. Taking him under their wing, the trio soon taught Mark the ins and outs of retail lumber, laying the groundwork for his future business success in the home improvement industry.

After leaving Knox, Mark held leadership roles with Payless Cashways, Scotty's, and Home Base before joining Home Depot in that company's formative years. While at Home Depot, Mark held numerous executive positions, including Chief Operating Officer, and continued to build deep and lasting relationships throughout the home improvement vendor and real estate communities, helping to drive large-scale growth for his company and the industry. He even used his flying skills, and both personal and business aircraft, to help identify locations for hundreds of new stores nationwide.

Mark has held numerous other influential positions, including Chief Operating Officer at Scotts Miracle-Gro Company, President and Chief Executive Officer at outdoor outfitter Gander Mountain, and Chief Executive Officer at Orchard Supply Hardware.

Recognizing the important role of mentors in his own life, Mark has generously mentored hundreds of pilots, providing access to aircraft, instructors, and opportunities to fly, as well as sharing the wisdom he has gained in more than 10,000 hours at the controls. In that same spirit, he launched the You Can Fly program at AOPA, which has so far provided free aviation STEM curriculum to more than 100,000 high school students nationwide.

Mark's commitment to creating opportunities for young people is matched only by his commitment to his family, including his wife JoAnn; his four children, Lindsay, Kristine, Shannon, and Andrew; his sons-in-law Pete and Alex; and his eight grandchildren.

As Mark prepares to retire from AOPA, I wish him well in all his endeavors and thank him for his service to the aviation community and the Nation. I am confident he will continue to mentor the next generation of aviators as a passionate and influential advocate for GA.
