INFORMING CONGRESS OF THE DEATH OF JAMES EARL CARTER, JR., THE 39TH PRESIDENT OF THE UNITED STATES—MESSAGE FROM THE PRESIDENT OF THE UNITED STATES

The SPEAKER pro tempore laid before the House the following message from the President of the United States; which was read:

To the Congress of the United States:

By this Message, I officially inform you of the death of James Earl Carter, Jr., the thirty-ninth President of the United States.

President Carter was a man of character, courage, and compassion, whose lifetime of service defined him as one of the most influential statesmen in our history. He embodied the very best of America: A humble servant of God and the people. A heroic champion of global peace and human rights, and an honorable leader whose moral clarity and hopeful vision lifted our Nation and changed our world.

The son of a farmer and a nurse, President Carter's remarkable career in public service began in 1943 as a cadet at the United States Naval Academy. He later served in both the Atlantic and Pacific fleets before becoming a decorated lieutenant, and being selected to join the elite nuclear submarine program.

After his father died, he shifted from active duty to the Navy Reserve and returned home to Plains, Georgia, to help manage his family's peanut farm. He worked hard stewarding the land while leading his community as a

church deacon, Sunday school teacher, and board member of a hospital and library. His deep faith inspired a passion for public service that led him to be elected State Senator, Georgia's 76th Governor, and ultimately President of the United States.

As President, he understood that Government must be as good as its people—and his faith in the people was boundless just as his belief in America was limitless and his hope for our common future was perennial.

With President Carter's leadership, the modern Department of Education and the Department of Energy were created. He championed conservation and his commitment to a more just world was at the heart of his foreign policy, leading on nuclear nonproliferation, signing the Panama Canal treaties, and mediating the historic 1978 Camp David Accords. His partnership with Vice President Walter Mondale is one that future administrations strived to achieve.

Following his Presidency, President Carter advanced an agenda that elevated the least among us. Guided by an unwavering belief in the power of human goodness and the God-given dignity of every human being, he worked tirelessly around the globe to broker peace; eradicate disease; house the homeless; and protect human rights, freedom, and democracy.

Through his extraordinary moral leadership, President Carter lived a noble life full of meaning and purpose. And as a trusted spiritual leader, he shepherded people through seasons of pain and joy, inspiring them through the power of his example and healing them through the power of his guidance.

As we mourn the loss of President Carter, we hold the memory of his beloved Rosalynn, his wife of over 77 Years, close in our hearts. Exemplifying hope, warmth, and service, she and her husband inspired the Nation. The love Rosalynn and President Carter shared is the definition of partnership, and their devotion to public service is the definition of patriotism.

May President Carter's memory continue to be a light pointing us forward. May we continue to be guided by his spirit in our Nation and in our world.

H.R. 9549. To designate the facility of the United States Postal Service located at 125 South 1st Avenue in Hillsboro, Oregon, as the "Elizabeth Furse Post Office Building".

H.R. 1555. To designate the facility of the United States Postal Service located at 2300 Sylvan Avenue in Modesto, California, as the "Corporal Michael D. Anderson Jr. Post Office Building".

H.R. 9580. To designate the facility of the United States Postal Service located at 2777 Brentwood Road in Raleigh, North Carolina, as the "Millie Dunn Veasey Post Office".

H.R. 1823. To designate the facility of the United States Postal Service located at 207 East Fort Dade Avenue in Brooksville, Florida, as the "Specialist Justin Dean Coleman Memorial Post Office Building".

H.R. 9592. To amend title 44, United States Code, to modernize the Federal Register, and for other purposes.

H.R. 2997. To direct the Secretary of the Interior to convey to Mesa County, Colorado, certain Federal land in Colorado, and for other purposes.

H.R. 9600. To designate the facility of the United States Postal Service located at 119 Main Street in Plains, Georgia, as the "Jimmy and Rosalynn Carter Post Office".

H.R. 3354. To designate the facility of the United States Postal Service located at 220 North Hatcher Avenue in Purcellville, Virginia, as the "Secretary of State Madeleine Albright Post Office Building".

H.R. 9775. To designate the facility of the United States Postal Service located at 119 North Anderson Street in Elwood, Indiana, as the "Officer Noah Jacob Shahnavaz Post Office Building".

H.R. 3391. To extend the Gabriella Miller Kids First Pediatric Research Program at the National Institutes of Health, and for other purposes.

H.R. 10065. To designate the facility of the United States Postal Service located at 802 North Tanchua Street in Corpus Christi, Texas, as the "Captain Robert E. 'Bob' Batterson Post Office".

H.R. 4136. To name the Department of Veterans Affairs community-based outpatient clinic in Plano, Texas, as the "U.S. Congressman Sam Johnson Memorial VA Clinic".

H.R. 4955. To name the community-based outpatient clinic of the Department of Veterans Affairs in Monroeville, Pennsylvania, as the "Henry Parham VA Clinic".

H.R. 4984. To amend the District of Columbia Stadium Act of 1957 to provide for the transfer of administrative jurisdiction over the Robert F. Kennedy Memorial Stadium Campus to the Administrator of General Services and the leasing of the Campus to the District of Columbia for purposes which include commercial and residential development, and for other purposes.

H.R. 5103. To require the Director of the Office of Management and Budget to approve or deny spend plans within a certain amount of time, and for other purposes.

H.R. 5443. To establish a policy regarding appraisal and valuation services for real property for a transaction over which the Secretary of the Interior has jurisdiction, and for other purposes.

H.R. 5867. To designate the facility of the United States Postal Service located at 109 Live Oaks Boulevard in Casselberry, Florida, as the "Colonel Joseph William Kittinger II Post Office Building".

H.R. 5887. To amend chapter 3 of title 5, United States Code, to improve Government service delivery, and build related capacity for the Federal Government, and for other purposes.

H.R. 6062. To restore the ability of the people of American Samoa to approve amendments to the territorial constitution based on majority rule in a democratic act of self-determination, as authorized pursuant to an Act of Congress delegating administration of Federal territorial law in the territory to the President, and to the Secretary of the Interior under Executive Order 10264, dated June 29, 1951, under which the Constitution of American Samoa was approved and may be amended without requirement for further congressional action, subject to the authority of Congress under the Territorial Clause in article IV, section 3, clause 2 of the United States Constitution.

H.R. 6116. To designate the facility of the United States Postal Service located at 14280 South Military Trail in Delray Beach, Florida, as the "Benjamin Berell Ferencz Post Office Building".

HONORING THE LIFE AND LEGACY OF SENATOR RICHARD F. COLBURN

Mr. HARRIS. Mr. Speaker, this past Friday I learned with great sadness about the passing of Senator Richard Colburn, a dedicated public servant and an Eastern Shore patriot who devoted his life to the service and betterment of the people of the State of Maryland.

Senator Colburn and I served together in the Maryland State Senate. He arrived to the Maryland General Assembly first as a State Delegate about sixteen years prior to my being elected to the Maryland Senate in 1999. By that time, Rich Colburn had already been serving as a State Senator for four years. He quickly became my mentor, dear colleague, and a trusted friend. For a period, Rich and I served on the Education, Health and Environmental Affairs Committee. As a devoted Eastern Shoreman and a son of a waterman, Senator Colburn knew how crucial it is for the government to be accountable, transparent, honest, and helpful to its citizens. As such, he made constituent casework and assisting his fellow Marylanders his top priority.

As a “Shore Senator,” Rich fought on behalf of his constituents with fervor and purpose. During his time in the legislature, he introduced hundreds of bills, at times reaching across the aisle to promote projects and priorities he believed would benefit the Shore. One of his greatest accomplishments was the multi-decade battle led to his securing over \$60 million to replace the Dover Bridge; a vital artery connecting Southern Caroline and Talbot Counties on the Eastern Shore. The bridge finally opened in 2018 with great fanfare. Among his many other accomplishments was his success in the preservation of the Easton hospital, widening U.S. Route 50, increasing benefits for veterans and law enforcement, and obtaining funding for restoration of the Chesapeake Bay’s oyster population. He advocated for businesses and tourism on the Shore to lift and support the local economy by helping provide funding for the Choptank River Lighthouse and bringing in the Hyatt hotel to Cambridge, among others.

Richard Franklin Colburn was born on February 9, 1950 and grew up in Oxford, Maryland. After graduating from the Easton High School, Rich served in the United States Army Security Agency posted in Germany during the height of the Cold War. He left after three years with the Army, achieving the rank of Sergeant. After his return to Maryland, he worked in private practice. He was elected to the House of Delegates in 1983, where he served until 1991 before he ascended to the State Senate in 1995. Senator Colburn became the longest serving Republican Senator

in the Senate. After his service in elected office, he served as Special Assistant to Agriculture Secretary Joe Bartenfelder under Governor Larry Hogan. His district included the counties of Caroline, Dorchester, Talbot and Wicomico.

Senator Richard Colburn passed away suddenly on Friday, December 27, 2024, in Easton at the age of 74 years old. I would like to express my sincere condolences to his loving wife Alma, daughter Johanna Hamilton (Bobby), granddaughter Saylor and sister Marie, as well as the entire extended Colburn family and friends. The Eastern Shore is forever grateful for Senator Colburn's commitment to service and his dedication to Maryland.

Mr. GRIFFITH. Mr. Speaker, I rise to honor Mr. Marvin Dennis Reaser, Jr., who passed away on August 20 at the age of 84. Mr. Reaser was a talented musician and beloved band director whose career spanned over 30 years in Salem, Virginia, most notably leaving a lasting impact on Salem High School.

Mr. Reaser was born on July 28, 1940, in Nitro, West Virginia. His parents, Artie Lda Shomo and Marvin Dennis Reaser, Sr., raised him in St. Albans, West Virginia, with a very modest family lifestyle.

Music remained a necessity for the Reaser household, with piano lessons being a requirement for Mr. Reaser, his sister, Sally, and his brother, David. During his tenure at St. Albans Jr. High, Mr. Reaser played in the High School Band, which was directed by Alan Farley. Mr. Farley saw something remarkable about Mr. Reaser's musical ability and would not soon forget his four-year impact on the school.

Mr. Reaser then enlisted in the United States Navy after attending one year of college. He served for four years in the Navy, from Africa to Saudi Arabia, playing his trumpet for the Navy Band. Upon Mr. Reaser's return from his service overseas, he landed two teaching jobs as band director for two different

high schools, notably without a college degree—a testament to his skill and talent.

By 1968, Mr. Reaser earned his undergraduate degree from Morris Harvey College (now University of Charleston) in Charleston, West Virginia. This same year, his former high school band director, Mr. Farley, who had been working at Andrew Lewis High School in Salem, VA, reached out to Mr. Reaser asking for him to apply to the Band Director job there. After landing the job one year later, Mr. Reaser joined a team that would shape his career for the next 30 years. With Mr. Reaser's directing style closely mirroring what he had learned from the United States Navy, the award-winning Andrew Lewis High Band was widely known for their student-led governance with emphasis on excellence and hard work.

When Andrew Lewis HS closed and its students were merged into Salem High School (Salem, VA), he became the band leader there.

Mr. Reaser, throughout his tenure as a band director, participated in a number of complementary pursuits, such as playing trumpet for gigs in the surrounding areas of Southwest Virginia, authoring a book, and even earning his master's degree in music composition from Radford University.

In 2001, Mr. Reaser earned a key to the city from the Salem City Council, marking his retirement from Salem City Schools on a day that was dubbed "Dennis Reaser Day" by the City of Salem. However, he knew he had more to teach and went on to work as a band director for the Hargrave Military Academy for three years and then assistant principal for First Flight High School for over 10 years.

Mr. Reaser retired for good in 2015 and spent the remainder of his life composing and arranging music, playing in community bands and surrounding himself with his family and friends. Mr. Reaser unfortunately was diagnosed with Parkinson's Disease in his final seven years, but always stayed ahead of his disease, averaging five to ten thousand steps per day instead of allowing the symptoms to overcome him.

While I was never a member of the Andrew Lewis High School marching band as a student there, I was proud to know Mr. Reaser and admired his work both with the marching band and all the other programs, particularly the annual Opus.

Mr. Marvin Dennis Reaser, Jr. was a true example of someone who delivers excellence

to communities with his passion for music. He will be remembered for his outstanding work as a teacher, a veteran, and family man.
