The rule further provides for consideration of H.R. 881, the “DHS Restrictions on Confucius Institutes and Chinese Entities of Concern Act”, under a closed rule. The rule waives all points of order against consideration of the bill. The rule provides that in lieu of the amendment in the nature of a substitute recommended by the Committee on Homeland Security now printed in the bill, an amendment in the nature of a substitute consisting of the text of Rules Committee Print 119–2 shall be considered as adopted and the bill, as amended, shall be considered as read. The rule waives all points of order against provisions in the bill, as amended. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Homeland Security or their respective designees. The rule provides one motion to recommit. Testimony was heard from Representatives Hageman, Hoyle of Oregon, Pfluger, and Thompson of Mississippi.
