Res. 88, providing congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Environmental Protection Agency relating to “California State Motor Vehicle and Engine Pollution Control Standards; Advanced Clean Cars II; Waiver of Preemption; Notice of Decision”, after agreeing to the motion to proceed. **Page S3101**

California State Motor Vehicle and Engine Pollution Control Standards: By 51 yeas to 45 nays (Vote No. 279), Senate passed H.J. Res. 87, providing congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Environmental Protection Agency relating to “California State Motor Vehicle and Engine Pollution Control Standards; Heavy-Duty Vehicle and Engine Emission Warranty and Maintenance Provisions; Advanced Clean Trucks; Zero Emission Airport Shuttle; Zero-Emission Power Train Certification; Waiver of Preemption; Notice of Decision”, after agreeing to the motion to proceed. **Pages S3102–05**
