Committee on Rules: Full Committee held a hearing on H.R. 275, the “Special Interest Alien Reporting Act of 2025”; H.R. 875, the “Jeremy and Angel Seay and Sergeant Brandon Mendoza Protect Our Communities from DUIs Act of 2025”; H.R. 3944, the “Military Construction, Veterans Affairs, and Related Agencies Appropriations Act, 2026”; and H. Res. 516, condemning the violent June 2025 riots in Los Angeles, California. The Committee granted, by a record vote of 8–4, a rule providing for consideration of H.R. 3944, the “Military Construction, Veterans Affairs, and Related Agencies Appropriations Act, 2026”, H.R. 275, the “Special Interest Alien Reporting Act of 2025”, H.R. 875, the “Jeremy and Angel Seay and Sergeant Brandon Mendoza Protect Our Communities from DUIs Act of 2025”, and H. Res. 516, Condemning the violent June 2025 riots in Los Angeles, California. The rule provides for consideration of H.R. 3944, the “Military Construction, Veterans Affairs, and Related Agencies Appropriations Act, 2026”, under a structured rule. The rule waives all points of order against consideration of the bill. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees. The rule provides that an amendment in the nature of a substitute consisting of the text of Rules Committee Print 119–5 shall be considered as adopted and the bill, as amended, shall be considered as read. The rule waives all points of order against provisions in the bill, as amended, for failure to comply with clause 2 of rule 21. The rule makes in order only those amendments printed in the Rules Committee report, amendments en bloc described in section 3, and pro forma amendments described in section 4. Each amendment shall be considered only in the order printed in the report, may be offered only by

a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment except as provided by section 4 of the rule, and shall not be subject to a demand for division of the question. The rule waives all points of order against the amendments printed in the Rules Committee report or amendments en bloc described in section 3 of the rule. The rule provides that the chair of the Committee on Appropriations or his designee may offer amendments en bloc consisting of amendments printed in the Rules Committee report not earlier disposed of. Amendments en bloc shall be considered as read, shall be debatable for 20 minutes equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees, shall not be subject to amendment except as provided by section 4 of the rule, and shall not be subject to a demand for division of the question. The rule provides that the chair and ranking minority member of the Committee on Appropriations or their respective designees may offer up to 10 pro forma amendments each at any point for the purpose of debate. The rule provides for one motion to recommit. The rule further provides for consideration of H.R. 275, the “Special Interest Alien Reporting Act of 2025”, under a closed rule. The rule waives all points of order against consideration of the bill. The rule provides that the amendment in the nature of a substitute recommended by the Committee on Homeland Security now printed in the bill shall be considered as adopted and the bill, as amended, shall be considered as read. The rule waives all points of order against provisions in the bill, as amended. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Homeland Security or their respective designees. The rule provides for one motion to recommit. The rule further provides for consideration of H.R. 875, the “Jeremy and Angel Seay and Sergeant Brandon Mendoza Protect Our Communities from DUIs Act of 2025”, under a closed rule. The rule waives all points of order against consideration of the bill. The rule provides that the amendment in the nature of a substitute recommended by the Committee on the Judiciary now printed in the bill shall be considered as adopted and the bill, as amended, shall be considered as read. The rule waives all points of order against provisions in the bill, as amended. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on the Judiciary or their

respective designees. The rule provides for one motion to recommit. The rule further provides for consideration of H. Res. 516, Condemning the violent June 2025 riots in Los Angeles, California, under a closed rule. The rule provides that upon adoption of this resolution it shall be in order without intervention of any point of order to consider H. Res. 516. The rule provides that the resolution shall be considered as read. Finally, the rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on the Judiciary or their respective designees.
