H.R. 42, to amend the Alaska Native Claims Settlement Act to exclude certain payments to aged, blind, or disabled Alaska Natives or descendants of Alaska Natives from being used to determine eligibility for certain programs. Signed on July 7, 2025. (Public Law 119–22)

H.R. 43, to amend the Alaska Native Claims Settlement Act to provide that Village Corporations shall not be required to convey land in trust to the State of Alaska for the establishment of Municipal

Corporations. Signed on July 7, 2025. (Public Law 119–23)
