HONORING WORLD WAR II VETERAN HARLAND J. HENNESSEY

Ms. STEFANIK. Mr. Speaker, I rise today to honor the life and posthumous return of United States Army Veteran Harland J. Hennessey.

Harland J. Hennessey was born on September 1, 1918. He attended Boonville High School where he was president of his eighth-grade class, played soccer, and appeared in school musicals and plays.

Hennessey left Boonville on May 27, 1941 to join the United States Army. He trained at Fort Jay on Governors Island and later at Fort Belvoir in Virginia. By December 1941 he was stationed at Fort Stotsenburg in the Philippines.

In 1942, he was serving with the 803rd Engineer Battalion when Japanese forces invaded the Philippine Islands. Heavy fighting led to the surrender of the Bataan Peninsula on April 9, 1942, and Corregidor Island on May 6, 1942. Hennessey was captured when U.S. forces in Bataan surrendered.

He and other POWs were forced to march 65 miles in the Bataan Death March and were later held at the Cabanatuan POW Camp No. 1. Hennessey died on November 1, 1942, at the age of 24. He was one of the first servicemen from the Boonville area to die in World War II. He was buried with other deceased prisoners in Common Grave 704 at the camp cemetery.

After the war, the American Graves Registration Service (AGRS) exhumed those buried at the Cabanatuan cemetery and moved the remains to a temporary U.S. military mausoleum near Manila. In 1947, AGRS examined the remains, identifying two sets from Common Grave 704 and declaring the other eight unidentifiable. These were buried as Unknowns at the Manila American Cemetery and Memorial (MACM).

In 2018, as part of the Cabanatuan Project, the Defense POW/MIA Accounting Agency exhumed the remains from Common Grave 704 for laboratory analysis. Using dental and anthropological evidence, circumstantial data, and mitochondrial DNA testing, scientists identified Hennessey's remains.

Though interred as an Unknown for more than 70 years, his grave was cared for by the American Battle Monuments Commission. He is honored on the Cabanatuan Memorial, built by survivors of the Bataan Death March and the Cabanatuan POW camp, and on the Walls of the Missing at MACM where a rosette will now mark that he has been accounted for.

VFW Post 5538 in Boonville bears Hennessey's name in honor of his incredible service to our country. After 84 years, his remains are set to return to his hometown where he will be buried in Boonville Cemetery.

RECOGNIZING JESSE DRAKE

Mrs. TORRES of California. Mr. Speaker, I rise today to honor Jesse Drake, a proud constituent of Montclair, California, for his courageous service during World War II and to celebrate his upcoming 101st birthday on September 24, 2025.

Mr. Drake was born on September 24, 1924. On June 6, 1942, he enlisted in the United States Navy at the age of 17. He went on to serve with distinction as a Petty Officer Second Class, participating in several major campaigns, including the Atlantic Invasion of North Africa and the pivotal battles of Iwo Jima and Okinawa in the Pacific Theater.

During the Okinawa campaign, Mr. Drake and his fellow sailors bravely endured a deadly kamikaze attack while aboard the USS *Hyman*, a Fletcher-class destroyer. The enemy strike hit the ship's torpedo tube, causing a devastating explosion in the engine room. Tragically, 12 sailors lost their lives and 40 were wounded. Mr. Drake survived the attack, and his colleagues note that his resilience has been a testament to the strength and sacrifice of the Greatest Generation. Mr. Drake was honorably discharged from the Navy on October 6, 1947. He was awarded the World War II Victory Medal and the Asiatic-Pacific Campaign Medal with two battle stars to honor his valor and dedication.

Not only is Mr. Drake highly regarded by those he served with, but he is also the beloved father of three daughters and two stepsons, a proud grandfather to 16 grandchildren, and a great-grandfather to 10 great-grandchildren. He has spent 43 years married to his devoted wife, Evelyn. His nephew, Ryan Page, describes him not only as a remarkable veteran but also as an extraordinary father figure whose impact continues to shape the lives of those around him.

For his outstanding military service and his remarkable life, it is my honor to recognize Jesse Drake. His commitments to his family and our Nation are worthy of the highest commendation.

HONORING THE 140TH ANNIVERSARY OF BETH SHALOM CONGREGATION

Mr. BERGMAN. Mr. Speaker, I rise today to recognize and celebrate the 140th anniversary

of Beth Shalom congregation. This historic synagogue, recognized as a state historical site, holds the distinction of being the oldest continuously operating synagogue in our state.

As the remote mill community of what would become Traverse City grew, three Jewish merchants—Julius Levinson, Julius Steinberg and Solomon Yalomstein—organized a congregation in 1882. It was Mr. Steinberg who originally purchased the land where the synagogue would be built, which initially served as a cemetery for the congregation's members. In 1885, the synagogue's first cornerstone was laid, and in March of 1886, the building was dedicated, marking the beginning of a lasting religious and cultural presence in Northern Michigan.

Over the following years, Beth Shalom congregation became not only a house of worship but also a beacon of service and advocacy. By the turn of the twentieth century, more than forty Jewish families were part of the community. Throughout the twentieth century, the congregation advocated for Jewish people across the world, helping a Jewish family fleeing Nazism in 1939 by raising funds for rescue and resettlement efforts. In 1970, the congregation campaigned on behalf of Jews persecuted in the Soviet Union, and in 1973, the congregation had its first woman president—symbolizing the synagogue's move towards gender equality.

Mr. Speaker, it is my distinct honor to commend Beth Shalom congregation on its 140th anniversary and for its unwavering support for the Jewish community across the globe. For well over a century, the congregation has stood as a pillar of faith, resilience, and community spirit. I offer my best wishes to the congregation as they continue their efforts to serve their neighbors and enrich the broader fabric of Northern Michigan.

Generations of employees passed through its doors, many starting as young people looking for summer jobs who went on to become teachers, medical professionals, engineers, and servicemembers.

Dave himself grew up helping run his family's Glen Motel and, with little restaurant experience, poured his energy and vision into creating a business that became part of the region's identity. Through hard work, he was able to build a future for his family, send two children to school, and provide a home. When his wife Joanne, a retired Westmoreland schoolteacher, was diagnosed with cancer, Dave turned his diner into a force for good, raising over \$10,000 for the Joseph Michael Chubbuck Foundation through the diner's cruise-ins to help local families facing cancer.

Beyond his business success, Dave has given back to the community in countless ways. His diner was a hub for America First rallies since 2016, a place where neighbors came together not only for food but also for civic life and shared values. He quietly helped families in need, especially those struggling with illness or financial hardship, providing support in difficult times.

On August 7, 2025, Dave announced that Dave's Diner will close its doors on September 1st as he begins his well-earned retirement. The outpouring of support was extraordinary, with hundreds of comments and shares from people across the region who felt touched by the memories, meals, and kindness that Dave and his team provided over 36 years.

He was recognized for academics on the All-Big 8 Academic Team. Following graduation, Mr. Pieratt returned to Lexington and married Patsy, his sweetheart who he met in seventh grade.

Mr. Pieratt went to work at Pieratt's, the family business founded in 1946 by his father Frank, a WWII veteran. The business started as a radio and small appliance repair shop and rapidly expanded. Mr. Pieratt worked alongside his father, brothers, brother-in-law, and nephews and helped grow Pieratt's into one of the most respected retailers in Central Kentucky. In 1988, Bruce Pieratt was named President and CEO, a role he held until 2021 when the company sold.

A true patriot who loved his country and believed in serving, Mr. Pieratt joined the Kentucky Army National Guard in 1968. He had a long and distinguished military career over thirty-one years. He served Kentucky as Assistant Adjutant General-Army and attained the rank of Brigadier General.

Mr. Pieratt was a loyal supporter of the University of Kentucky. He served on many boards and community organizations across Kentucky where his leadership was widely respected. He and his wife Patsy had three daughters, Nicole, Noel, and Nalise, and eight grandchildren. In a life filled with great accomplishments, he was most proud of his family.

A patriotic American, a respected community leader, a family man, and a true friend to many, he touched countless lives. I am honored to call Brigadier General Bruce Pieratt my friend and to lift up his life before the House of Representatives.

Mr. CRANK. Mr. Speaker, I rise today to honor the courageous, convictional, and influential leadership of Dr. James Dobson, who passed into eternity on August 21, 2025, at the age of 89. "The greatest legacy one can pass on to one's children and grandchildren is not money or other material things accumulated in one's life, but rather a legacy of character and faith," wrote Dr. Billy Graham. Mr. Speaker, Dr. Graham's friend and Focus on the Family founder, Dr. James Dobson, did just that.

As a trusted advocate for faith, family, and biblical values, Dr. Dobson's legacy is unmatched, and his life's work continues to shape our nation. We were honored that he chose Colorado Springs, Colorado as his home and base of operations for Focus on the Family.

Dr. James Dobson founded Focus on the Family in 1977 with the conviction that America's failing families needed to return to Biblical principles. A licensed marriage, family and child counselor in both California and Colorado, Dr. Dobson authored more than 30 books, including the popular best-sellers *Dare to Discipline*, *Love Must Be Tough*, and *Bringing Up Boys*. Although he eventually became

associate clinical professor of pediatrics at the USC School of Medicine, Dr. Dobson's attention ultimately turned to addressing the breakdown of the traditional family unit. His concern led him to leave USC and in 1977 open a small, two-room office he called Focus on the Family. That small ministry grew to become a global multimedia nonprofit that reaches about 18 million people in more than 98 countries, thanks in part to its Radio Hall of Fame-winning flagship program, thirteen international offices and many radio, video, digital and print resources.

His wide reach through his numerous books and daily radio broadcast became the national voice of conservative, moral, and Biblical values in the public square. Dr. Dobson was a once-in-a-generation leader whose courage to speak truth shaped the course of American family life. He inspired and truly created a grass-roots movement to defend life, Biblical marriage, and religious freedom throughout America and around the world. Dr. Dobson not only built organizations like Focus on the Family and the Family Policy Alliance, but he also built-up people of faith to stand boldly for biblical values in a culture that increasingly opposes and demeans them.

With unwavering conviction, he championed the sanctity of marriage, the dignity of life, and the importance of parental rights, principles woven into the DNA of our movement. My friend and current Focus on the Family President Jim Daly may have summarized it best in saying, "Millions of marriages were saved and strengthened, millions of parents were able to raise happier, healthier children, and millions of men and women were equipped and encouraged to stand boldly for their faith in the public square because Dr. Dobson answered God's call to create Focus on the Family."

I am grateful for his decades of courage and leadership to the Pikes Peak region, the country and the world. His belief in the power of civic engagement and cultural renewal still inspires many. Dr. Dobson emphasized the responsibility of believers to be "salt and light" in society, and we must take that charge seriously. I know I speak on behalf of many of my colleagues in this chamber that Dr. Dobson continues to inspire us to and his legacy has entrusted us to: advancing biblical values through civic engagement, calling on believers to pray, vote, and engage for a nation where God is honored, religious freedom flourishes, families thrive, and life is cherished.

Our thoughts and prayers are with Dr. Dobson's family, especially his college sweetheart and lifelong partner Shirley; his two adult children, Danae and Ryan; and his two grandchildren during this time of loss and the celebration of his life. Mr. Speaker, I ask my colleagues to join me in thanking the Lord for his life and impact in our country and the world.
