H.R. 3390, to amend the Federal Reserve Act to require the Board of Governors of the Federal Reserve System to carry out a review of discount window operations and to implement improvements to

such operations, and for other purposes, with an amendment (H. Rept. 119–234); and

H.R. 3074, to direct the Secretary of the Treasury to stop minting the penny, to require cash transactions to be rounded up or down to the nearest five cents, and for other purposes, with an amendment (H. Rept. 119–235). **Page H3860**

Energy and Water Development and Related Agencies Appropriations Act, 2026: The House passed H.R. 4553, making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2026, by a yea-and-nay vote of 214 yeas to 213 nays, Roll No. 239. Consideration began yesterday, September 3rd.

Schweikert amendment (No. 33 printed in H. Rept. 119–232) that sought to revise appropriations to reduce unobligated funds from top-line accounts totaling \$37,353,345,385.09 (by a recorded vote of 76 ayes to 351 noes, Roll No. 237).

H. Res. 672, the rule providing for consideration of the bill (H.R. 4553) and the joint resolutions (H.J. Res. 104), (H.J. Res. 105), and (H.J. Res. 106), was agreed to yesterday, September 3rd.
